## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

### 1. Description of the Plan

Organically Grown Company, Inc. (the Company or Employer) established the Organically Grown Company 401(k) Plan (the Plan), effective April 1, 1995 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. A 401(k) Plan committee, consisting of Company employees, administers the Plan and is responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan trustee and record keeper. Fidelity holds, invests, and reinvests Plan assets in the interest and at the direction of the participants and their beneficiaries.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, aged 18 and older, may participate in the Plan after completing three months of service with the Company.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax and Roth post-tax salary deferral contributions up to 92% of their annual eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 can elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

The Plan provides for automatic enrollment on the date participants become eligible for the Plan. The automatic pre-tax salary deferral contributions for eligible participants are 5% of their eligible compensation, unless participants request a different amount to be contributed or formally decline participation. Participants may adjust their deferral rate or discontinue their contributions at any time.

---

### 1. Description of the Plan (continued)

#### *Contributions:* (continued)

The Company matches 100% of employee contributions, up to 5% of eligible compensation, not to exceed \$3,500. The Company made non-discretionary matching contributions of \$692,797 for the year ended December 31, 2024.

The Company may also make discretionary non-elective (profit-sharing) contributions to the Plan. The Company did not make any discretionary profit-sharing contributions in 2024.

Contributions are subject to certain limitations under the Code.

#### *In-Plan Roth Conversions:*

The Plan allows participants who are active employees of the Company to convert any portion of their pre-tax contributions to Roth balances. There were no conversions of pre-tax deferral contributions to Roth account balances in 2024.

#### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are fully vested (100%) in their contributions, plus earnings (less any losses) thereon. Vesting in Company contributions, plus allocated earnings (less any losses) thereon, is based on continuous years of service. Participants hired before November 1, 2022, become 25% vested in Company contributions every year of service, and are fully vested after four years of service. Participants hired after November 1, 2022, become 20% vested in Company contributions after two years of service, 45% after three years, 75% after four years, and are fully vested after five years of service. Participants would also become fully vested upon death or disability.

### 1. Description of the Plan (continued)

#### *Forfeitures:*

Forfeitures of non-vested Company contributions may be used to reduce future Company contributions or to pay Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,934 and \$139, respectively. During 2024, forfeitures of \$27,086 were used to pay Plan administrative expenses.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the balance in the participant accounts, and bear a reasonable rate of interest as determined by the Plan administrator. The interest rates on the notes outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

#### *Payment of Benefits:*

On termination of service, participants may elect to leave their account balances in the Plan or receive benefits. Benefits are paid in installments or lump-sum cash distributions equal to the value of the participant's account. Accounts of terminated participants between \$1,001 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts of terminated participants with balances of \$1,000 or less may be distributed directly to participants without participant approval. The Plan agreement also allows for certain in service and hardship withdrawals for current employees. Benefits are recorded when paid.

#### *Administrative Expenses:*

The investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain transaction and maintenance fees are paid by the Plan. All other administrative expenses related to the Plan are paid by the Company and are not reflected in these financial statements.

#### *Risks and Uncertainties:*

The Plan offers a variety of investment options to participants. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Plan administrator has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

The Plan's investments consist of mutual funds, a money market fund, and participant directed brokerage accounts. These investments are reported at fair value, which is the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

### 2. Summary of Significant Accounting Policies (continued)

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

The three-level hierarchy for fair value measurement is defined as follows:

- **Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- **Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- **Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

An investment's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

### 5. Party-In-Interest Transactions

Certain Plan investments include investment options managed by Fidelity. As Fidelity is the Plan trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 6. Subsequent Events

Subsequent events have been evaluated through June 11, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
