**NOTE 1 DESCRIPTION OF PLAN**

The following description of the United Cerebral Palsy Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan, formed on July 1, 2012, is a defined contribution plan covering all eligible employees of United Cerebral Palsy of Georgia and United Cerebral Palsy of South Carolina (the “Company”). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (“ERISA”).

**Contributions** – Each year, participants may contribute a portion of their pretax compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions by the Company are discretionary. Contributions made by the Company, exclusive of forfeitures applied of \$8,307, for the year ending December 31, 2024, totaled \$166,205. Contributions are subject to certain Internal Revenue Service limitations. An aggregate of \$2,833 was rolled into the Plan during the year ending December 31, 2024, and is included in the statement of changes in net assets available for benefits.

**Eligibility** – Eligible employees are able to make salary deferrals into the Plan. There is no minimum age or service requirements to make salary deferrals. In order to be eligible to receive matching employer contributions, a participant must satisfy certain age and service requirements and be employed on the last day of the Plan year, December 31. These requirements include that the employee is at least 18 years old and has completed one year of service. A year of service includes working 1,000 hours during the 12-month period immediately following their hire date.

**Participant accounts** – Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided in the Plan agreement from the participant's vested account. Participant accounts are charged with an allocation of administrative expenses paid by the Plan.

**Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance and may not have a term that exceeds five years unless the loan is for their principal residence. Loan transactions are treated as a transfer from the investment fund to the notes receivable from participant account. These notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest, at a reasonable rate per year, is paid ratably through payroll deductions.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

**Investment options** – Upon enrollment in the Plan, a participant may direct employee contributions in various Principal investment options. Participants may change their investment options as they deem necessary.

**Payment of benefits** – On termination of service due to death, disability or retirement, a participant, or their beneficiary, may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installment payments, if the account balance is greater than \$1,000. If the vested balance in the participant’s account is \$1,000 or less, a lump sum distribution will be made. If the vested balance is \$5,000 or less and an election is not made, the balance will be placed in a Principal IRA.

**Risks and uncertainties** – The Plan’s invested assets ultimately consist of investment securities. Investment securities are exposed to various risks such as interest rate risk and market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Forfeitures** – Forfeitures are created when participants terminate employment before becoming fully vested. Forfeitures used and applied against the employer contributions totaled \$8,307 for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$191, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.

**Plan fees** – The Company paid substantially all of the Plan fees in the current year. These expenses are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value investments.

**Estimates** – The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments are stated at fair value, except for the fully benefit responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions** – Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits** – Benefits are recorded when paid.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded monthly. No allowance for credit losses has been recorded at December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 4 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

The net assets available for benefits per the financial statements agree with the net assets available for benefits per the Form 5500.

There are no reconciling differences between benefits paid to participants between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded on the Form 5500 for benefit claims that have been processed and approved for payment prior to December 31 but not yet paid as of that date. No approved benefit claims existed at December 31, 2024, which were not paid.

**NOTE 5 TAX STATUS**

The Company has adopted the Plan based on a volume submitter plan document sponsored by United Retirement Inc. United Retirement Inc. has received an opinion letter from the Internal Revenue Service ("IRS") dated March 31, 2017, that states that the form of the volume submitter plan is acceptable under Section 403(b) of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Principal Trust Company (“Principal”), the trustee of the Plan, as complete and accurate, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedule:

For the year ended December 31, 2024, the trustee certified to the completeness and accuracy of the Plan’s net appreciation in the fair value of investments of \$472,058, interest and dividends related to the aforementioned Plan assets of \$60,234, and interest on notes receivable from participants of \$7,432.

**NOTE 7 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal totaling \$114,426 for 2024 and \$112,933 for 2023. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer is approximately 1 percent. The crediting rate is reviewed on a semi-annually basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value is equivalent to fair value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE 7 INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 8 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Principal provides certain administrative services to the Plan pursuant to a master Plan Service Agreement ("MSA") between the Company and Principal. Principal receives revenue from mutual fund service providers for services Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan.

If the revenue received by Principal from such mutual fund service providers exceeds the amount owed under the MSA, Principal remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Plan sponsor may make a payment to Principal for administrative expenses not covered by revenue sharing.

Certain Plan investments are shares of mutual funds managed by Principal, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal amounted to \$18,103 for the year ended December 31, 2024.

**NOTE 9 FAIR VALUE MEASUREMENTS**

The Plan establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below.

**Basis of fair value measurement**

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
