### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of CHC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CHC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### Note 1 - Description of the Plan

The following description of the CHC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description (SPD) for more complete information on the Plan's provisions. Copies of the SPDs are available in the offices of each participating employer.

**General** - The Plan is a defined contribution retirement plan and provides retirement, disability and death benefits for all eligible employees electing membership. Participation in the Plan is open to non-union employees of Construction and Healthcare Consultants, L.P. (the Plan Sponsor), Graciano Corporation, Grane Healthcare Company, Harmon House Care Center, Providence Care Center, Riverside Nursing Centers, Inc., Kittanning Care Center, Woodhaven Care Center, HarmarVillage Care Center, Altoona Center for Nursing Care, LaurelWood Care Center, Greensburg Care Center, Highland Park Care Center, Apex Rehab Solutions, Inc., Grane Supply, Inc., Colonial Park Care Center, PACE Healthcare Transportation, Inc., PACE Consulting Solutions, Inc. (formerly Senior LIFE Management, Inc.), Trade Facility Services, L.P., Pennsylvania PACE, Inc., Practical Administrative Solutions, L.P., Senior LIFE Washington, Inc., Preferred Laundry Services, Inc., Senior LIFE York, Inc., Ebensburg Care Center, Senior LIFE Altoona, Inc., Seniors at Home, Inc., Senior LIFE Greensburg, Inc., Senior LIFE Lehigh Valley, Inc., Physician Solutions Group, Inc., Grane PBM, Inc., Florida Executive Business Advisors, Inc., and Restoration Systems, Inc. (the Companies). Employees are eligible to participate in the Plan if they completed 1,000 hours of service within their first year of employment and have attained age 21 or 3 consecutive years of service (where the employee completes at least 500 hours of service). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.

**Contributions** - Participants in the 401(k) Plan are required to elect to defer, by periodic salary deduction, an amount neither less than one percent, nor more than ninety percent of their basic compensation. The Companies, at their discretion, may contribute on behalf of each participant. During 2024 and 2023, the employers matched up to 2% of each participant's salary and an additional 0.25% for each of the employees' contributions from 3% to 6%.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings.

**Vesting** - The participant's own contributions and any rollover amounts are fully vested at all times. The employers' matching contributions become vested based on the number of years of service, with full vesting occurring after six years of service.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### Note 1 - Description of the Plan (continued)

**Payment of Benefits** – On termination of service due to retirement or disability for a vested account balance over \$5,000, a participant may elect to receive either a lump-sum amount equal to the value of their vested interest in the account, installments over a period of not more than an assumed life expectancy, or partial withdrawals. Vested account balances under \$5,000 may only be distributed in a single lump-sum payment.

In general, a death benefit will be paid to a beneficiary as a lump-sum payment. A death benefit may also be paid over a period of time provided that time does not extend beyond an assumed life expectancy.

**Plan Termination** - The Plan Sponsor has the right to terminate the Plan in the event it is concluded that it is impossible or inadvisable to continue the Plan. In the event of a termination of the Plan, the participants, retired participants, and beneficiaries will become fully vested and entitled to receive the amounts then credited to their accounts in the Trust Fund.

### Note 2 - Significant Accounting Policies

**Basis of Presentation** - The accompanying financial statements include the accounts of the CHC 401(k) Plan. A contracted trust company holds the assets of the Plan. The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Allowance for Credit Losses** – The Plan provides an allowance for credit losses based on management's evaluation of year-end receivables. No allowance was deemed necessary at December 31, 2024 and 2023.

**Operating Expenses** - The Plan Sponsor and employers absorb certain administrative fees. Expenses that are paid by the Plan Sponsor and employers are excluded from these financial statements.

### Note 2 - Significant Accounting Policies (continued)

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

### Note 3 - Fair Value Measurements

Fair value is defined as a market-based measurement. The objective of a fair value measurement is to estimate the price at which an orderly transaction to sell the asset or to transfer the liability would take place between market participants at the measurement date under current market conditions (that is, an exit price at the measurement date from the perspective of a market participant that holds the assets or owes the liability). A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market (or in its absence, the most advantageous market) for the asset or liability.

For some assets and liabilities, observable market transactions or market information may be available. For other assets and liabilities, observable market transactions and market information might not be available. When a price for an identical asset or liability is not observable, a reporting entity will measure fair value using another valuation technique that maximizes the use of relevant observable inputs and minimizes the use of unobservable inputs. Because fair value is a market-based measurement, it is measured using the assumptions that market participants would use when pricing the asset or liability, including assumptions about risk. As a result, a reporting entity's intention to hold an asset or settle or otherwise fulfill a liability is not relevant when measuring fair value.

Three levels of inputs may be used to measure fair value:

**Level 1** - Unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the reporting entity has the ability to access at the measurement date.

**Level 2** - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active and other inputs that are observable or can be corroborated by observable market data. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

### Note 3 - Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

**Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 4 - Forfeited Accounts

During 2024 and 2023, employers' contributions were reduced by approximately \$142,000 and \$76,000, respectively, from forfeited nonvested accounts.

### Note 5 - Income Tax Status

The Company has adopted a prototype plan sponsored by ADP. The prototype plan received an opinion letter dated October 6, 2020 in which the Internal Revenue Service (IRS) stated that the prototype plan was in compliance with the applicable requirements of the Internal Revenue Code (the Code). In addition, the opinion letter stated that an employer who adopts this prototype plan may rely on the prototype plan opinion letter with respect to the qualification of its plan under the Code. Therefore, the Plan Administrator believes that the Plan continues to be designed and operated in all material respects in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 6 - Investment Income**

In accordance with the Contract Agreements, interest, dividends and realized gains and losses are automatically re-invested. The net change in fair values of investments consists of the net change in appreciation (depreciation) in current value, purchases of investments, and gains and losses on sales of investments.

#### **Note 7 - Information Prepared and Certified by Trustee (Unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by approximately \$8,597,000 and \$11,285,000, respectively.

### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of receivables. Receivables are principally due from employers and participants.

### **Note 9 - Corrective Distributions**

The Plan is subject to ERISA and tax requirements for design and operation. The requirements relate to minimum participation, coverage, vesting, and funding, as well as contributions, distributions, and nondiscrimination. During 2024 and 2023, the Plan made corrective distributions of approximately \$162,000 and \$130,000, respectively, to participants in order to comply with the applicable regulations. Additionally, accrued corrective distributions of approximately \$155,000 were made during 2025. Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.

### **Note 10 - Plan Amendments, Adoptions and Resolutions**

The Plan implemented the provisions in the Secure 2.0 Act regarding the increase in age for required minimum distributions and the coverage for long-term, part-time employees.

Several affiliated employers sold their assets under an asset purchase agreement on June 30, 2023 (the "Sale Event"). As a result, these participating employers ceased to have employees on July 1, 2023. The affiliated employers simultaneously revoked their participation in the Plan as noted below. The revocation of participation of the affiliated employers resulted in a partial plan termination. As such, any employee affected by the Sale Event had their accounts fully vested at the time of termination.

Effective July 1, 2023, Board resolutions were adopted to cease participation in the Plan from Altoona Center for Nursing Care, LLC, Colonial Park Care Center, LLC, Ebensburg Care Center, LLC, Greensburg Care Center, LLC, HarmarVillage Care Center, LLC, Harmon House Care Center, LLC, Highland Park Care Center, LLC, Kittanning Care Center, LLC, Laurelwood Care Center, LLC, Providence Care Center, LLC, Preferred Laundry Services, Inc., Riverside Nursing Centers, Inc. and Woodhaven Care Center, LLC.

Effective August 1, 2023, Board resolutions were adopted to cease participation in the Plan from Apex Rehab Solutions, Inc.

Effective September 1, 2023, Board resolutions were adopted to cease participation in the Plan from Trade Facility Services, LP.

Effective September 1, 2023, Board resolutions were adopted to allow eligible employees of Restoration Systems, Inc. to participate in the Plan.

Effective October 1, 2023, Board resolutions were adopted to cease participation in the Plan from Grane Healthcare Co.

Effective December 31, 2024, Board resolutions were adopted to cease participation in the Plan from Graciano Corporation.

Effective December 31, 2024, Board resolutions were adopted to cease participation in the Plan from Restoration Systems, Inc.

#### **Note 11 - Subsequent Events**

Plan management has evaluated subsequent events through June 30, 2025, the date the financial statements were available to be issued.

Effective January 2025, ADP Retirement Trust Services, LLC replaced Reliance Trust Company as the trustee of the Plan.

The Plan implemented the provisions in the Secure 2.0 Act regarding the treatment of student loan payments as elective deferrals for purposes of matching contributions.
