Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Menominee Tribal Retirement and 401(k) Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. December 31, 2023 and 2022

Note 1 - Description of Plan

The following brief description of Menominee Tribal Retirement and 401(k) Savings Plan (Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a voluntary, defined contribution plan established by Menominee Tribal Enterprises (Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees, as defined in the Plan document, who have completed at least 6 months of service and are age 21 or older are eligible to participate in the Plan. Upon enrollment in the Plan, a participant may direct company and participant contributions to any combination of available investment options offered by the Plan. The Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Contributions

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participant contributions can be made in the form of pretax contributions or after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan includes an auto enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or make an alternative deferral rate election. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. In addition, the Plan permits Company discretionary matching contributions, as determined by the Company's board of directors. The Company discretionary matching contribution was 100% of participant contributions up to 4% of the participant's eligible compensation for the years ended December 31, 2023 and 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts and Rollovers

Each participant's account is credited with the participant's contributions, rollover contributions, Company contributions, and an allocation of plan earnings thereon (net of administrative expenses). Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's eligible compensation, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are immediately vested in their participant and rollover contributions plus earnings thereon. Company discretionary matching contributions and earnings thereon vest based on years of service as defined in the plan document. A participant is 100% vested in Company discretionary matching contributions and related earnings following three years of service. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan document, are considered 100% vested.

Payment of Benefits

On termination of service due to death, total disability or retirement, participants or their beneficiaries are entitled to receive the entire amount credited to their account as of that date. The Plan provides for normal retirement at age 65. Participants may take an in-service withdrawal upon reaching the age of 59-1/2 provided they are 100% vested in the Plan. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan document.

Payment of Benefits (Continued)

Participants whose employment with the Company is terminated before retirement for any reason other than death or total disability shall be entitled to the total of the vested balance in their accounts.

Any amount payable under the Plan because of retirement, death, total disability, or termination is to be paid to the participant or beneficiary using one of several available benefit distribution methods. If a participant's account balance is less than \$5,000 prior to the time distributions are to commence, a lump-sum distribution will be made.

Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service from the Company before becoming 100% vested in the Company's discretionary matching contributions and related earnings. As of December 31, 2023 and 2022, forfeited nonvested accounts had a balance of \$21,294 and \$10,468, respectively. Forfeited nonvested accounts are used to reduce future Company discretionary matching contributions. For the years ended December 31, 2023 and 2022, Company discretionary matching contributions were reduced by \$2,589 and \$20,938, respectively, from forfeited nonvested accounts.

Administration

The Company is the administrator of the Plan and has appointed Fidelity Management Trust Company as trustee and recordkeeper. The trustee is responsible for investing and safekeeping all of the assets of the Plan.

Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of Menominee Tribal Retirement and 401(k) Savings Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the plan committee who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the plan committee to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Plan for investment management and other administrative services are included under administrative expenses on the statements of changes in net assets available for benefits. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through November 15, 2024, the date the financial statements were available to be issued.

Note 3 - Tax Status

The Company adopted a volume submitter plan offered by the trustee. The volume submitter plan received an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan committee believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (level 1 inputs).

Note 5 - Party-in-Interest Transactions

Certain Plan investments are managed by the trustee of the Plan and; therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for administrative services amounted to \$28,131 and \$23,721 for the years ended December 31, 2023 and 2022, respectively, and are included under administrative expenses on the statements of changes in net assets available for benefits. Additional investment fees paid to the trustee are included in net appreciation/depreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Certain administrative features of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity Management Trust Company. Fidelity Management Trust Company receives revenue from mutual fund service providers for services Fidelity Management Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan.

If the revenue received by Fidelity Management Trust Company from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity Management Trust Company remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2023 and 2022, there were no excess amounts. The Plan or Company may make a payment to Fidelity Management Trust Company or administrative expenses not covered by revenue sharing.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company discretionary matching contributions and related earnings.
