## **INDEPENDENT AUDITORS' REPORT**

To the Plan Sponsor and Trustees of

1. DESCRIPTION OF THE PLAN

The following description of National Integrated Industries, Inc. (“the Company”) 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General Information:

On January 1, 1992, the Company incorporated a 401(k) Plan into its profit sharing plan. The 401(k) Plan is a discretionary contribution plan with participant salary reduction contributions matched by the Company. The Plan covers all full-time employees of the Company who have attained one year of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as well as applicable sections of recent tax legislation.

Contributions:

Each year, participants may contribute up to 90% of their annual compensation, as defined in the Plan and subject to IRS limitations. Effective January 1, 2009, there are two types of salary deferrals: Pretax 401(k) deferrals and Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a common/collective trust as investment options for participants. The Company contributes 100% of salary deferrals up to 1%, and 50% of salary deferrals thereafter up to 6%. Additional profit-sharing amounts may be contributed at the option of the Company’s board of directors. Contributions are subject to certain limitations as stipulated in the Plan.

Participant Accounts:

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants:

Participants may obtain loans from the Plan. The maximum loan a participant can receive cannot exceed the lesser of \$50,000 or 50% of the vested interest. The minimum loan a participant can receive is \$1,000. The loans are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime lending rate. The interest rate during the Plan year ranged from 4.25% to 9.50% for all outstanding loans. Principal and interest is paid ratably through payroll deduction.

Payment of Benefits:

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in his or her account, or, if the vested account balance exceeds \$5,000, installments over a period of not more than his or her assumed life expectancy (or the assumed life expectancies of the participant and his or her beneficiary). Partial withdrawals are also allowed for vested balances exceeding \$5,000. In-service withdrawals are allowed for participants over the age of 59½ and for hardships in line with IRS regulations.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$217, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$260 in 2024 and \$3,001 in 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING AND REPORTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

Investments are reported at fair value (except for the Common/Collective Trust, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Excess Contributions Payable:

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits:

Benefits are recorded when paid.

Operating Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events:

Subsequent events were evaluated through July 11, 2025, which is the date the financial statements were available to be issued.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Common Stocks*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Corporate Bonds*: Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.
- *Mutual Funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *U.S. Government Securities*: Valued using pricing models maximizing the use of observable inputs for similar securities.

5. CERTIFIED INVESTMENTS

Other than the fair value of the common collective trust and the related adjustment from fair value to contract value for fully benefit-responsive investment contracts, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company (the trustee of the Plan). The contract value of the guaranteed investment was certified by the trustee.

6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2024 and 2023, the Plan invested in a fully benefit-responsive collective investment fund managed and trustee by Reliance Trust Company. Reliance Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Funds seek to provide investors with a moderate level of stable income without principal volatility. There is no assurance that the Funds will achieve their objective. The Funds' primary investments are guaranteed investment contracts (GIC's), security backed investment contracts, separate account GIC's, cash or cash equivalents and collective investment trusts.

Because the Funds are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. The Funds are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$3,861,200 and \$3,757,583, respectively. The crediting interest rate is based on a formula that reflects the earnings of the contracts' underlying fixed income securities.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity of wash provisions, (c) bankruptcy of the Plan sponsor or other Plan events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The contracts in which the Funds are invested do not allow the issuer to terminate the agreement prior to the scheduled maturity date.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 11, 1995, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

9. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

Reliance Trust Company, corporate trustee of the Plan, holds the Plan's investment assets and executes transactions therein. Financial information relating to those assets is included in the accompanying financial statements based on information provided by the trustee.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
