INDEPENDENT AUDITORS' REPORT

**To the Plan Administrator and Participants
Watson Engineering Incorporated 401k Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Watson Engineering Incorporated 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

1. **Description of plan:**

The following description of the Watson Engineering Incorporated 401k Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) **General:** The Plan is a defined contribution plan covering substantially all employees of Watson Engineering, Inc. (the Company) who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) **Contributions:** Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Salary deferrals consist of pre-tax and/or Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualifying defined benefit or defined contribution plans (rollover).

The Plan includes an auto enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. In accordance with the Plan provisions, automatically enrolled participants will have their deferral rate automatically increased by 1% at the beginning of each Plan year until their deferral rate reaches 6%.

The Company may also, at the discretion of the board of directors, make matching contributions and/or discretionary contributions to the Plan. Company matching contributions and discretionary contributions, if any, are placed in investments directed by the participants. The Plan made a discretionary matching contribution of \$103,912 for the fiscal year ended September 30, 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions of automatically enrolled participants are invested in a Qualified Default Investment Alternative until changed by the participant. Contributions are subject to certain statutory limitations.

(c) **Participant accounts:** Each participant's account is credited with the participant's contributions, rollover contributions, the Company's matching and discretionary contributions (when made), and allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) **Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

(e) **Payment of benefits:** On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their vested interest in his or her account, an annuity payable during the lifetime of the participant, or monthly installments over a designated period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals of participant's elective contributions may be made by a participant who has reached 59 ½ years of age or upon attaining normal retirement age. The Plan also permits withdrawals of an active participant's vested balance only in amounts necessary to satisfy financial hardships, as defined by the Plan agreement.

1. **Description of plan (continued):**

- (f) **Forfeited accounts:** Available forfeitures may be used to reduce future Company matching and discretionary matching contributions or to pay Plan administrative expenses. For the year ended September 30, 2024 and 2023, forfeitures were used to reduce administrative expenses in the amount of \$10,008 and \$861, respectively. There were no non-vested forfeitures at September 30, 2024 and 2023.

2. **Summary of significant accounting policies:**

The following are the significant accounting policies followed by the Plan:

- (a) **Basis of accounting:** The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.
- (b) **Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (c) **Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received upon sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.
- Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- (d) **Payment of benefits:** Benefits are recorded when paid.
- (e) **Expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the processing of benefit payments are charged directly to the participant's accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.
- (f) **Date of Plan Management's reviews:** Subsequent events were evaluated through July 2, 2025, which is the date the financial statements were available to be issued.

3. **Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

3. **Fair value measurements (continued):**

Level 2: Other significant observable inputs including: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs are significant and unobservable (including the Plan's own assumptions used to determine value).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) of the account, which primarily includes a mix of mutual funds and common stocks. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the account.

Collective investment trusts:

Principal Stable Value Fund (SVF): The SVF is comprised of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust, however, this trust is not fully benefit-responsive to the Plan. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. If the Plan initiates a full redemption of the SVF, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly manner.

Principal Trust Income Fund (PTIF): The PTIF is comprised of a variety of separate accounts and mutual funds. The fair value of the underlying investments are used in determining the NAV.

Target Date Retirement Funds (TDF): TDFs invest in a collective trust fund as well as a variety of separate accounts and mutual funds. Each target date retirement fund seeks a total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who expects to retire in the year of the target date fund. The fair values of the underlying investments are used in determining the NAV.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified investments:

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments, dividends, interest and other investment income for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company (the Trustees of the Plan).

5. Related party and party-in-interest transactions:

Certain investments are managed or issued by Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company, and therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management and recordkeeping services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. The Plan made direct payments for certain administrative services totaling \$58,273 for the year ended September 30, 2024, which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

6. Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. **Tax status:**

The Plan is based on a Prototype Non-standardized Profit Sharing Plan with CODA of Principal Life Insurance Company (Prototype Plan), which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of plan identified is acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan has not filed for its own determination letter from the IRS. The Prototype Plan has been amended since the date of the opinion letter. However, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified and is exempt from taxation under the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. **Risks and uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
