## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of B.V. Hedrick Gravel & Sand Company Salary Deferral and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### **NOTE A – DESCRIPTION OF THE PLAN**

The following description of the B.V. Hedrick Gravel & Sand Company Salary Deferral and Profit Sharing Plan (the “Plan”) provides only general information concerning the operation of the Plan. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of B.V. Hedrick Gravel & Sand Company (the “Company”), who have completed 90 days of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Each year, participants may contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for employer profit sharing contributions and discretionary matching contributions that may be contributed at the option of the Company’s board of directors.

A profit sharing contribution of \$1,782,000 was made during the year ended December 31, 2024. No matching contributions were made for the year ended December 31, 2024. Contributions are subject to certain limitations.

#### **Participant Accounts**

Each participant’s account is credited with (1) the participant’s contribution and (2) allocations of the Company’s contributions and Plan earnings. Each account is also charged with an allocation of investment management expenses and Plan losses, if any. For the year ended December 31, 2024, certain administrative expenses were paid by the Plan sponsor. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are 20% vested after two years of credited service, increasing by 20% with each additional year of service with 100% vesting after six years of credited service.

#### **Payment of Benefits.**

On termination of service due to death, a participant’s beneficiary will receive the value of the vested interest in the participant’s account as a lump-sum distribution. On termination of service due to other reasons, a participant who’s vested account balance exceeds \$1,000 may elect to receive either a lumpsum amount equal to the value of the participant's vested interest in his or her account, or annual installments. If the vested account balance is less than

\$1,000, a participant will receive the value of the vested interest in his or her account as a lump sum distribution. Under certain circumstances, participants may elect to receive in-service distributions.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, there were no forfeitures available to be allocated to participants in the future. During the year ended December 31, 2024, \$12,670 of forfeited amounts were allocated to participants. The forfeiture allocation was based on a participant's eligible compensation.

### **NOTE B – SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The accrual method of accounting is used for financial statement purposes.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

#### **Investments Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment management fees are charged directly to the participant accounts.

#### Subsequent Events

The Plan has evaluated subsequent events through July 8, 2025 (the issuance date of the financial statements) and has determined that there were no subsequent events to recognize or disclose in these financial statements.

#### NOTE C – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

In accordance with *Financial Accounting Standards Board Accounting Standards Codification 820-10*, certain investments that were measured at net asset value per share have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits.

#### Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

#### Common Trust Funds

Collective trust funds are valued at their net asset values (“NAV”) per share as of the close of business on the valuation date. Net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Redemption for collective trust funds is permitted daily with no other restrictions or notice periods and there are no unfunded commitments. This valuation method would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

#### **NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 was \$15,745. There were no investment contracts held by the Plan as of December 31, 2023. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 2.80%.

Certain events might limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the entire Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### **NOTE G – TAX STATUS**

The Plan adopted a preapproved profit sharing plan sponsored by Principal Life Insurance Company. The Internal Revenue Service has determined and informed Principal Life Insurance Company by a letter dated June 30, 2020, that the preapproved profit sharing plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. The Plan has determined that it does not have any material unrecognized tax benefits or obligations as of December 31, 2024. The Plan is generally subject to routine audits by the Internal Revenue Service and/or Department of Labor for three years, including 2021, 2022 and 2023. There are currently no audits for any periods in progress.

#### **NOTE H – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Principal Trust Company holds the Plan’s investments and provides recordkeeping services to the Plan. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for contract administration amounted to \$63,680 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **NOTE I – RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances and the amounts reported in the financial statements.

#### **NOTE J – PLAN TRANSFERS**

During 2024, \$10,606 of assets were received from the Cumberland Gravel and Sand Company Salary Deferral and Profit Sharing Plan. The transfers were due to the transfer of eligible employees between the plan sponsors.
