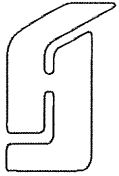

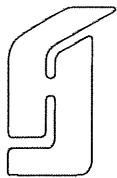

Notes to Financial Statements

At December 31, 2024 and 2023 and For the Year Ended December 31, 2024

(1) Description of Plan

The following description of the FineMark National Bank & Trust 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of FineMark Holdings, Inc. and its subsidiary, FineMark National Bank & Trust (collectively the "Company") who are age twenty-one or older. Employees may enter the Plan after completing 250 hours of service within the first three months of employment. Employees who do not meet the service requirement in their first three months are eligible if they complete 1,000 hours of service after one year of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's trustees are members of the Company's management. The Plan's designated custodian and record-keeper is Great-West Life & Annuity Insurance Company and Subsidiaries (DBA Empower Retirement) ("Great-West").

Contributions. Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company's matching contribution is 100% of the first 5% of base compensation that a participant contributes. Additional amounts may also be contributed at the option of the Company's Board of Directors. Participants direct the investment of their contributions into various investment options offered by the Plan. All employer contributions are invested ratably in the investment options selected by the participants and are subject to the vesting guidelines discussed below. These options may be changed at any time. Participants have the option to invest in an individually managed self-directed brokerage account, which can be invested in a portfolio of investments beyond those offered by the Plan. Participant and employer contributions are also subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their voluntary contributions, including amounts transferred into the Plan from other qualified employee benefit plans, plus actual earnings thereon. Vesting in any additional employer contributions, matching contributions, and earnings thereon is based on years of continuous service as defined in the Plan. A participant is 25% vested after each year of service. A participant is 100% vested in the entire account after four years of credited service.

(1) Description of Plan, Continued

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, unless the loan was used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at one percentage point above the prime rate and the interest rate is fixed throughout the duration of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments over a specified period of time, not exceeding the participant's life expectancy or the joint life expectancy of the participant and the designated beneficiary. Upon termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump sum distribution.

Participant Termination and Forfeitures. If at the time of termination of employment, the participant is not 100% vested, the nonvested portion ("forfeitures") of the participant's account shall be placed in a separate account and will be utilized to reduce future employer contributions or pay Plan expenses. During 2024, total forfeitures used to reduce employer contributions was \$35,543. The unallocated forfeitures account balance at December 31, 2024 and 2023 was \$2,000 and \$10,000, respectively.

(2) Summary of Accounting Policies

Basis of Presentation. The Plan's financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). The following is a summary of the significant accounting policies:

Use of Estimates. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events. Management has evaluated all significant events occurring subsequent to the statements of net assets available for benefits date through June 26, 2025, which is the date the financial statements were available to be issued, determining no events require additional disclosure in the financial statements.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value, except for its fixed annuity, a fully benefit-responsive investment contract, which is valued at contract value. Fair values of mutual funds are determined using unit values calculated by the mutual fund managers. Self-directed brokerage accounts are valued on the basis of readily determinable market prices.

Investment Valuation and Income Recognition, Continued. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Contributions. Contributions are accrued and credited to participants' accounts as of each pay period.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

(3) Investment Contract with Insurance Company

The Plan has entered into an investment contract with Great-West in which participants may invest in a fixed annuity. The fixed annuity option is a guaranteed fund with interest compounded annually at a corporate rate set by Great-West. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and asset charges. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and asset charges. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value unless withdrawals are due to plan or contract termination or preretirement distributions at age 59 1/2 or after. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The methodology for calculating the interest crediting rate for the fixed annuity is based on the earnings of the underlying assets in the annuity and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the fixed annuity was 1.93% for the year ended December 31, 2024.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(3) Investment Contract with Insurance Company, Continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Company does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

(4) Fair Value Measurements

GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. GAAP also establishes a fair value hierarchy which requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy describes three levels of inputs that may be used to measure fair value:

Level 1: Observable inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Inputs other than quoted prices that are observable for the asset or liability, either directly or indirectly. These include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities that are not active; and model-driven valuations whose inputs are observable or whose significant value drivers are observable. Valuations may be obtained from, or corroborated by, third-party pricing services.

Level 3: Unobservable inputs to measure fair value of assets and liabilities for which there is little, if any market activity at the measurement date, using reasonable inputs and assumptions based upon the best information at the time, to the extent that inputs are available without undue cost and effort.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(4) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts. Accounts primarily consist of cash, bonds, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(6) Tax Status

The Company has not received a determination letter from the IRS approving the qualification of the Plan for tax exempt status; however, the Company has obtained a determination letter qualifying the volume submitter document upon which the Plan was adopted. Although the Plan has been amended since receiving the determination letter, the Company believes the Plan is currently operating in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, no provision for income taxes has been recorded in the accompanying financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

(7) Information Certified by Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information contained in the financial statements and supplemental schedule, which was certified by Great-West, the Plan's custodian, is as follows:

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Party-In-Interest and Related Party Transactions

The fixed annuity is managed by Great-West and this transaction qualifies as a party-in-interest transaction. The Plan's investment advisor is a party-in-interest and an insider of the Company. The Company covers the cost of certain third-party accounting and administrative services for the Plan.
