The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Gladeview Health Care Center 401(k) Plan (the "Plan"), sponsored by Gladeview Health Care Center (the "Company"), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the Company who have at least a year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The custodian of the Plan is Lincoln National Life Insurance Company ("Lincoln").

Contributions - Each employee who elects to participate in the Plan may authorize a payroll deduction up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code Sections 401(k), 404, and 415 to contribute to his or her individual account in the Plan on either a pre or post-tax basis. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company provides a discretionary matching contribution to an eligible participant based upon their elective deferrals, which may not exceed 25 percent of the participant's elected contributions. There were no matching contributions for the plan year ended September 30, 2024. The Company made a 6% safe harbor contribution for the plan year ended September 30, 2024 in the amount of \$365,217 which was allocated among all eligible participants regardless of participation in the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, if any, and (b) Plan earnings, and is charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately and fully vested in the value of their contributions made to the Plan and actual earnings thereon. The participant is vested in the employer's matching and non-elective contributions based on years of continuous service. A participant is fully vested in the employer's matching and non-elective contributions after completing three years of service. The safe harbor employer contribution is fully vested immediately.

Payment of Benefits - Benefits are payable upon termination of employment, retirement, death or total disability. Participants receive benefits in a lump-sum payment.

Hardship Withdrawals - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

Plan Expenses - All costs and expenses with regard to the purchase or sale of investments are paid by the plan sponsor. The Plan receives a refund of excess fees received by Lincoln which is used to offset fees charged by the third party administrator. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

Forfeitures - The forfeiture of all or a portion of a participant's non-vested account balance occurs when the total distribution is received, a participant has five consecutive one-year breaks in service (not being employed by the Company for 5 years), the Plan Administrator determines that a participant or beneficiary cannot be located to receive a distribution from the Plan, or a participant receives a corrective distribution for excess aggregate contributions and the portion which relates to non-vested employer matching contributions, including any allocable income or loss, is forfeited in the Plan year in which the corrective distribution is made from the Plan. Forfeitures are first used to reduce employer matching and non-elective contributions. Forfeitures are then used to pay Plan expenses in the year the forfeitures are allocated. At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$3,293 and \$2,586, respectively.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to an amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan. The maximum payment term for any loan is five years, except for loans used to acquire a personal residence for which the maximum payment term is thirty years. The loans are secured by the balance in the participant's account. The minimum loan is \$1,000. The loans bear interest at the prime rate plus two percent. Principal and interest is paid ratably through payroll deductions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The Plan financial statements have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Payment of Benefits - Benefits are recorded when paid.

Fair Value Measurements - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Disclosure of Subsequent Events - Management has evaluated subsequent events through July 8, 2025, the date the financial statements were available to be issued.

NOTE 3 - SUMMARY OF CERTIFIED FINANCIAL DATA (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln, the custodian for the Plan, has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of September 30, 2024 and 2023, and for the year ended September 30, 2024. The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Lincoln:

NOTE 4 - INSURANCE CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive investment contract with Lincoln. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Since the guaranteed investment contract meets the fully benefit responsive investment contract criteria, the guaranteed investment contract is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants

may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to Plan documents (including complete or partial plan termination or merger with another plan), changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary), that cause a significant withdrawal from the plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974, premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) a breach of the contract by the Plan, (2) the Plan ceases to meet the requirements of the appropriate Internal Revenue Code sections, (3) if the account has not achieved a balance limit imposed by Lincoln in a specified time period.

NOTE 5 - INVESTMENTS MEASURED AT NAV USING THE PRACTICAL EXPEDIENT

The Plan's pooled separate accounts are measured at NAV as a practical expedient to estimate fair value and, therefore, have not been classified in the fair value hierarchy.

Investments measured at NAV, which represents investments at fair value were \$2,418,898 and \$1,596,023 at September 30, 2024 and 2023, respectively. Participants can redeem their investments in pooled separate accounts daily without notice. There are no unfunded commitments.

NOTE 6 - TAX STATUS

The Plan sponsor has adopted a standardized prototype plan which received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2021.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

During the plan year ended September 30, 2024, there were transactions involving the investment of Plan assets in accounts maintained by Lincoln, a party-in-interest, as defined under Section 3(14) of ERISA.

Lincoln provides certain administrative services to the Plan. Lincoln receives revenue from mutual fund service providers for services Lincoln provides to the funds. This revenue is used to offset certain amounts owed to Lincoln for its administrative services to the Plan.

NOTE 8 - TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would immediately become 100% vested in their employer contributions.
