Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Adam Corporation/Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Adam Corporation/Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Adam Corporation/Group 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Adam Corporation/Group 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Description of the Plan

The following description of The Adam Corporation/Group 401(k) Plan (the “Plan”) provides only general information. An employee of the Company who has satisfied the eligibility requirements and entered the Plan, is a “Participant”. A Participant should refer to the Plan Agreement or Summary Plan Document for a more complete description of the Plan’s provisions relating to eligibility, vesting service, matching contributions, vesting schedule, in service withdrawals and notes from Participant.

General

The Plan was created on April 1, 2005, to provide retirement benefits for eligible employees of The Adam Corporation/Group and subsidiaries and affiliates (collectively referred to as the “Corporation” and each entity individually referred to as the “Company”.) The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Secure 2.0

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (“Secure 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within Secure 2.0 vary through 2026. The Corporation has until December 31, 2026 to amend the Plan for the changes related to Secure 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Eligibility

All employees, beginning on the first day of the month following 30 days of consecutive eligibility service, who are twenty-one, are eligible to participate in the Plan.

Contribution

A Participant may authorize the Company to make a salary reduction contribution by reducing the employee’s salary and contributing to the Plan an amount subject to the limitations of the Internal Revenue Code (“IRC”) and the actual deferral percentage tests defined in the Plan. Each year a Participant may contribute up to 100% of their pre-tax compensation, as defined in the Plan, up to the maximum annual deferral limitation amount allowed by IRC of pre-tax annual compensation. A Participant may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollovers”). A Participant over 50 years of age may also make catch up contributions in excess of the annual deferred limitation. For each Participant, annual Participant contributions shall not exceed the maximum deferral percentage computed in accordance with section 401(k) (3) of the IRC.

The Company contributes one dollar for each dollar contributed by the Participant, up to 6% of the Participant’s salary.

An eligible Participant will automatically contribute 2% of their pre-tax compensation, as defined in the Plan, unless specifically elected otherwise by the Participant.

The Participant directs the investment of their and the Company contributions into the investment options offered by the Plan.

1. Description of the Plan (continued)

Contributions receivables are contributions earned and withheld by the Company as of December 31 which are transferred to the Plan subsequent to year end.

Participant Accounts

Ascensus Trust Company (the "Trustee") maintains an account in the name of each Participant ("Individual Account") which reflects the total value of their vested accrued benefits ("Benefit"). Each Participant's Individual Account is comprised of the following sub accounts (a) Participant contributions, (b) Company contributions, (c) Participant rollover contributions, (d) Participant transfer contributions, and (e) Participant nondeductible contributions. The value of a Participant's Individual Account equals the fair market values of the assets less any applicable charges and penalties. The Benefit represents the accrued benefit, less the portion of the Company contribution that is not vested.

Vesting

A Participant is immediately vested in their contribution and actual earnings thereon as well as, any rollover. If a Participant terminates employment due to death, disability or attains an age of 65, the Company contribution, as well as, any earnings thereon, shall be 100% vested. If a Participant terminates employment due to any reason other than death or disability, vesting in the Company contribution portion of their accrued benefit is based on years of continuous service. A Participant is 100% vested in the Company contribution after five years of eligible service, as defined in the Plan.

Payment of Benefits

A Benefit becomes available to a Participant or Participant's beneficiary upon the earlier event of (1) termination of employment, (2) retirement of the Participant, (3) reaches the age of 65, or (4) death or disability of the Participant. The payment options related to these events are described in detail in the Plan Agreement and the payment of Benefit is recorded when paid.

The timing of the payment of a Benefit after a separation of employment is dependent upon the amount of vested benefits payable. If the value of the Benefit is \$7,000 or less, the Company will direct the Benefit to be paid as soon as possible. If the Benefit balance is more than \$7,000, the Participant's Individual Account will remain in the Plan until the Participant requests a payment in writing. A distribution is made based on the vested portion of the Participant's Individual Account at the time of the distribution.

A Benefit cannot be withdrawn as long as the Participant is employed by the Company except for "hardship" reasons or if the Participant remains employed after reaching the age of 65. However, after reaching the age of 70 ½, active Participants must begin to take Required Minimum Distribution.

Notes from Participants

Participants may borrow from their Individual Account a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or one-half of their vested Benefit with only one loan outstanding at any time. The loans are secured by the remaining balance in the Participant's Individual Account and bear interest of Prime plus 1%. Principal and interest is paid through monthly payroll deduction.

Forfeited Accounts

If a terminated Participant requests a distribution, the non-vested portion of the terminated Participant's benefit is forfeited. If the terminated Participant has neither received a distribution nor has been deemed to receive a distribution and incurs five consecutive one-year breaks in vesting service, the portion of the Participant's Individual Account which is not vested shall be forfeited. A one-year break-in-service is defined as any Plan year in which the Participant does not complete more than 500 hours of service. Any forfeiture may be utilized to reduce future Company matching contributions. As of December 31, 2024 and 2023, the forfeited portion of Participants non-vested accrued benefits was \$204,430 and \$130,346 respectively. For the year ended December 31, 2024, Company matching contributions were reduced by \$131,371 from forfeited non-vested accrued benefits.

Plan Termination

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, Participants will become 100% vested in the Corporation's contributions and any earnings thereon.

Plan Administrator and Trustee

The general administration of the Plan is performed by the Corporation ("Plan Administrator"), which has broad powers regarding supervision and administration of the Plan. The Trustee is responsible for the administration, management and investment of the Plan, as directed by the Plan Administrator. The Trustee maintains Participant and Company contributions in a pooled account. The pooled account is credited with earnings on the underlying investments and charged for Benefits and distributions paid and administrative expenses of the Trustee. In addition, the Trustee makes all Benefits and distributions payments for the Plan to Participants and Participant beneficiaries as well as, maintains the investments in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounting and financial reporting policies of the Plan conform to accounting principles generally accepted in the United States of America ("GAAP"). The accompanying supplemental schedules are in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Use of estimates and assumptions

In preparing the financial statements the Plan Administrator is required to make estimates and assumptions that affect the reported amounts of assets and liabilities as of the date of the statements of net assets available for benefits and the reported amounts of additions to and deductions from net assets in the statement of changes in net assets available for benefits. The actual realized results could differ from current estimates and assumptions.

Valuations

The investments have been recorded at the fair values as provided by the Trustee. The Plan relies upon the Trustee to determine the fair value of the investments by utilization of quoted market values when available or alternative approaches when market prices are not available, with such valuation techniques consistently applied. Shares of mutual funds are valued daily at quoted market prices which represent the net assets value of shares held by the Plan as of the valuation date. Shares of the collective trust are not actively traded and the Company relies upon the Trustee for valuation. Participant notes are valued at their unpaid principal balances

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

plus any accrued but unpaid interest. While the Plan Administrator believes the Trustee's valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value.

Purchases and sales of investments are recorded on the trade date. Interest income is recorded as earned and dividends are recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold during the year as well as, held as of year end.

Risk and uncertainties

The Plan invests in various investments, whose underlying securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the near-term could materially affect a Participant's account balance and the amounts reported in the statements of the Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Income Tax Status

The Plan has received an opinion letter from Internal Revenue Service ("IRS") dated January 1, 2018 stating that the Plan is qualified under Section 401(a) of the IRC and therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving this opinion letter, the Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

GAAP requires an evaluation of uncertain tax positions taken by the Plan. The Plan Administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken by the Plan.

Expenses

Expenses reflect expenditures for administration and operation of the Plan that are not otherwise paid by the Corporation.

Subsequent events

The Plan has evaluated subsequent events through July 07, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The fair value measurement accounting standard establishes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The valuation techniques used maximizes the use of observable inputs and minimizes the use of unobservable input. The fair value hierarchy is as follows:

- Level 1 Inputs - Unadjusted quoted prices in active markets for identical assets that the reporting entity has the ability to access as of the measurement date.
- Level 2 – Inputs, other than quoted prices included in Level 1, which are observable for investments, either directly or indirectly. These inputs might include quoted prices for similar investments in active markets, quoted prices for identical or similar investments in markets that are not active, inputs other than quoted prices that are observable for the investment (such as interest rates, volatilities, prepayment speeds, credit risks) or inputs that are derived principally from or corroborated by market data or other means.
- Level 3 Inputs - Unobservable inputs for determining the fair values of assets that reflect assumptions that market participants would use in pricing the assets.

The mutual funds are valued at the net asset value (“NAV”) of shares held as of the reporting date. The NAV is based on the fair value of the underlying investments held by the mutual funds less liabilities. A collective trust funds hold fully benefit responsive investment contracts and is measured at NAV, as a practical expedient for fair value, thus have not been categorized in the fair value hierarchy in accordance with Accounting Standard Update (ASU) 2015-07.

The Plan invests in mutual funds and Columbia Trust Stable Government I-15, which is a collective trust. These securities are redeemable at fair value on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumption to determine the fair value of mutual funds and the collective trust could result in a different fair value measurement as of the reporting date.

Certain information included in the financial statements such as investments and notes from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest on notes from participants for the year ended December 31, 2024, were obtained from data that has been prepared and certified as complete and accurate by the Trustee.
