<b>Average Annual Earnings:</b>	The average of a Participant's greatest five consecutive Annual Earnings, taking into account no more than ten Annual Earnings immediately preceding the date of determination.
<b>Normal Retirement Benefit:</b>	<p>Normal retirement - The annual amount of pension payable at Normal Retirement Date (subject to the limitations of Section 415 of the Internal Revenue Code) is the greater of (I) and (ii) offset by (iii):</p> <ul style="list-style-type: none"><li>(i) 1% of final five year average earnings up to the average Social Security Base plus 1-1/2% of the excess, multiplied by years of service not in excess of 35 years.</li><li>(ii) \$60.00 multiplied by years of service not in excess of 35 years.</li><li>(iii) Actuarial equivalent pension of any distribution from prior profit sharing plans.</li></ul> <p>Benefits were frozen as of March 17, 2003.</p>
<b>Integration Level:</b>	The average of the Social Security taxable wage bases in effect during the 35 years ending with the calendar year of attainment of Social Security Retirement Age.
<b>Normal Form of Payment:</b>	Five- Year Certain and Life Annuity.

## **Retirement Income Plan for Employees of Insulfab Plastics, Inc.**

Summary of Plan Provisions

Valuation Date: 1/1/2024

### **Retirement:**

- (a) Normal retirement - An employee's normal retirement age is the date of age 65 and 5 years of service.
- (b) Early retirement - an employee who has attained age 55 may retire at any time prior to normal retirement age upon the completion of 10 years of credited service.
- (c) Disability retirement - An employee who becomes totally and permanently disabled shall be retired if he has completed 10 years of credited service provided he qualifies for disability benefits under the Social Security Act.
- (d) Deferred retirement - An employee may continue in active employment after his Normal Retirement Date.

### **Normal Retirement Date:**

Eligibility: Upon termination prior to retirement but after 5 years of service, an annual pension is payable to the employee commencing at Normal Retirement Date equal to the pension accrued under 6 above based on service and earnings to date of termination. An early retirement pension equal to the actuarial equivalent of the accrued benefit may commence at any time after attainment of age 55 provided the employee completed 10 years of service on his date of termination.

Benefit: Accrued Benefit determined as of the termination date. Payments commence on the first day of the month on or after date of termination.

### **Early Retirement:**

The annual amount of pension payable at Normal Retirement Date is the product of (I) an amount calculated as for normal retirement based on the final five year average earnings and the average Social Security Limit at retirement and credited service projected to Normal Retirement Date (not in excess of 35 years) and (ii) a fraction, the numerator of which is the actual years of Credited Service at retirement and the denominator of which is the years of Credited Service projected to Normal Retirement Date. If the participant elects to have his pension commence at his early retirement date, it will be reduced 1/2% per month for each month by which his early retirement date precedes his Normal Retirement Date.

### **Deferred Retirement:**

The annual amount of pension payable at a later retirement date is calculated as above with credited service not in excess of 35 years and final five year average earnings measured at the later retirement date. The highest average Compensation received from any five consecutive plan years of service preceding the Participant's date of termination.

**Optional Forms:** Life Annuity, 50% / 100% Joint and Survivor Annuity, Life Annuity with 120 monthly payments guaranteed, lump sum.

**Death Benefits:** Upon death of a participant after completion of five years of service, a monthly pension is payable to the spouse of the participant commencing on the participant's Normal Retirement Date in an amount equal to 50% of the amount that would have been payable to the participant under the Joint and 50% survivor option.

Upon death after retirement or after his Normal Retirement Date if the employee is still actively employed, if an optional form of pension is not in effect, pension payments are continued to the designated beneficiary for the remainder of the initial 60-month period since retirement.

**Vested Termination Eligibility:** Termination of employment prior to eligibility for Early or Normal Retirement, and after the completion of five years of Vesting Service.

**Vested Benefit:** Vested Accrued Benefit determined as of the termination date, payable commencing at Normal Retirement Date. Provided the Participant has ten years of Vesting Service, the benefit can become payable at age 55 or later with the same reduction as under the Early Retirement benefit.

**Disability Benefit:** The annual amount of pension payable to a disability retirement is the pension accrued under normal retirement without reduction.
