### **Opinion on the Financial Statements**

We have audited the accompanying financial statements of Western News&Info, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE1 - DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a 401(k) plan established on December 30, 1963. Employees of Western News&Info, Inc. (the Plan Sponsor or Company) are eligible to participate in the Plan once they have attained the age of eighteen and completed six months of service. Participants may enter the Plan on the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Each year, participants may contribute a portion of pretax annual compensation, as defined in the plan document, up to the maximum amount allowed by the IRS. For 2024 this deferral limit was \$23,000. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants will be automatically enrolled in the Plan upon satisfaction of eligibility requirements at a deferral rate of 3% of eligible gross compensation. Participants may also rollover amounts from other qualified plans.

The Company may make discretionary non-elective contributions to the Plan, an amount the Company in its sole discretion may determine. Participants must complete at least 501 hours of service and be employed on the last day of the Plan year in order to share in the non-elective contribution. The Company will designate the non-elective contributions as qualified non-elective contributions when they are allocated to non highly compensated participants' accounts. During 2024, no non-elective contributions or qualified non-elective contributions were made.

The Company may make discretionary employer matching contributions to the Plan, an amount the Company in its sole discretion may determine. During 2024, the Company matched 20% of the first 5% of participants' deferrals. There were approximately \$32,000 in employer matching contributions during 2024.

*Participant Accounts*

Individual accounts are maintained to record participant contributions, rollover contributions, discretionary matching contributions, discretionary non-elective contributions, qualified non-elective contributions, and earnings thereon for each participant. The benefit to which a participant is entitled is the total benefit, which can be provided from the vested portion of these individual accounts.

**NOTE 1 - DESCRIPTION OF THE PLAN, CONTINUED**

*Vesting*

Upon entry into the Plan, participants are 100 percent vested in their participant contributions, rollover contributions, qualified non-elective contributions, and earnings thereon. Vesting for the discretionary matching contributions, discretionary non-elective contributions, and earnings thereon are based on years of service as follows:

*Notes Receivable from Participants*

Loans are not permitted.

*Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may request a distribution of their vested account balance from the Plan Administrator. Furthermore, upon approval of the Plan Administrator, participants may be entitled to take hardship distributions from their vested account balances. Participants may elect to withdraw all, or a portion of their account while still employed, upon attainment of age 59 ½. Participants that have terminated employment and have a vested balance less than \$1,000 will receive a distribution as soon as administratively feasible. Benefits are recorded when paid.

*Forfeited Accounts*

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$25,000 and \$27,000, respectively. These accounts will be used to reduce the employer contributions or pay administrative expenses in a future period. During 2024, approximately \$4,000 of forfeitures were used to reduce Company contributions. No forfeitures were used to pay Plan expenses.

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual method of accounting except for payment of benefits, which are recorded when paid.

**NOTE 2 - AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Administrative Expenses*

Fees related to the administration of distributions and notes receivable from participants are charged directly to the corresponding participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements.

*Subsequent Event*

The Plan has evaluated subsequent events through June 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds (CTFs):* Valued using the NAV as a practical expedient, which is based on the quoted market prices of the underlying securities of the funds. The unit price is based on the value of the underlying investments assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The CTFs provide for daily redemptions by the Plan at reported NAV, with no advance notice requirements.

**NOTE 4 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the preapproved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in their employer contributions.

**NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fidelity Investments held the Plan's investments. Professional Capital Services performed the recordkeeping. The Retirement Plan Company performed the third-party administration. Investment advising is performed by Coble Wealth Management, Inc. Therefore, any investment or administrative fee paid during the year to these parties qualify as party-in-interest transactions.

**NOTE 7 – SECURE 2.0**

The SECURE 2.0 Act of 2022 introduces several changes to qualified retirement plans, with various implementation dates ranging from 2023 to future years. Key provisions include enhanced catch-up contribution limits for participants ages 60-63 (effective 2025), requirements for higher-income participants to direct catch-up contributions to Roth accounts (effective 2026), increases to required minimum distribution ages (phasing up to age 75), and the option to increase the automatic rollover threshold for force-out distributions from \$5,000 to \$7,000.

The Plan Administrator is currently evaluating these changes to determine which optional provisions may benefit plan participants. Any required amendments will be implemented by their respective deadlines, and participants will be notified of adopted changes that affect their accounts or options under the Plan.
