We are the Accountants for the Chapter 7 Bankruptcy Trustee of Foxtrot Ventures, Incorporated (“Foxtrot” or the “Debtor”), the Sponsor of the Foxtrot Ventures 401(k) Plan. Foxtrot filed for protection under Chapter 7 of the United States Bankruptcy Code on May 14, 2024, at which time Jeffrey Burtch Esq. was appointed as the Chapter 7 Trustee (“Trustee”). The Debtor ceased all operations and payroll as of the Chapter 7 filing.

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. § 704(a)(11), the Trustee is responsible for the liquidation of the Plan Assets of the Foxtrot Ventures 401(k) Plan (“the Plan”).

The 2024 annual informational return (“Form 5500”) was prepared by Principal Financial Group (“Principal”), the Plan Asset Custodian, from the best information available; that is, data provided by the Debtor’s former personnel. Due to the cessation of business, the filing of bankruptcy, and lack of cooperation from the Debtor’s former personnel, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable. In addition, the Debtor’s former personnel did not provide any assistance to the Trustee in contacting Principal or transferring administration of the Plan to the Trustee, and the Trustee was only able to contact the proper personnel at Principal to administer and terminate the Plan in late October, 2024, so there were extenuating circumstances surrounding the bankruptcy.

This Plan requires audited financial statements, but as a result of the bankruptcy, the bankruptcy estate does not have funds to pay for the audit, and bankruptcy regulations require that Plan expenses be paid from Plan Assets. In an effort to minimize costs and preserve participants’ funds, the annual audit will not be prepared. Given that the Plan has terminated and all funds have been distributed to participants, the Trustee and Bederson believe that not preparing audits is in the best interests of the Plan’s participants. In addition, the Debtor’s former personnel provided the Trustee with very limited financial or other records needed to administer the bankruptcy, and as such, the records required to complete the audit are not available. Accordingly, due to lack of information caused by the bankruptcy and the need to preserve Plan Assets for participants’ benefit, the annual audit will not be prepared or attached to this Form 5500.

During 2024, as part of the termination and liquidation process, all of the Plan’s remaining funds were distributed to Participants. We are not aware of any complaints from Participants regarding the distribution or disposition of their account balances.

The period on this return through May 14, 2024 pre-dates the appointment of the Trustee and his professionals. Neither the Trustee nor the Trustee’s Accountants have any direct knowledge of the transactions recorded by the Debtor and Principal as reported on this Form 5500 return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Debtor or Principal.

The Trustee, by his signature on the face of this informational return, has relied on Principal’s expertise in preparing the return from the available records, which were limited due to the entity's cessation of business. However, it is our qualified opinion that this is a complete return based on the financial information available.
