Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Flexfab Horizons International Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

1. Plan Description

The following description of the Flexfab Horizons International Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan designed to cover substantially all salaried employees of Flexfab LLC (the Company) and its subsidiary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The contract holder and trustee of the Plan are Empower Annuity Insurance Company of America and Empower Trust Company, LLC, respectively (collectively, Empower). The administrator of the Plan is the Company. Empower holds all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Participant Eligibility

Employees of the Company are considered eligible for participation, except for: (1) nonresident aliens with no U.S. source of income, (2) employees covered by a collective bargaining agreement that does not provide for participation in the Plan, (3) leased employees, and (4) independent contractors.

Participants must be 21 years of age and complete one year of service to participate in the Plan. Employees are credited with one year of service at the end of the first year in which they complete 1,000 hours or more of service.

Contributions

Employees may elect to contribute to the Plan using payroll deductions not to exceed the maximum annual amount allowable under the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants are automatically enrolled in the retirement savings contribution portion of the Plan at an initial rate of 4% of compensation. The Plan allows for Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan also allows in-Plan Roth rollover conversions.

The employer contributes on both a matching and discretionary basis, as determined annually by the Company's Board of Directors. The Company's match was 50% of the first 4% of employee contributions for 2024 and 2023. Discretionary contributions were approximately \$1,004,000 and \$848,000 for 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's matching and discretionary contributions, and Plan earnings or losses. Allocations to participant accounts are specified by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are 100% vested in their individual deferral and rollover contributions and the allocated earnings thereon. Participants become vested in the Company's contributions based on years of continuous service, as follows:

Forfeitures

Forfeitures resulting from the non-vested portions of the accounts of participants who terminate prior to being fully vested are allocated to participants as additional Company matching contributions. Forfeitures allocated to participants in 2024 and 2023 were approximately \$28,000 and \$35,000, respectively. The forfeiture account balance was approximately \$92,000 and \$14,000 as of September 30, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates that are commensurate with local borrowing rates. Interest rates range from 7.50% to 8.50% on outstanding loans as of September 30, 2024. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years.

Payment of Benefits

Participants may withdraw amounts from the Plan only after the occurrence of a distributive event and filing of an application for distribution. Distributive events include death, the attainment of age 59½, total and permanent disability, termination of employment, and termination of the Plan. Participants may also obtain hardship withdrawals with the Company's consent. All vested account balances less than \$1,000 may be automatically distributed to the participant.

Administrative Expenses

Administrative expenses, including recordkeeping and investment advisory services, are asset based and charged to participants on a quarterly basis. Fees related to the administration of distributions

from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as a reduction in net appreciation in fair value of investments. In addition, the asset-based fees charged to participants are offset by revenue-sharing income, which is noted on the statements of changes in net assets available for benefits as other income. The Company allocates revenue-sharing income on a pro-rata basis to participant accounts. All other Plan expenses are paid by the Company.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Subsequent Events

Subsequent events have been evaluated by management through July 8, 2025, the date these financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems

the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant contributions and discretionary employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

3. Investments

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The valuation methodologies used to measure the fair value of the Plan's investments are as follows:

Mutual Funds - Mutual funds are valued at quoted market prices in an exchange and active market, which represent the net asset value (NAV) of shares held by the Plan.

Pooled Separate Account (PSA) - The Plan holds the New York Life Anchor Account (Anchor Account), which is comprised of the New York Life Insurance Company's PSA group annuity contract. The Anchor Account is a stable-value product that guarantees principal and interest. Anchor Account contributions are directed to a New York Life PSA. Units of the PSA are valued based on the underlying investments (i.e., fixed-income securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSA is not publicly quoted. The NAV is reported by the fund manager as of the financial statement date based on recent transaction prices and is used to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSA held by the Plan provides for daily redemptions by the Plan at reported NAV with no advance-notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. This investment is considered a direct-filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

5. Related Party and Party-in-Interest Transactions

Participant loan and distribution processing fees are paid to Empower by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated June 14, 2023 that the Plan and related trust were designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since the date of the determination letter, Plan management believes that the Plan and the related trust are currently designed and operated in compliance with the applicable requirements of the IRC and continue to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Plan Transfers

During the plan year ended September 30, 2024, as permitted by the Plan, funds totaling \$464,113, were transferred into the Plan from the Flexfab 401(k) Plan for Bargaining Unit Employees (an affiliated plan sponsored by the Company). Plan transfers were based on changes in job status of certain employees that correspondingly affected their eligibility to participate in the affiliated plan.
