### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements**

We have performed an audit of the financial statements of Haynes Furniture Company Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2024 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion on the 2024 Financial Statements**

In our opinion, based on our audit and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the 2024 Financial Statements* section of our report,

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. Description of Plan

The following description of the Haynes Furniture Company Retirement Savings Plan (the “Plan”) is provided for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### **General**

Haynes Furniture Company, Inc. (the “Company” or “Plan Sponsor”) established the Plan on July 1, 1976, and amended and restated the Plan on January 1, 2022. There were no material modifications made to the Plan as a result of the most recent plan amendment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan is a defined contribution plan that covers substantially all employees of the Company. Employees ages 18 or over are eligible to participate in the Plan on the first day of any month coincident with or following 60 days of service.

#### **Contributions**

Eligible participants may elect to contribute a pre-tax and/or after-tax percentage of their eligible compensation to the Plan, not to exceed the limit set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Plan allows for a discretionary employer matching contribution each year. For 2024, the Company elected to make matching contributions of 25% of employee contributions, not to exceed 5% of eligible compensation.

Participants may direct the investment of contributions on a daily basis into various investment options offered by the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, and an allocation of plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their salary deferral contributions and rollover contributions, plus actual earnings thereon. A participant also becomes 100% vested upon death, becoming disabled, or reaching retirement age, as defined by the Plan. The employer discretionary matching contribution is vested as follows:

#### **Notes Receivable from Participants**

Participants may borrow from his or her account up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested balance, reduced by the participant's highest outstanding balance during the preceding one-year period, if any. Loan terms are not to exceed five years, except for loans to purchase or construct a primary residence, which are permitted to be repaid over a maximum of 15 years. Notes are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or separation, a participant or beneficiary may elect to receive an amount equal to the participant's interest in his or her account in a lump sum. In-service distributions may be made to participants who have reached age 59½ and six years of service. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified by the Plan. Participants with six years of vested service may take in-service withdrawals of their employer vested balance only.

#### **Forfeitures**

Forfeitures from non-vested participant accounts are used to reduce administrative expenses. In 2024, forfeitures used to reduce administrative expenses were insignificant. Available forfeitures were approximately \$33,000 and \$34,000 as of December 31, 2024 and 2023.

#### **Administrative Expenses**

Most expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statements of changes in net assets available for benefits as administrative expenses. Loan and distribution fees are paid from affected participant accounts. The Company absorbs the remaining expenses incidental to the administration of the Plan.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are primarily stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Investment Valuation and Income Recognition (Concluded)***

Certain investment contracts with Empower are included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts issued by Empower as described in Note 9.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through July 8, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company LLC ("Empower"), the custodian of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by CCH Incorporated, DBA ftwilliam.com ("CCH"). The IRS has determined and informed CCH by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan assets are invested in a group annuity contract managed by an affiliate of Empower. Fees paid to Empower and affiliates by the Plan for recordkeeping and investment management services were approximately \$36,000 for 2024. Empower serves as custodian and, therefore, these transactions qualify as party-in-interest transactions. Empower receives revenue from mutual fund service providers for services Empower provides to the funds.

Fees paid to BDO USA, PC for third party administrator services were approximately \$21,000 in 2024.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Guaranteed Investment Contract with Insurance Company

The Plan has a group annuity contract with Empower that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value, as reported to the Plan by Empower, represents cash contributions deposited under the contract, plus earnings, less participant withdrawals, and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. This investment has no unfunded commitments or redemption frequency restrictions. The average yield and crediting interest rates were 1.41% and 1.23% for the years ended December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination), (2) termination of the contract or breach of a provision of the contract by the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA. The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### 10. Delinquent Participant Contributions

During the year ended December 31, 2023, participant elective contributions of \$4,877 were not remitted within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The correction was made in 2024.
