NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the National Construction Enterprises, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of National Construction Enterprises, Inc. (the "Company"), who are age eighteen or older and have a minimum of 500 hours of service, except those whose employment is governed by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, subject to a maximum amount established by Code Section 402(g). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may designate all or any part of their employee deferrals as Roth 401(k) contributions. Eligible participants are automatically enrolled at a deferral rate of 1% of eligible wages, unless the participant makes an alternative election. In addition, all participants that are deferring below 10% will have their deferrals increased by 1% per year up to 10%, unless the participant elects a different deferral percentage. The Company may make matching contributions of participant deferrals at its discretion. During the year ended September 30, 2024, the Company matched employee contributions at 20% of the first 10% of the compensation deferred. The Company may also make an additional discretionary profit-sharing contribution to each participant who was employed on the last day of the Plan year. Contributions are subject to certain limitations. The Company elected to make an additional discretionary contribution of \$500,000 to the Plan for the year ended September 30, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, net of investment expenses, (c) forfeitures of employer profit sharing contributions, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, earnings, or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: Participants are immediately vested in their voluntary and employer matching contributions plus actual earnings thereon. Vesting in the remainder of their account, including employer profit sharing contributions plus earnings thereon, is based on years of continuous service. All participants are fully vested after six years of credited service. Forfeitures of employer matching or profit-sharing contributions may be used to offset future employer matching contributions or administrative expenses of the Plan. During the year ended September 30, 2024 and 2023, there were \$10,396 and \$2,485 forfeitures used to reduce employer contributions. There were no forfeitures used to reduce administrative expenses of the Plan during the year ended September 30, 2024. As of September 30, 2024 and 2023, there were no forfeitures available to be used in the future.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

(Continued)

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Payment of Benefits: Upon termination of service, participants may elect to receive a lump-sum distribution, or a direct rollover amount equal to the value of the vested interest in their account. In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan and withdrawals upon attainment of 59 ½ years of age.

Administrative and Investment Management Expenses: The Plan’s recordkeeping and audit fees are paid by the Plan and the Company and are reflected in the financial statements as administrative expense of the Plan. Investment management fees are charged to the Plan as a reduction of investment income and included in the net appreciation (depreciation) in fair value of net assets available for benefits.

Notes Receivable from Participants: Participants may borrow funds against their account limited to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the participant’s account balance and bear interest at a rate commensurate with prevailing rates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan’s investments, other than fully benefit responsive investment contracts, are reported at fair value as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides various investment options in any combination of mutual funds, investment contracts and collective trust funds offered by the Plan. The underlying investments are exposed to various risks, such as interest rate, market, liquidity, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances.

NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Funds: The fair values of participation units held in collective trust funds are based on their net asset values reported by the fund managers as of the financial statement dates. Each collective trust

held directly by the Plan provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - GUARANTEED INVESTMENT CONTRACTS

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life as of September 30, 2024. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value, as this is the relevant measurement. Contract value, as reported to the Plan by Principal Life represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 5 - GUARANTEED INVESTMENT CONTRACTS (Continued)

There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date without 90-day notice to Principal Life.

NOTE 6 - INCOME TAX STATUS

The employer has adopted a non-standardized pre-approved plan document. This non-standardized prototype Plan has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the document is acceptable under Internal Revenue Code ("IRC") Section 401. Although the Plan has been amended from the original prototype document, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

As the employer is following all the terms of the Plan, and the Plan's eligibility requirements and benefit provisions are not more favorable for highly compensated employees than non-highly compensated employees, under the terms of the opinion letter, management believes the Plan is qualified under the appropriate requirements of the IRC.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative fees are paid to Principal, the Plan trustee and recordkeeper and to investment issuers for various investment fees. For the year ended September 30, 2024, fees of \$130,955 were paid by the Plan to the trustee.

The Plan held party-in-interest investments, at fair value/net asset value of \$13,162,262 as of September 30, 2024. Notes receivable from participants are also considered to be party-in-interest transactions.

NOTE 8 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through July 10, 2025, which is the date the financial statements were available to be issued.
