### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of RSP Architects, LTD Retirement Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended September 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

**NOTE 1 DESCRIPTION OF PLAN**

The following description of RSP Architects, LTD (the Company) Retirement Savings Plan and Trust (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Company established the Plan effective June 1, 1984. The Plan was last amended and restated effective October 1, 2021. The Plan is a defined contribution plan covering substantially all employees of the Company. The Plan excludes employees covered by a collective bargaining agreement, nonresident aliens, leased employees, reclassified employees not classified by the Company as common law employees of the Company, temporary student interns and independent contractors. Employees are eligible to participate in the 401(k) deferral and match arrangement upon commencement of employment. Employees become eligible for the Company's profit sharing contribution after completing six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants age 50 or older are allowed to make catch-up contributions.

The Company may, at its discretion, elect to make a matching contribution or profit sharing contributions to the Plan as determined by the Board of Directors. For the years ended September 30, 2024 and 2023, the matching contribution was 100% up to 5% of deferral contributions. For the years ended September 30, 2024 and 2023, there were no Company profit sharing contributions.

Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans or conduit IRAs. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit sharing contribution, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances as defined. Income is allocated daily based on each participant's share of the account. Participants direct the investment of contributions into various investment options offered under the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement (age 65), death, or permanent disability.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to reduce Company contributions or to pay administrative expenses. Forfeited nonvested accounts as of September 30, 2024 and 2023 totaled \$149,218 and \$81,620, respectively. There were \$81,704 and \$83,340 of forfeitures used to reduce Company contributions for the years ended September 30, 2024 and 2023, respectively. There were \$1,943 and \$2,662 of forfeitures used to pay administrative expenses for the years ended September 30, 2024 and 2023, respectively.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution, substantially equal installment or partial distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and for hardship distributions based on satisfying certain conditions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent in the form of a lump sum payment.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows participants to borrow funds from the Plan based on certain conditions. Notes are repaid through payroll deductions. Note terms may not exceed five years, except for notes to fund the purchase of a principal residence, for which the Plan administrator may permit a longer repayment term. The notes are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, including any revenue sharing credits, are included in net appreciation of fair value of investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance shall be offset in accordance with the terms of the loan policy.

**Benefit Payments**

Benefit payments are recorded when paid.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding distribution for corrective contributions. The Plan distributed the 2024 excess contributions to the applicable participants in accordance with IRS regulations.

**Subsequent Events**

The Plan has evaluated subsequent events through June 30, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The Standard Insurance Company, the insurance company and qualified institution, has certified to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of September 30, 2024, the statements of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of September 30, 2024.

Minnesota Life Insurance Company, the insurance company and qualified institution, has certified to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statements of net assets available for benefits as of September 30, 2023 and the statement of changes in net assets available for benefits for the year then ended.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at September 30, 2024 and 2023.

*Pooled Separate Accounts:* Valued at the net assets value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the pre-approved plan indicating that the pre-approved plan is qualified under the applicable sections of the IRC. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the pre-approved plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 TRANSFER FROM RSP ARCHITECTS, LTD. EMPLOYEE STOCK OWNERSHIP PLAN**

Subject to certain diversification provisions, participants in the RSP Architects, Ltd Employee Stock Ownership Plan may elect to transfer to the Plan, a portion of the estimated fair market value of the total shares of Company stock (in the form of cash). During the years ended September 30, 2024 and 2023, participants elected to diversify Company stock in the amount of \$191,930 and \$185,526, respectively. There were no transfers from RSP Architects, Ltd Employee Stock Ownership Plan recorded as a transfer receivable as of September 30, 2024 and 2023.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The investments are held by The Standard Insurance Company (The Standard), the insurance company. Therefore, transactions with The Standard qualify as party-in-interest transactions.
