Opinion

We have audited the accompanying financial statements of The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan, as of September 30, 2024, and 2023 and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate that raise substantial doubt about The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentation, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing and opinion on the effectiveness of The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.



- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among others matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

A - Description of Plan

The following description of The Arc/Morris County Chapter, N.J., Inc., Flexible Benefits Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **Sponsor** - The sponsor of the Plan is The Arc/Morris County Chapter, N.J., Inc., a New Jersey non-profit corporation.
2. **General** - The Plan provides the employees of the sponsor with a choice of various fringe benefits. Certain plan assets are held in a voluntary employees' beneficiary association trust (VEBA). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.
3. **Benefits** - The Plan provides health benefits (major medical, dental, group term life, accidental death and dismemberment, and long term disability), medical expense reimbursement plan, dependent care assistance plan and legal subsidy plan covering employees of the sponsor working more than 21 hours per week excluding overtime. A participant becomes eligible after three months of employment.
4. **Contributions** - The Plan agreement provides that contributions are remitted each pay period. The employer's contribution rate is determined annually by the sponsor based on the current cost for single HMO/DMO Coverage. Employees may contribute specified amounts, determined annually by the Plan's insurance companies, to extend coverage to eligible dependents.
5. **Other** - Although it has not expressed any intention to do so, the sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

B - Summary of Significant Accounting Policies

1. **Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Accounting Estimates** - The preparation of the financial statements, in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

3. **Payment of Benefits** - Premiums paid by either the sponsor or the VEBA are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.
4. **Administration Expenses** - The Plan's expenses are paid either by the Plan or by the sponsor. Expenses that are paid directly by the sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of net assets available for benefits. In addition, certain investment-related expenses are included in the investment income presented in the accompanying statement of changes in net assets available for benefits.
5. **Reclassifications** - Certain reclassifications of amounts previously reported have been made to the accompanying financial statements to maintain consistency between periods presented. The reclassification has no impact on previously reported net assets available for benefits.
6. **Date of Management's Review of Subsequent Events** - The Plan's management has evaluated subsequent events through July 3, 2025, the date that the financial statements are available for issuance. Based on this evaluation, it has been determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

C - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of temporary cash investments in banks in excess of the U.S. Federal Deposit Insurance Corporation (FDIC) insured \$250,000 limit and all investments in money market and certificates of deposit.

D - Other Matters

The VEBA established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly, the Trust's net investment income is exempt from income taxes. The VEBA has obtained a favorable tax determination letter from the Internal Revenue Service and the sponsor believes that the VEBA, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

E - Tax Status

The Plan is qualified under Section 125 of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

F - Termination of the Plan

Although it has not expressed any intention to do so, the sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, the remaining assets will be applied in a uniform and nondiscriminatory manner towards the provision of benefits for or on account of the participants. No assets of the Plan may revert to the sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.
