## **Report of Independent Auditors**

To the Plan Participants and the Plan Administrator of

### **Opinion**

We have audited the financial statements of Polaris Inc. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s

provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

**Notes to Financial Statements**

**December 31, 2024**

**1. Plan Description**

**General**

Polaris Inc. (the "Company") established the Polaris Inc. Employee Stock Ownership Plan (the "Plan") effective January 1, 1997. The Plan operates, in relevant part, as a non-leveraged employee stock ownership plan. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the "Code") and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Company is the plan sponsor and the Polaris Retirement Plan Committee is the plan administrator. Fidelity Management Trust Company is the trustee (the "Trustee") of the Plan. The following is not a comprehensive description of the Plan and therefore does not include all situations and limitations covered by the Plan. Participants should refer to the Plan agreement for more complete information.

**Plan Operations**

Certain administrative costs totaling \$58,230 and \$84,817 were paid by the Company for the plan years ended December 31, 2024 and 2023, respectively. For the plan year ended December 31, 2024, certain administrative costs totaling \$34,947 were paid by the Plan using previously forfeited amounts.

**Eligibility**

The Plan covers the majority of the employees of Polaris Industries Inc. and certain U.S. subsidiaries. Full-time salaried employees who have completed one month of continuous service are eligible to participate in the Plan on the first day of the plan year in which the requirement is met. In general, hourly employees must complete 60 days of continuous employment, and part-time, temporary and seasonal employees must complete twelve months of continuous service by December 31. Officers, employees covered by collective bargaining agreements and certain other individuals are not eligible.

**Contributions**

The Plan provides that the amount and timing of the Company's contributions shall be determined by the Board of Directors of the Company at its sole discretion. The Plan allows for contributions in the form of Company common stock or cash.

The Board of Directors approved a contribution for the 2024 plan year of 277,785 shares in March 2025 at the December 31, 2024 closing stock price. For the 2023 plan year, the Board of Directors approved a contribution of 176,054 shares at the December 31, 2023 closing stock price that was made in 2024. These contributions were recorded in employer contributions receivable in the statements of net assets available for benefits and employer contribution in the statements of changes in net assets available for benefits.

**Vesting**

Participants who were hired prior to January 1, 2007, or who retire, die or become disabled while employed are 100% vested in employer contributions and earnings thereon. Participants hired on or after January 1, 2007 are subject to the following vesting schedule:

Less than two years of service	0% vested
Two but less than three years of service	50% vested
Three or more years of service	100% vested

Any portion of a participant's account that is not vested will be forfeited on the date on which he or she receives a complete distribution of his or her account or, if earlier, the date on which the participant incurs a five-year break in service. Forfeitures may be used to restore previously forfeited amounts of certain reemployed employees, used to pay Plan expenses or allocated among participants, all in accordance with Plan rules.

**Distributions**

Following severance from employment, distributions of whole shares of stock may commence at any time. If employment ends due to death, disability, or after reaching the age of 59 1/2, a participant's account is distributed in shares of stock as soon as administratively practicable after the end of the plan year in which employments ends, unless distribution is delayed.

Distributions for other terminations of employment are paid or start to be paid after the end of the first plan year following the year in which employment ends, unless distribution is delayed. Account balances valued at \$1,000 or less as of the end of the calendar quarter in which employment ends are distributed in the form of a single lump-sum cash payment as soon as administratively practicable after such termination, unless a rollover is elected. Participants with account balances of \$1,000 to \$7,000 may elect to receive their distribution in cash in lieu of stock in a lump sum, or have the balance rolled over to an individual retirement account ("IRA") or other plan of their choosing, all in accordance with Plan rules. Participants with account balances in excess of \$7,000 may elect to receive their distribution in cash in lieu of stock in a lump sum or in five equal annual distributions, delay the distribution to a later date, or have the balance rolled over to an IRA or other plan of their choosing, all in accordance with Plan rules.

**Diversification**

Once participants have reached 40 years of age and have completed at least five years of Plan participation, the Plan allows for diversification of their account through transfers to the Polaris 401(k) Retirement Savings Plan ("401(k) Plan"). Such transfers are allowed according to age as follows:

<u>Age</u>	<u>Percent That Can Be Diversified</u>
40-49	25%
50-54	50%
55+	75%

Diversified shares will be sold and the cash will be transferred into participants' 401(k) Plan accounts. Once the cash is transferred, those funds will be invested according to the participants' investment elections in the 401(k) Plan. The total amount transferred out of the Plan and into the 401(k) Plan for the years ended December 31, 2024 and 2023 was \$1,863,329 and \$5,536,168, respectively.

**Participant Accounts**

The Plan maintains a separate account for each participant. Contributions are allocated to participants based on eligible compensation. Contributed shares are allocated to participants in the ratio of the participant's eligible compensation to total participants' eligible compensation. Dividends are allocated to participants based on the share balance in their account.

**Plan Termination and Amendments**

The Plan may be amended and/or terminated at any time, subject to Plan and ERISA provisions. In the event of the Plan's termination, participants become fully vested in their accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Investment Valuation**

The shares of common stock are valued at fair value, determined by the Company's closing stock price on the New York Stock Exchange. Other investments of the Plan are stated at fair value. See the "Fair Value Measurement" section for further discussion and disclosures related to fair value measurements.

**Payment of Benefits**

Benefits are recorded when paid.

**Fair Value Measurement**

Accounting Standards Codification Topic 820 ("ASC 820") defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. ASC 820 also establishes a fair value hierarchy, which requires classification based on observable and unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are as follows:

*Level 1* - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.

*Level 2* - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

The Company uses the market approach to measure fair value for all investments in the Plan. The market approach uses prices and other relevant information generated by market transactions involving identical or comparable assets. The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial investments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, the Company's common stock valued at \$166,686,320 and \$276,146,998, respectively, represents the only investment that has a value of more than 5% of the Plan's net assets.

### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### 3. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated February 3, 2016, stating that the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 4. Party-in-Interest Transactions

The Plan holds units of mutual funds managed by the Trustee. The Plan also invests in the common stock of the Company. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. During 2024 and 2023, the Plan received \$7,875,658 and \$7,681,441, respectively, in dividends from Company common stock and mutual funds held.

## **5. Risks and Uncertainties**

The Plan invests primarily in Company securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and amounts reported in the statements of net assets available for benefits.

## **6. Subsequent Events**

Management evaluated events for the Plan through June 18, 2025, the date the financial statements were available to be issued.


