We have performed audits of the accompanying financial statements of Hertzberg – New Method, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

September 30, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Hertzberg – New Method, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan sponsored by Hertzberg – New Method, Inc. (the Company) for the benefit of its full-time union employees who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

The Plan permits eligible employees through a salary reduction election to contribute between 1% to 15% of their eligible compensation. Employee rollover contributions are also permitted. The Company makes contributions of 3% of employees’ compensation. Additionally, the Company contributes a 1% match for the first 1% contributed by the employee. Effective January 1, 2024, the Plan was amended to allow Roth contributions.

3. Participant Accounts

Each participant’s account is credited with the participant’s contribution and actual earnings and allocation of the Company’s contribution and Plan earnings on invested assets, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested, on a graded basis, after seven years of credited service.

5. Investment Options

Upon enrollment in the Plan, a participant may direct contributions in various investment options. Participants may change their options daily.

6. Payment of Benefits

Upon termination of service, participants may elect to receive a lump-sum amount or installments equal to the value of their account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

7. Forfeited Accounts

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$ 7,143 and \$ 8,805, respectively. These accounts are used to reduce the Plan's ordinary and necessary administrative expenses for the Plan. During the years ended September 30, 2024 and 2023, Plan administrative expenses totaling \$ 10,134 and \$ 11,992, respectively, were paid from forfeited nonvested accounts.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

2. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Payment of Benefits

Benefits are recorded when paid.

4. Subsequent Events

The Plan assessed events that have occurred subsequent to September 30, 2024 through May 27, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. The Trustees modified the Plan to allow Roth deferral contributions beginning January 1, 2024.

5. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions. Those estimates and assumptions affect the reported amount of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

NOTE D - FAIR VALUES OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Pooled Separate Accounts

The Plan invests in pooled separate accounts. The unit values of these pooled separate accounts are determined at the close of each business day that the New York Stock Exchange is open for business. Units may be issued and redeemed on any business day at the daily unit value. All earnings, gains, and losses of the pooled separate accounts are reflected in the computation of the daily unit value and are realized by the participants upon redemption from the pooled separate accounts. Net investment income and net realized gains are reinvested, and thus, there are no distributions of net investment income or net realized gains to participants.

NOTE E - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

The Plan's investments are units of pooled separate accounts and general account deposits managed by John Hancock Life Insurance Company. Additionally, the Company provides certain administrative services at no cost to the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

NOTE F - TAX STATUS

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan follows accounting principles generally accepted in the United States of America related to the accounting for uncertainty in income taxes, which sets a minimum threshold for financial statement recognition of the benefit of a tax position taken or expected to be taken in a tax return.


