NOTE 1: DESCRIPTION OF PLAN

The following description of the Lehigh University Retirement Plan (the "Plan"), sponsored by Lehigh University (the "University") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan, covering faculty and exempt or non-exempt salaried staff who are scheduled or have completed 1,000 hours of service ("Base Plan Employee") in each service computation period, pursuant to the participation rules in the Plan document. The Plan was restated and amended January 1, 2020 to reflect the new hardship withdrawal rules and loan procedures applicable to the Plan, incorporate prior amendments to the Plan, and make certain other desirable changes to the Plan. It is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). The Plan has been amended and restated to comply with final regulations under section 403(b) of the Internal Revenue Code of 1986, as amended (the "Code").

The Plan Administration Committee is responsible for administration, interpretation and operation of the Plan, except for responsibility related to Plan investments, which authority has been delegated to the Plan Investment Committee.

B. Contributions

For 2024 and 2023, participants may contribute salary deferrals up to the maximum amount allowed under the Code, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollovers) and amounts transferred from other Code section 403(b) plans (Plan to Plan Transfers), and Roth Contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Base Plan eligible employees have their deferral rate set at 3.0% for their pretax contribution and their contributions invested in a designated balanced fund until changed by the participant. The University contributes Base Contributions and Matching Contribution on behalf of each Base Plan Employee. For 2024 and 2023, Base Contributions for active participants was a maximum of 8.0%.

For Base Plan employees hired after December 31, 2013 the University contribution schedule is based on years of service. Employees with less than 3 years of service receive a University contribution of 4.0% of eligible compensation, employees with 3 to 5 years of service receive 6.0%, and employees with greater than 5 years of services receive 8.0%. For 2024 and 2023, the Matching Contribution was equal to fifty percent of the participant's salary deferrals that were not in excess of 6.0%. Contributions are subject to certain IRS limitations.

C. Participant Accounts

Each participant's account is credited with their allocations of the participant's and University's contribution and Plan earnings, and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

A participant shall have 100% non-forfeitable interest at all times in his/her salary deferrals, rollovers, and Roth contribution. A base plan employee who was employed by the University as of December 31, 2013 shall have a 100% non-forfeitable interest in his/her entire account. A participant who was not a base plan employee employed by the University as of December 31, 2013 shall have a non-forfeitable interest in his/her matching and base contribution account when he/she has credit for three years of service.

E. Payment of Benefits

For all terminations of service, a participant shall be entitled to receive a distribution from their accumulation account in accordance with the options set forth in their individual agreement(s) with TIAA.

F. Participant Loans

Participant loans are permitted under the Plan. The minimum amount of the loan is \$1,000 and the maximum amount of the loan is \$50,000. The term of the loan shall not exceed five years unless the loan proceeds are used to acquire a dwelling that is used as the participant's primary residence. The loan shall bear a variable interest rate that may increase or decrease as determined by the funding agent. The balance outstanding of participant loans at December 31, 2024 and 2023 was, \$1,182,206 and \$1,061,423, respectively.

G. Plan Termination

The University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

H. Related Party Transactions

Certain Plan investments consist of shares of mutual funds, annuities, and other accounts managed by TIAA. TIAA is the trustee/custodian of the Plan and, therefore those transactions qualify as party-in-interest transactions exempt from prohibited transaction rules. CAPFINANCIAL Partners, LLC is the investment manager of the Plan, therefore all transactions qualify, as party-in-interest transactions.

TIAA provides certain services to the Plan pursuant to an agreement between the University and TIAA. TIAA receives revenue from mutual fund and collective trust fund service providers for services TIAA provides to the funds. This revenue is used to offset certain amounts due to TIAA for its administrative services provided to the Plan.

H. Related Party Transactions (Continued)

If the revenue received by TIAA from such mutual fund or collective trust fund service providers exceeds the amount owed under the agreement, TIAA remits the excess of the Plan's trust on a regular basis. Such amounts were applied to pay Plan administrative expenses allocated to the accounts of the participants. The Plan may make a payment to TIAA for administrative expenses not covered by the revenue sharing.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Payment of Benefits

Benefits are recorded when paid.

E. Subsequent Events

The Plan has evaluated all other subsequent events through June 11, 2025, the financial statement issuance date.

NOTE 3: PLAN ADMINISTRATION

The Plan is administered by the University. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the University. Expenses that are paid by the University are excluded from these financial statements. Investment related expenses are included in net appreciation / (depreciation) of fair value of investments.

NOTE 4: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The plan administrator and the plan's tax counsel believe that the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5: INVESTMENTS

During 2024 and 2023 the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$66,600,751 and \$81,267,393 respectively.

NOTE 6: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6: FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered Investment Companies: Primarily valued using market quotations or prices obtained from independent pricing sources (net asset value of shares held by the plan at year-end). CREF Money Market Account holdings are valued at amortized cost, which approximates fair value.

Pooled Separate Account: Valued based on the market value of underlying real estate holdings or other real estate related investments. Real estate holdings are valued using external appraisals, which are estimates of property values based on a professional's opinion. Securities are valued based on independent pricing sources. Unit values are calculated each day.

Unallocated Insurance Contracts: Valued at contract value, equal to the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals, which approximates fair value.

Self-Directed Accounts: Primarily consists of Registered Investment Companies, which are valued using market quotations or prices obtained from independent pricing sources (net asset value of shares held by the plan at year-end).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7: GUARANTEED INVESTMENT CONTRACT WITH TIAA

The Plan entered into a benefit-responsive guaranteed investment contract with TIAA totaling \$25,157,051 for 2024 and \$26,173,881 for 2023. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but generally, it is generally not lower than 3 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value, which for the Plan approximates fair value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
