### 1. Plan Description

---

The following description of the Kidwell, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Kidwell, Inc. (the Company).

Employees are eligible to make voluntary salary deferral contributions, as well as receive discretionary matching contributions and discretionary profit sharing contributions after attaining age 18 and completing 3 months of service. Eligible employees may become participants on the first day on which entry requirements are fulfilled. Employees must be employed on the last day of the Plan year in order to receive discretionary profit sharing contributions.

#### ***Contributions***

Participants may make voluntary pre-tax or Roth after-tax salary deferral contributions up to the maximum dollar limit allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled with an initial 3% salary deferral contribution once an employee becomes eligible for the Plan. This contribution percentage is increased by one percentage point at the beginning of each Plan year, until it reaches 6% of their eligible compensation. A participant can elect not to contribute at any time, may increase or decrease his or her deferral rate to any rate allowed under Plan provisions, or may elect out of automatic deferral rate increases. The Company may make discretionary matching and discretionary profit sharing contributions. The Company made discretionary matching contributions of \$588,669 and \$609,809 for the years ended December 31, 2024 and 2023, respectively. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching or profit sharing contributions and (b) Plan earnings or losses, (c) and charged with an allocation of administrative expenses. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit sharing contributions are allocated among participants based upon each participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Union Bank and Trust Company (UBT).

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions credited to participants' accounts are based on years of continuous service. A participant is 20% vested after the first year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are made on a non-discriminatory basis and are secured by the balance in the participant's account. Interest rates are established at current market rates at the time of issuance and range from 4.25% to 9.50% as of December 31, 2024 and 2023. Principal and interest rates are paid ratably through monthly payroll deductions.

### *Payment of Benefits*

Upon termination of service due to retirement, disability, or death, the participant or beneficiary may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested interest in the participant's account. For termination of service for other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. Plan participants are eligible for normal retirement at age 65 but may elect to retire at a later date. Upon attainment of 65 years of age, death, or determination of disability, a participant becomes 100% vested regardless of the number of credited years of service completed. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Benefits are recorded when paid.

### *Forfeitures*

Non-vested Company matching and profit sharing contributions of terminated participants become forfeitures of the Plan. Forfeitures are valued as of the day the participant is terminated from the Plan. Forfeitures remain in the Plan and will be used to pay administrative expenses or to reduce the Company's discretionary matching and profit sharing contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23 and \$0, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$37,723 and \$42,525 respectively, were used to reduce discretionary matching contributions.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Other**

Audit fees are paid by the Company and are excluded from these financial statements. Investment management and recordkeeping expenses are paid by the Plan and are included in administrative expenses. Other expenses specifically incurred or attributable to individual participants are paid from the applicable participant’s accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through July 8, 2025, noting no items requiring disclosure.

### 3. Information Certified by UBT

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by UBT, except for comparing such information certified by the custodian and the trustee to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price reported on the active market on which the individual securities are traded.

*Common Collective Trust:* Valued at the Net Asset Value (NAV) per unit based on the market value of its underlying investments. FASB 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

---

The Plan is qualified as a profit sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 6. Related Party Transactions

---

The Plan's cash is held and managed by UBT, the custodian and trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

### 7. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.
