Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Northeast New Jersey Legal Services Employees' Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules (DOL) and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



NOTE 1 DESCRIPTION OF PLAN

The following description of the Northeast New Jersey Legal Services Employees' Savings Plan (the Plan) is provided for general informational purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan was established January 1, 2004, and is a defined contribution plan sponsored by Northeast New Jersey Legal Services (the Plan Sponsor or Company). The Plan is designed to comply with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plans assets are held by TIAA and CREF, (which also extends with respect to those investments held by TIAA, FSB and TIAA Trust, N.A., as directed Trustee or Custodian that are record kept by TIAA), the Custodians of the Plan.

Eligibility

An employee is eligible to participate in the Plan if he or she (a) is hired to work more than 14 hours of service per week and (b) is not excluded under the collective bargaining agreement covering such employment. Leased employees and nonresident aliens are also not eligible to participate in the Plan. Eligible employees may enter the plan immediately upon meeting the eligibility requirements.

Contributions

Participant elective deferrals are not permitted to the Plan. The Plan makes a 5% nonelective contribution to participants based on each eligible participant's annualized compensation. Effective January 1, 2024, contribution rate changed to 10%. These contributions were subject to the Internal Revenue Code (IRC) limitations.

Vesting

Participants become 100% vested in the Plan's nonelective contribution and earnings thereon completion of 1,000 service hours, death or total permanent disability.

Participant Accounts

Individual accounts are established for each plan participant. Each participant's account is credited with the allocation of (a) the Company's contribution, if any, and (b) Earnings, losses and investment related administrative expenses attributable to the self-directed investments chosen by the Participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to termination of employment, disability or retirement, a married participant's account balance is converted into a joint and survivor annuity. If the spouse consents, a participant receives an amount equal to the value of the participant's vested interest in his account in a lump-sum. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary in the form of an annuity to his spouse or, if the spouse consents, or the participant is unmarried, the benefit is paid as a lump sum.

Forfeitures

Forfeitures are related to when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures can be used to reduce employer contributions under the Plan. Forfeitures as of December 31, 2024 and 2023, totaled \$117 and \$1,601, respectively. \$7,628 was used from the forfeiture account to reduce Plan contributions during the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Recordkeeping and investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan Administrator and Trustees have evaluated subsequent events through June 18, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENT INFORMATION

Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equity Fund (CREF), and TIAA on behalf of TIAA, FSB and TIAA Trust, N.A., the qualified institutions, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the quoted market prices in the active market in which the fund is traded. (Level 1 inputs)

Pooled Separate Account – Valued using the NAV of units. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. (Level 2 input)

TIAA Traditional Annuity Accounts - Nonbenefit Responsive – The TIAA Traditional Annuity Nonbenefit Responsive contracts are valued at fair value. The nonbenefit responsive contracts includes the Retirement Choice (RC) offered by TIAA. The TIAA Traditional Annuity accounts are not available for sale or transfer on any securities exchange. The accounts are invested in corporate and government bonds, preferred stock, mortgage and asset backed securities, commercial mortgages, private equity, limited partnership fund investments, REIT common stock, other common stock, real estate, and cash. Insurance regulations limit the proportion of investments that can be allocated to certain asset classes. Specifically, regulations limit holding of below-interest-grade bonds to 10% of the portfolio; emerging market debt to 4%, U.S. common stock and other nonpreferred equity securities to 20%, and U.S. real estate to 20%. Regulations also require TIAA to maintain certain minimum amounts of capital. These capital requirements vary by the amount and type of risk. For instance, emerging market bonds, equities and real estate require significantly higher capital than investment grade bonds. Certain contracts issued for the TIAA Traditional Annuity accounts contain liquidity restrictions on transfers and withdrawals, which could impact the value realized upon exiting the contract. The Retirement Annuity and Group Retirement contracts require cash withdrawals and transfers to be spread over 10 annual installments. Some contracts permit withdrawal over five annual installments after termination of employment. The Group Retirement and Retirement Choice contracts provide for a 2.5% withdrawal fee if a participant separates from service and elects to withdraw accumulations within 120 days of separation. Accordingly, transactions in similar investment instruments are not observable. (Level 3 input)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2, or 3.

NOTE 5 INDIVIDUAL ANNUITY CONTRACT WITH INSURANCE COMPANY

Each participant maintains an individual annuity contract with TIAA. TIAA maintains a portion of the contributions in a "guaranteed account," which is called the TIAA Traditional Fixed Account. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA. The guaranteed minimum rate of interest is based on a formula established by TIAA and is between 3% and 5%. Any additional interest is not guaranteed. The Traditional Fixed Account does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

NOTE 5 INDIVIDUAL ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

The Traditional Fixed Account individual annuity contracts are considered to be nonfully benefit-responsive. These contracts are included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. These contracts are subject to a 10-year withdrawal period. Upon termination of the contracts, the amount of each transfer payout annuity payment will be determined as of the annuity starting date for the transfer payout annuity by the amount of the Traditional Fixed Account accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account. There are no reserves against fair value for credit risk of the contract issuer or otherwise.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the IRC. No contributions are forfeited when made to participants. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of Plan termination.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 TAX STATUS

On June 30, 2020, the Internal Revenue Service (IRS) stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 9 PARTY-IN-INTEREST

All Plan investments are held in custody by the Custodians. The Custodians provide investment management and administrative services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for investment management services are calculated using the average assets for the reporting period and are net with investment appreciation on the statement of changes. TIAA and CREF investment management services fees totaled \$18,641 for the year ended December 31, 2024.
