## **IFP Group of Co Profit Sharing 401(k) Plan Notes To The Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of The IFP Group of Companies Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering the employees of IFP Motion Solutions (the Company). Full-time employees are eligible to participate after 90 days of service and part-time, seasonal, and interns are covered under the Plan after they attain 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustees are responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the trustees.

#### **Participant Contributions**

Each year, participants in the Plan may contribute up to 75% of their annual pretax compensation, as defined in the Plan, limited to the maximum amount allowable under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans (rollover), as well as after-tax contributions from their current compensation. The Plan includes an auto-enrollment provision whereby all newly-eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, increasing 2% annually until the election reaches 8% or the participant elects to change their percentage or discontinue their contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. If the participant does not make an investment election, the contributions are invested in the Plan's default investment option.

#### **Profit-Sharing and Employer Matching Contributions**

Participants are eligible to receive profit-sharing and employer matching contributions after one year of service in which they attain 1,000 hours of service during the fiscal year. Once eligible, participants maintain their eligibility as long as they are employed on the last day of the fiscal year. The Company made discretionary matching contribution of 25% of elective deferrals up to 8% of eligible compensation that a participant contributed to the Plan for the year ended September 30, 2024. For the year ended September 30, 2024, the Company made profit-sharing contributions based on rates approved by the Board totaling \$1,765,166. Company contributions are invested in the same manner as participant contributions. Contributions are subject to certain IRS limitations.

## IFP Group of Co Profit Sharing 401(k) Plan Notes To The Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses, that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

#### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested account balance. Terminated participants with vested balances of less than \$5,000 can be distributed in lump-sum without participant election. The Plan allows for in-service withdrawals employee and rollover accounts at any time and of fully vested safe harbor matching balances any time after reaching age 59 ½. Hardship distributions are also permitted.

#### **Forfeitures**

Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's contributions to the Plan are used in the following order: reduce the Company's matching contribution or offset plan expenses. Forfeited nonvested account balances totaled \$29,593 and \$87,571 as of September 30, 2024 and 2023. During the Plan year ended September 30, 2024, forfeitures of \$99,900 were used to reduce Plan expenses and the Company's matching contribution.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Subsequent Events**

The plan administrator has evaluated subsequent events through July 7, 2025, the date which the financial statements were available to be issued.

### NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage account:* Valued at NAV, includes publicly traded securities and mutual funds which are valued at quoted market prices.

*Collective investment trust funds:* Valued at NAV, established by the fund's sponsor on the last business day of the plan year, based on the fair value of the assets underlying the funds. The investment strategies of the funds include maximum appreciation, portfolio appreciation, moderate growth, and preservation of capital. The investments are valued daily and have no redemption restrictions or future commitments.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

**NOTE 6 - CERTIFICATIONS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Custodian of the

Certain plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
