### ***Opinion on the 2024 Financial Statements***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



### ***Auditor's Responsibilities for the Audit of the 2024 Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedule Required by ERISA***

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of September 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial



statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

***Other Matter - Report on the 2023 Financial Statements***

The 2023 financial statements of Plan were audited by predecessor auditors. Their audit report, dated July 11, 2024, expressed an unmodified opinion on these financial statements.

### 1. Description of Plan

The following summary description of the Recology Employee Stock Ownership Plan (the Plan or ESOP) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan is a defined contribution stock bonus plan under Section 401(a) of the Internal Revenue Code (IRC) covering most employees of Recology Inc. and its Participating Companies (Recology, the Company, and the Plan Administrator). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. As an employee stock ownership plan under Section 407(d) of ERISA, the Plan is designed to invest primarily in the common stock of the Company and may acquire such stock on a leveraged basis.

#### *Administration*

The Company stock in the Plan is currently held in trust by two named trustees of the Plan (the Trustees) who are also employees of Summit Fiduciary Group, LLC., the company which provides administrative services to the Plan ancillary to the Trustees. The ESOP Administrative Committee (the Committee) is a named fiduciary of the Plan, and the Company is the Plan Administrator for purposes of Section 3(16) (A) of ERISA and Section 414(g) of the IRC.

#### *Eligibility*

Employees of a Participating Company are generally eligible to participate in the Plan after they have completed 1,000 hours of service during a Plan year.

#### *Contributions*

Employee contributions to the Plan are not permitted.

The Company contributed 350,000 shares at a fair value of \$13,100,500 for the year ended September 30, 2024. The Company contributed 306,500 shares at a fair value of \$10,243,230 for the year ended September 30, 2023. The Company also contributed cash in the amount of \$8,146,703 and \$8,595,753 to fund participant distributions and plan to plan transfers for the years ended September 30, 2024 and 2023, respectively.

#### *Allocations to Participants*

Each eligible participant's account is credited annually with an allocation of (i) contributions from the Company in the form of shares of company stock, (ii) forfeitures of terminated participants' nonvested accounts, and (iii) shares reallocated by reason of cash distributions of benefits to eligible participants. The release of shares for allocation to participant accounts is determined in accordance with the applicable regulations under the IRC and the Plan document. Allocation of shares to participant accounts is based on the proportion of a participant's eligible compensation in relation to the aggregate eligible compensation for the plan year. During the years ended September 30, 2024 and 2023, forfeited shares of 2,791 and 5,077, respectively, were reallocated to participants' accounts. The Plan was amended effective September 15, 2021, so that any

forfeiture of shares after that date would be converted to shares acquired by the ESOP on or after January 1, 1987 (Post-1986 shares) when they are reallocated to participants' accounts.

### *Vesting*

A participant's account becomes 100% vested upon completion of three years of service or upon death.

### *Distributions*

The Plan distributed 893,714 and 893,448 shares to participants that were immediately repurchased for \$29,879,200 and \$29,385,512 by the Company in 2024 and 2023, respectively. In addition, the Plan reallocated to active participants' account shares totaling 243,755 and 261,349, respectively, during the years ended September 30, 2024 and 2023, representing the shares made available for reallocation as a result of cash benefit distributions made under the Plan.

Effective April 30, 2020, any Pre-1987 Shares converted to cash in the recycling portion of the benefit distribution process are converted to shares acquired by the ESOP after December 31, 1986 (Post-1986 shares) when they are reallocated.

### *Timing of Distributions*

If a participant terminates service because of retirement, disability (as these terms are defined in the Plan), or death, the distribution of Plan benefits will be offered over a five year period beginning in the first Plan year following the Plan year in which the participant terminated service.

If a vested participant terminates service for a reason other than retirement, disability, or death, distribution of the participant's Post-1986 shares will be offered over a five year period beginning in the sixth Plan year following the Plan year in which the participant terminated service. The portion of a participant's Plan benefit attributable to Pre-1987 shares will begin to be distributed only after the participant reaches retirement or otherwise becomes eligible for a full distribution.

### *Form of Distributions*

As long as the Company's Articles of Incorporation restrict ownership of substantially all stock to the ESOP, or as long as the Company remains an S Corporation, Plan benefits may be paid in cash based on the value of stock and cash (if any) in the participant's account. Alternatively, the ESOP Administrative Committee (the Committee) may choose to make distributions in the form of Recology stock, subject to the requirement that the distributed stock be immediately sold to the Company at the most recent appraised value.

A participant who terminates employment for a reason other than retirement or death and who fails to consent to a distribution will have the portion of the account attributable to Post 1986 shares converted to cash and invested in assets other than Recology stock (Conversion Accounts). This investment conversion will occur using the fair value of Recology stock as of the Allocation Date immediately preceding the date the distribution is offered, and will continue in substantially equal amounts over a period not to exceed five years. A retiree whose retirement age is 61 and who fails to consent to his distribution will not have the investment of his account converted for the Plan year.

Once the participant's investment in Recology stock has been converted, the funds will be credited to a separate Conversion Account for the participant. The assets in the Conversion Account will then be transferred to the Company's 401(k) plan. An account in the 401(k) plan will be established for each affected participant. The investment of these transferred assets will be made by participants through a participant directed investment arrangement in the 401(k) plan intended to meet requirements of Section 404(c) of ERISA.

If a participant's account is between \$1,000 and \$5,000, then the Plan will pay the benefit in the form of a lump sum if the participant consents to a distribution. If a participant's account is more than \$5,000, the Plan will distribute the benefit based on substantially equal annual installments of shares over a period of years generally not to exceed five years.

If benefits are paid in installments, the undistributed balance will remain invested in stock, and its value may vary at each valuation date.

If the value of a participant's ESOP account is \$1,000 or less at the time of determination, it will be distributed in a single lump sum.

After 90 days from the original issuance date, uncashed benefit distribution checks will be transferred to the Recology 401(k) Plan to be held for the benefit of the Participant (or Beneficiary).

### ***Voting Rights***

The Committee holds a proxy from the Trustee, which empowers the Committee to vote the stock held by the Plan. However, in the case of certain corporate matters, which involve the voting of shares and which relate to a corporate merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all of the assets of a trade or business, participants are entitled to direct the voting of shares allocated to their accounts, whether or not vested.

### ***Diversification***

Participants close to retirement may elect to receive a distribution for diversification of their holdings of Post 1986 shares. To qualify for diversification participants must be 55 years old with at least ten years of participation in the Plan. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25% of the number of post 1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Presentation***

The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles (GAAP).

### *Use of Estimates*

The preparation of the financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade date basis. The net realized and unrealized gains or losses, which include gains and losses on investments bought and sold as well as held during the year, are included in the net appreciation (depreciation) in fair value of investments.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

The Company pays all of the Plan's administrative expenses.

### *Risks and Uncertainties*

The Plan invests in common stock of the Company. The common stock of the Company is exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with the common stock, it is at least reasonably possible that changes in the fair value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

## **3. Investment in Company Stock**

The Trustee, as directed by the Committee, will invest in the Recology Employee Stock Ownership Trust Fund (the Trust Fund) all amounts, which are paid to it with respect to the Plan, other than benefit distributions. The Trust Fund is generally invested only in common stock of the Company or, on a temporary basis, short term interest bearing investments. The Plan's 100% ownership interest in the Company consists of 13,280,511 and 13,824,225 shares of the Company's common stock as of September 30, 2024 and 2023, respectively. The Plan's investment, for financial statement purposes are presented in the following table:

The fair value per share of the common stock as determined by the Committee's independent appraiser as of September 30, 2024 and 2023 was \$37.43 and \$33.42, respectively.

### 4. Nonparticipant Directed Investment

All components of investments and investment activity are nonparticipant directed.

### 5. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are as follows:

*Level 1* - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Company can access at the measurement date.

*Level 2* - Inputs to the valuation methodology are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

*Level 3* - Inputs to the valuation methodology are unobservable inputs for the asset or liability.

The level in the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes during the year in the methodologies used at September 30, 2024:

- Investment in the common stock of the Company is valued at its estimated fair value as determined by the Committee based upon an independent appraisal using valuation methodologies that are commonly used and accepted within the financial community, including a Market Approach and an Income Approach. The significant unobservable inputs used in an income valuation approach of the Level 3 assets measured at fair value are earnings before interest, taxes, depreciation, and amortization (EBITDA), net income, weighted average cost of capital, discount rate, and discount for lack of marketability. The significant unobservable inputs used in the market valuation approach of the Level 3 assets measured at fair value are public comparables, revenue multiples, EBITDA multiples, and discount for lack of marketability. Because of the inherent subjectivity in any valuation, the estimated value might differ significantly from the value that would have been used had a ready market for the security existed.

## 6. Plan Termination

The Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the IRC. In the event of plan termination, participants will become 100% vested.

## 7. Income Tax Status

The Internal Revenue Service has determined and informed the Company in a letter dated January 21, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator and the Committee's tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trusts are tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Related Party Transactions

Recology Inc. common stock transactions between the Plan and the Company are subject to the party in interest transaction restrictions and must meet an exemption.

### 9. Subsequent Events

The Plan has evaluated subsequent events through June 30, 2025, the date the financial statements were available to be issued.

For the period October 1, 2024 to June 20, 2025, the Company contributed cash in the amount of \$7,887,994 to fund participant distributions, including diversification distributions, that took place during the Plan year ending September 30, 2024. For the period October 1, 2024 to June 20, 2025 the Plan distributed 915,486 shares to participants that were immediately repurchased by the Company for \$34,266,641.
