### **1. Plan Description**

The following description of the TLC Operations, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan that operates under Section 403(b) of the Internal Revenue Code covering substantially all employees of TLC Operations, Inc. ("the Organization" or "Plan Sponsor"). Employees are eligible to contribute to the plan upon hire, except for employees who normally work less than 20 hours per week. Employees are generally eligible to receive employer contributions upon completion of two years of service, as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year participants may contribute amounts up to the allowable deferral limit defined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Plan Sponsor may make discretionary matching contributions for participants who actively contribute elective deferrals to the Plan. No discretionary matching contributions were made in 2024. The Plan Sponsor may also make discretionary non-elective contributions to all eligible employees. During 2024, discretionary non-elective contributions of 2% of eligible compensation were made to all eligible employees. Contributions are subject to certain IRS limitations.

#### ***Participant Accounts***

Each participant's account is credited with the employees' contributions and the Organization's discretionary contributions and allocations of plan earnings and losses. Allocations of Plan earnings and losses are based on participant earnings or account balances, as defined in the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions into selected investment options as made available and determined by the Plan Administrator. The Plan currently offers mutual funds and an insurance contract. Participants have daily access to their investment balances. Changes are self-directed by the participants.

#### ***Vesting***

Participants are vested immediately in their elective deferral contributions and employer contributions plus actual earnings thereon.

#### ***Notes Receivable from Participants***

Participants may borrow from their plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. Principal and interest is paid ratably through regular payroll deductions.

## ***Payment of Benefits***

Upon retirement, disability, death, or termination, a participant may elect to receive the value of his or her account in either a lump sum or annual installments. In-service distributions are also permitted at age 59.5.

## **2. Summary of Significant Accounting Policies Accounting Records**

### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Notes Receivable from Participants***

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Participant loans in the amount of \$355 were deemed to be in default during 2024 and recorded as distributions.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value, except for the fully benefit responsive investment contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. See Note 5 for investment contract information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Plan Expenses***

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of loans, distributions, and other participant requested services are charged directly to the participant's account and are included in administrative expenses. There is an ERISA Budget Account ("EBA") held outside the Plan that is available to offset eligible Plan expenses. Earnings of \$4,246 from the EBA were allocated to participants at a rate of 0.15 percent during 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 and 2023.

*Mutual funds* - These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a fixed income guarantee option with Principal Life Insurance Company ("Principal Life") through a custodial account with Principal Trust. The contract holder maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to the fixed annuity investment contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For investment contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. These contracts are included in the financial statements at contract value, as reported to the Plan by Principal Trust. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become fully vested.

### **7. Tax Status**

The Internal Revenue Service has issued an opinion letter on the volume submitter 403(b) plan document that the plan utilizes, dated March 31, 2017. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **8. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 9. Related Party and Party-In-Interest Transactions

Plan investments are mutual funds and an insurance contract managed by Principal Trust, as defined by the Plan, and utilize Principal Life Insurance Company as the recordkeeper. Transactions with these parties qualify as party-in-interest transactions. The Plan paid fees of \$3,081 to Principal Life Insurance Company for member requested services.
