Note 1 - Plan Description

The following description of In-Situ, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1990 and amended on January 1, 2023. The Plan is available upon hire to all employees, with the exception of union employees, and employees who were previously not treated as employees of the employer but who have been reclassified as employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In-Situ, Inc. (the "Company") is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Reliance Trust Company (Reliance) serves as trustee and offers plan participants a variety of investment options through various mutual funds and a money market fund. T. Rowe Price (TRP) functions as recordkeeper and investment manager, manages plan assets, and maintains the Plan's records. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement. Individual accounts are invested in the various investment options at the direction of participants. The investment advisor is IFAM Capital.

Contributions

Participants may make before-tax and after-tax contributions up to 100 percent of their annual eligible compensation, as limited by the Internal Revenue Service (IRS), which is adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions. Participants are automatically enrolled at 4 percent of eligible compensation unless the participant opts out or elects a different percentage. The Company automatically increases participants' contributions by 1 percent annually unless the participant opts out, elects a different percentage, or is already contributing greater than or equal to 10 percent. The Company may make a matching contribution of 100 percent of elective deferrals up to a discretionary percentage of eligible compensation. During the year ended December 31, 2024, the Company made a matching contribution of 100 percent of elective deferrals up to 2 percent of eligible compensation and 50 percent of elective deferrals for the next 2 percent of eligible compensation. Matching contributions are funded each pay period. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½.

The Company may make nonelective contributions equal to a discretionary percentage to be determined by the Company. There were no nonelective contributions made during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

Note 1 - Plan Description (Continued)

Any employer contributions (including forfeitures) and the earnings or losses thereon not fully vested when contributed will vest as follows:

A participant's account balance becomes 100 percent vested upon death, attaining early retirement age (the age of 55) while an employee, retirement due to disability, or termination of the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of one loan outstanding at any given time. The loans are secured by the balances in the participants' accounts; bear interest at rates that range from 4.25 to 9.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination; and mature at various dates through November 2029. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 30 years from the date of the loan origination. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full. There were no loans that were deemed a distribution in 2024.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan automatically rolls out terminated participant vested account balances of \$5,000 or less. Participants will be notified that they will be automatically removed from the Plan and of the options they have with their account balances to be automatically rolled out of the Plan. The Internal Revenue Service has required minimum distributions once a participant reaches age 70½ during the previous plan year and is no longer employed by the Company.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited and placed into a separate account. Forfeitures are used to pay plan expenses or reduce employer contributions or shall be allocated to participants in the same manner as the employer's contribution. Forfeitures in the amount of \$38,657 were applied to offset employer contributions during the year ended December 31, 2024. The balance of this account at December 31, 2024 and 2023 was \$0 and \$4,968, respectively, recorded in the money market fund on the statement of net assets available for benefits.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by T. Rowe Price or its affiliates. T. Rowe Price is the Plan's recordkeeper; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for loans to participants, which are also party-in-interest transactions that are exempt from the prohibited transaction rules.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Investment Valuation

The Plan's investments are stated at fair value.

Investments in money market and mutual funds are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

The common collective trust funds are valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 2 - Summary of Significant Accounting Policies (Continued)

Additionally, some investments held by Reliance are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

During the year ended December 31, 2024, three investments accounted for 33 percent of investment gain. At December 31, 2024 and 2023, three investments accounted for 40 and 40 percent, respectively, of total investments at fair value.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 10, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Reliance Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics on the asset.

In instances whereby inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
