### Note 1 - Plan Description

The following description of Young Supply Company 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

On April 19, 2024, Young Supply Company (the "Plan Sponsor") was acquired by Heritage Distribution Holdings. Effective April 18, 2024, the Plan was terminated and participants are now eligible to participate in Heritage Distribution Holdings 401(k) Plan, a contribution plan sponsored by the acquiring entity. Accordingly, the descriptions below are provisions of the Plan prior to termination. All plan assets were distributed out of the Plan by October 22, 2024.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Young Supply Company (the "Company") who are not covered by collective bargaining agreements, have completed at least six months of service, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee 401(k) contributions up to a maximum of 92 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions equal to 100 percent of each participant's elective deferral, limited to \$1,200. For the period ended October 22, 2024, matching contributions totaled \$147,090.

Additionally, the Company may make discretionary employer profit-sharing contributions, to be determined annually. There were no profit-sharing contributions for the period ended October 22, 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts limited to the lesser of \$50,000 or half of their vested interest in the Plan, as prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### **Vesting**

Upon the termination of the Plan, all participants' account balances became fully vested and nonforfeitable, in accordance with Section 411(d)(3) of the Internal Revenue Code. This ensures that participants' rights to their benefits are protected upon the Plan's termination.

#### **Payment of Benefits**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company employer contributions. At October 22, 2024 and December 31, 2023, forfeited account balances totaled \$0 and \$13,477, respectively.

#### ***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. As disclosed in Note 1, the Plan was terminated on April 18, 2024.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income***

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with liquidation basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 27, 2025, which is the date the financial statements were available to be issued.

Bank of America, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all investment transactions. The investment balances and participant notes receivable and related income and losses included in the accompanying financial statements are based solely on information certified by the Trustee.

### **Note 4 - Tax Status**

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### **Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 1 - Plan Description

The following description of Young Supply Company 401(k) Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

On April 19, 2024, Young Supply Company (the "Plan Sponsor") was acquired by Heritage Distribution Holdings. Effective April 18, 2024, the Plan was terminated and participants are now eligible to participate in Heritage Distribution Holdings 401(k) Plan, a contribution plan sponsored by the acquiring entity. Accordingly, the descriptions below are provisions of the Plan prior to termination. All plan assets were distributed out of the Plan by October 22, 2024.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Young Supply Company (the "Company") who are not covered by collective bargaining agreements, have completed at least six months of service, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee 401(k) contributions up to a maximum of 92 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions equal to 100 percent of each participant's elective deferral, limited to \$1,200. For the period ended October 22, 2024, matching contributions totaled \$147,090.

Additionally, the Company may make discretionary employer profit-sharing contributions, to be determined annually. There were no profit-sharing contributions for the period ended October 22, 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts limited to the lesser of \$50,000 or half of their vested interest in the Plan, as prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### **Vesting**

Upon the termination of the Plan, all participants' account balances became fully vested and nonforfeitable, in accordance with Section 411(d)(3) of the Internal Revenue Code. This ensures that participants' rights to their benefits are protected upon the Plan's termination.

#### **Payment of Benefits**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

### Note 1 - Plan Description (Continued)

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company employer contributions. At October 22, 2024 and December 31, 2023, forfeited account balances totaled \$0 and \$13,477, respectively.

#### ***Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. As disclosed in Note 1, the Plan was terminated on April 18, 2024.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income***

The Plan's investments are stated at fair value.

The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with liquidation basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 27, 2025, which is the date the financial statements were available to be issued.

### **Note 3 - Certified Information**

Bank of America, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all investment transactions. The investment balances and participant notes receivable and related income and losses included in the accompanying financial statements are based solely on information certified by the Trustee.

### **Note 4 - Tax Status**

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### **Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 6 - Termination - Liquidation Basis**

Effective April 18, 2024, the plan sponsor elected to terminate the Plan. The Plan adopted the liquidation basis of accounting in fiscal year 2024. Under the liquidation basis of accounting, assets are recorded at the amount expected to be collected, and liabilities are recorded at amounts expected to be paid during the course of liquidation.

Liquidation of assets through distributions to participants with account balances occurred during 2024, with full liquidation completed by October 22, 2024.
