REPORT OF INDEPENDENT AUDITORS

To the Trustees of the Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Flynn Brothers Contracting, Inc. 401(k) & Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following brief description of the Flynn Brothers Contracting, Inc. 401(k) & Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Flynn Brothers Contracting, Inc. and Flynn Trucking, LLC (collectively the Company) and is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees who are at least 21 years of age and have at least 90 days of service. The Trustees and Retirement Committee are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings, monitor investment performance, and report to the Company's Board of Directors.

Contributions

Each year, participants may contribute up to 90 percent of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect to not participate in the Plan. Automatically enrolled participants have their deferral rate set at two percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The automatic deferral amount will increase by one percent each year up to a maximum of six percent of plan compensation. At the discretion of management, the Company may make matching contributions to the Plan. Matching contributions were \$138,014 for the plan year ended September 30, 2024.

Certain participants whose services are under a public contract subject to the Davis-Bacon Act or to any prevailing wage law may receive employer prevailing wage contributions. The Company contributes the amount of contracted fringe benefits in excess of any other Company provided qualifying benefits. These prevailing wage contributions are included in employer contributions on the statement of changes in net assets available for benefits. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTES TO FINANCIAL STATEMENTS SEPTEMBER 30, 2024 AND 2023

Transfer of Assets

The Plan has entered into a transfer agreement with the Flynn Brother Contracting, Inc. Employee Stock Ownership Plan (ESOP). The agreement allows for the qualified participants as defined under the ESOP and under the ESOP diversification rules to transfer assets from the ESOP to the Plan.

Rollovers

A participant may contribute any rollover contribution to which the participant is entitled from another qualified trust. Such rollover contributions are deposited in the participant's account.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and all prevailing wage contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their account is based on years of continuous service, as follows:

At September 30, 2024 and 2023, the forfeited non-vested accounts totaled \$906 and \$1,706, respectively. These accounts are to be used to reduce future Company contributions or pay plan administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence. The notes are secured by the balance in the participant's account, bear interest at prime rate plus one percent, and principal and interest are paid through payroll deductions.

Benefit Payments

Upon termination of service due to death, disability, or retirement, participants are entitled to receive a lump-sum payment equal to the value of the participant's account or periodic installment payments. The Plan also permits hardship withdrawals and in-service withdrawals subject to certain restrictions as defined in the plan document.

Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become fully vested in the Company's contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Tax Status

The Plan is based on a volume submitter profit sharing plan which has received a favorable opinion letter from the Internal Revenue Service (IRS) dated March 22, 2021 that the Plan is designed in accordance with applicable sections of the IRS. Therefore, no provision for income taxes has been included in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, as of the date the financial statements were available to be issued, there were currently no audits for any tax periods in progress.

Subsequent Events

The plan administrator has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is July 9, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance, Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, collectively the custodian, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the schedule of assets (held at end of year) as of September 30, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended September 30, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
 - Level 2: Inputs to the valuation methodology include quoted prices for similar assets in active markets; quoted prices for identical or similar assets in inactive markets; inputs other than quoted prices that are observable for the asset; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methods and assumptions used for investments measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.
- *Pooled Separate accounts*: Primarily valued at NAV per share based on quoted market prices of underlying investments. The NAV is used as a practical expedient to estimate fair value.
- *Collective investment trusts*: Valued at the NAV of shares of a collective trust fund. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund. Participant transactions (purchase and sales) may occur daily.

5. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Company and certain others. Officers or employees of the Company perform certain administrative functions for the Plan. No such officer or employee receives compensation from the Plan. The Company serves as the Plan's sponsor. Blue & Co., LLC is the Plan's independent auditors. Principal Life Insurance, Principal Global Investors Trust Company, and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company are collectively the custodian of the Plan and, therefore, the Plan's payment of custodian's fees to them qualifies as party-in-interest transactions. The third-party administrator of the Plan, Retirement Management Services, LLC receives payment from the Company. Notes receivable from participants are also considered party-in-interest transactions. Certain collective investment trusts and pooled separate accounts are managed by the custodian and, therefore, these transactions qualify as party-in-interest transactions.
