## Independent Auditors' Report

### The Plan Administrator of JP Express Service 401(k) Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of JP Express Service 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of Plan

The following description of the JP Express Service 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan established on August 1, 1997, which covers all eligible employees of JP Express Service Inc. (the “Employer”). Employees are eligible to participate and make elective deferrals and receive all employer contributions upon attainment of age 18 and completion of 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

In February 2024, all assets of the Plan except for portions of the Voya Fixed Account were transferred from Voya Retirement Annuity and Insurance Company (“Voya”) to Principal Trust Company (“Principal”). The Employer has elected to transfer the balance in the Voya Fixed Account plus related interest in installments over a six-year period from Voya to Principal.

#### **Contributions**

Each year, participants may defer pre-tax voluntary contributions based on their eligible compensation on a per pay period basis, as defined in the Plan, up to the statutorily permitted amount. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into the various investment options offered by the Plan. The Plan has an automatic enrollment feature whereby eligible participants are automatically enrolled in the Plan at a pre-tax contribution rate of 3% of their eligible compensation upon meeting the eligibility requirements.

In accordance with the Plan document, the Employer may make a discretionary matching and/or nonelective contribution on behalf of eligible Plan participants, in a manner that is determined annually by the Employer. During the 2024 Plan year, discretionary matching contributions of 25% of the first 6% of eligible compensation used for elective deferral contributions was made. During the 2024 Plan year, no nonelective contributions were made.

#### **Vesting**

Participants are one hundred (100%) vested immediately in all elective contributions plus earnings thereon. Participants vest in the discretionary Employer matching contributions and Employer nonelective contributions based on the following table:

### **1. Description of Plan (*continued*)**

#### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,483 and \$21,283. These accounts may be used to reduce future Employer contributions or Plan expenses. During 2024, \$30,122 were used to reduce Employer contributions and \$13,865 were used to pay Plan expenses.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and the Employer discretionary matching contributions, and allocations of: (a) Employer nonelective contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship in accordance with provisions specified in the Plan.

#### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). The loans are secured by the participant's vested account balance and bear interest at the rate reflected in the Wall Street Journal on the date of the loan. A participant may only have one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions. The loan must be repaid within a five year period, unless the loan is used to purchase a participant's principal residence which extends the maturity date of the loan up to a thirty year period.

#### ***Expenses***

Certain expenses related to maintaining the Plan are paid by the Employer and are excluded from these financial statements. Any expenses not paid by the Employer are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **2. Summary of Significant Accounting Policies (continued)**

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the Voya Fixed Account and the Principal Guaranteed Option, which are stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The pooled separate accounts are stated at the value reported to the Plan, which represents the fair value of the underlying investments comprising the accounts. The Voya Fixed Account and the Principal Guaranteed Option are reported at contract value, which represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 10, 2025.

### 5. Voya Fixed Account

The Voya Fixed Account (the "Account") is a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company ("Voya"). The Account guarantees principal and a minimum guaranteed interest rate for the life of the contract, as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period – currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate that applies for the life of the contract. The current rate, the guaranteed minimum floor rate and the minimum guaranteed interest rate are expressed as annual effective yields. Taking the effect of compounding into account, the interest credited to a participant's account daily yields the then current credited rate. Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets.

Under this option, Voya assumes the risk of investment gain or loss by guaranteeing the principal amount allocated to this option and promises a minimum interest rate during the accumulation period and also throughout the annuity payout period. Voya may impose limitations on the ability to transfer funds out of this investment option. Withdrawals from the Account for other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Account is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Voya is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer was evaluated by nationally recognized statistical ratings agencies as follows: Standard & Poor's (A+ as of September 2024), Moody's Investor Service (A2 as of September 2024), and Fitch (A+ as of September 2024).

### 6. Principal Guaranteed Option

The Principal Guaranteed Option ("PGO") is a guaranteed general account-backed group annuity contract issued by Principal Life Insurance Company to Principal Trust Company. Principal and a rate of interest are guaranteed by the full faith and credit worthiness of Principal Life Insurance Company. The PGO meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

A composite crediting rate contractually guaranteed by Principal Life Insurance Company is credited to account balances. The rate is reset on a semiannually basis. The credit risk of the issuer was evaluated by nationally recognized statistical ratings agencies as follows: Standard & Poor's (A+ as of April 2024), Moody's Investor Services (A1 as of July 2024), Fitch (AA- as of June 2024), and A.M. Best Company (A+ as of March 2024).

Benefit payments to participants for plan benefit events, including retirement, termination of employment, disability, plan termination, death, loans, and withdrawals, as allowed by the plan, are made without any surrender charge or early termination charge. There are no restrictions on investment transfers initiated by a participant from the PGO to noncompeting investment options.

The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

### 7. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the Plan had \$8,297 and \$0 in excess contributions payable. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

### **8. Income Tax Status**

The Internal Revenue Service ("IRS") issued an opinion letter, dated June 30, 2020, which states that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **9. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### **10. Party-In-Interest Transactions**

Certain Plan investments are managed by Principal Life Insurance Company and Principal Trust Company, the trustees of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

The Voya Fixed Account was issued by Voya Retirement Insurance and Annuity Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### **11. Prohibited Transaction**

During the 2024 Plan year, the Employer failed to remit to the Plan certain participants contributions and loan repayments amounting to \$41,495 within the period described by the Department of Labor ("DOL") regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer is in the process of making the necessary corrections to satisfy both the DOL and Internal Revenue guidance for the delinquent contributions.

### 12. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
