INDEPENDENT AUDITOR'S REPORT

To the Administrator and Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Quality Management Associates, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 – Description of Plan

The following description of the Quality Management Associates, Inc. (the Company) 401 (k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Quality Management Associates, Inc. and Quality Management Associates – Delaware. The employees can begin participating in the Plan if they have completed 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Participant Contributions

Tax Deferred Participant Contributions

Each active participant may elect to make tax-deferred contributions of up to 100% from their salaries in each payroll period, not to exceed the dollar limit set by law. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trust accounts as investment options for participants.

Catch-up Contributions

All employees who are eligible to make tax-deferred participant contributions under the Plan and who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions in accordance with, and subject to the limitations of the Internal Revenue Code.

Employer Basic Contributions

The Company does not match employee contributions throughout the year.

Employer Discretionary Contributions

The Company may decide to make a non-elective contribution to the Plan, normally in the beginning of October, although the Company is not required to do so. The non-elective contribution will be allocated to all employees eligible to participate in the plan. They must be an eligible participant employed by the Company on September 30 to receive this allocation. If their employment terminates prior to September 30 due to death, disability, or attainment of age 65, they will be eligible to receive any non-elective contribution that the Company may make for the year in which employment terminated.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s discretionary contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings and account balances, as defined.

Note 1 – Description of Plan - continued

Forfeitures arising from terminated participants' unvested accounts are used to reduce employer contributions or offset plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Each participant directs his or her individual investment in the Plan's fund options.

Vesting

All participants are immediately 100 percent vested in their elective deferral and rollover (if any) contribution accounts and the earnings thereon.

If not already previously vested, participants become fully vested upon attainment of normal retirement age, death, or their total and permanent disability, whichever is the first to occur.

If participants leave the Company for any other reason, the vesting schedule for non-elective contribution accounts are as follows:

<u>Years of Service:</u>	<u>Vested %</u>
Less than 1 Year	0%
At least 1 year, but less than 2	20%
At least 2 years, but less than 3	40%
At least 3 years, but less than 4	60%
At least 4 years, but less than 5	80%
5 years of service or more	100%

Notes Receivable from Participants

Effective April 1, 2024, the Plan adopted a provision to permit loans to participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1% which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant is eligible to receive their entire vested account balance in a lump sum distribution.

Forfeited Accounts

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$47,204 and \$41,768, respectively. These accounts will be used to reduce future employer contributions or offset Plan expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of Quality Management Associates, Inc. 401(k) Profit Sharing Plan (the “Plan”) are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes therein during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. The Plan measures fair value as required by Accounting Standards Codification (ASC) 820, *Fair Value Measures and Disclosures*, which provides framework for measuring fair value under U.S. GAAP. Under ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability or, in the absence of a principal market, the most advantageous market for the asset or liability. See Note 3 for the fair value measurement disclosures associated with the Plan’s investments.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation included Plan’s gains and losses on investments purchased and sold as well as held during the year.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or by the Company as provided in the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

The Company has evaluated subsequent events through June 30, 2025, the date on which the financial statements were issued.

Note 3 – Fair Value Measurements

Current accounting guidance on fair value measurements includes the application of a fair value hierarchy that requires us to maximize the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. The Plan's financial instruments, which are mostly at fair value, are categorized into a three-level hierarchy, which is based upon the priority of the inputs to the valuation technique. Level 1 inputs consist of unadjusted quote prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. If the inputs used to measure fair value fall within the difference levels of the hierarchy, the category level is based on the lowest priority level input that is significant to the fair value measurement of the instrument. There were no transfers between Level 1, Level 2, or Level 3 during 2024.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Shares of mutual funds are stated at fair value based on quoted market prices in an active market for each share held by the Plan.

Common Collective Trust: Valued at net asset value, which is based on the latest quoted market price of the investments held within the fund.

Note 5 – Related Parties and Parties' Interest in Transactions

At September 30, 2024, the Plan held units of common collective trusts accounts managed by the Plan Custodian. These transactions qualify as party-in-interest transactions (as defined by ERISA); however, they are exempt from the prohibited transaction rules under ERISA.

Note 6 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a Volume Submitter Profit Sharing Plan with CODA letter dated March 29, 2012 that the Plan and related trusts are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by tax authorities for three years after filing; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 8 – Certified Investments

The Plan Sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held as of September 30, 2024 and 2023, and investment loss for the year ended September 30, 2023 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan Sponsor and certified as complete and accurate by the Reliance Trust Company for 2024, the trustee of the Plan.

Note 9 – Subsequent Events

Effective October 1, 2024, the Plan has been amended to include a Safe Harbor Matching Contribution equal to 100% of salary deferrals that don't exceed 3% of compensation plus 50% of salary deferrals between 3% and 5% of compensation. The contribution is 100% vested.
