## **Independent Auditors' Report**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Young Corporation 401(k) Retirement Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

**Basis for Opinion**

**Note 1 - DESCRIPTION OF PLAN**

The following description of the Young Corporation 401(k) Retirement Plan provides only general information. Participants should refer to the plan agreement or summary plan description for a more complete description of the plan's provisions, which are available from the plan administrator.

**GENERAL**

The plan is a defined contribution plan covering all employees of the plan sponsor, Young Corporation (the "company"), who are age twenty-one or older, have completed one year of service and have worked at least 1,000 hours. The trustees are responsible for oversight of the plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Each year, participants may contribute a percentage of eligible annual compensation, as defined in the plan agreement. Participants age 50 or older, who are making contributions to the plan, are allowed to make catch-up contributions as defined in the plan. Participants may also contribute amounts representing rollover distributions from other qualified plans. Additionally, the plan includes an auto-enrollment provision where all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. The auto-enrollment deferral rate is set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

The company may make matching contributions. These matching contributions are limited to 50% of employee contributions or a maximum of \$2,000 per participant. The company made matching contributions of \$121,616 and \$119,843 for the years ended December 31, 2024 and 2023, respectively.

Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**PARTICIPANT INVESTMENT ACCOUNT OPTIONS**

Upon enrollment in the plan, participants are able to direct their contributions, including company contributions, among any or all of the investment account options. Investment options are a pooled separate accounts and a guaranteed interest fund held by Standard Insurance Company. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options daily. There are no non-participant directed investments.

Contributions may be temporarily held as cash balances prior to the execution of the investment according to the participant's direction.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution and allocations of (a) the company matching contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately vested in their voluntary contributions and employer contributions plus actual earnings thereon.

**PAYMENT OF BENEFITS**

On termination of service due to death, disability or retirement, a participant may elect to receive either a single lump-sum distribution equal to the value of the participant's vested interest in his or her account, partial withdrawals of at least \$1,000, or installments to be paid over a period of not more than the participant's assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**HARDSHIP WITHDRAWALS**

Participants are permitted to withdraw, in a single sum, the vested portion of their account balance under certain conditions. These conditions include unreimbursed medical expenses, the purchase of the participant's principal residence, the payment of post-secondary education tuition, the payment of funeral expenses, casualty losses (as defined by the Internal Revenue Code) or to prevent eviction or foreclosure from the participant's principal residence.

**Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****BASIS OF ACCOUNTING**

The financial statements of the plan are prepared on the accrual method of accounting.

**USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**GUARANTEED INTEREST FUND**

The plan's guaranteed interest fund is valued at contract value as contract value is the relevant measurement attributable to fully benefit-responsive investment contracts. Contract value represents the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Contract value approximates fair value of the guaranteed interest fund.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's trustees determine the plan's valuation policies utilizing information provided by the investment custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **CONTRIBUTIONS**

Contributions from plan participants and the matching contributions from the company are recorded in the year in which the participants' contributions are withheld from compensation.

#### **EXCESS CONTRIBUTIONS PAYABLE**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code are recorded as a liability with a corresponding increase to corrective distributions. The plan distributed the excess contributions to the applicable participants prior to March 15 of the following year.

#### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

#### **ADMINISTRATIVE EXPENSES**

Certain expenses of the plan are paid by the company and are not included in the accompanying financial statements. Certain expenses of maintaining the plan are paid by the plan and included in administrative expenses. Additionally, fees related to distributions are charged directly to the participant's account and are included in administrative expenses.

#### **SUBSEQUENT EVENTS**

The plan has evaluated subsequent events through July 8, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

### **Note 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, the custodian of the plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Fair value of the pooled separate account
- Contract value of the guaranteed interest fund
- Net appreciation (depreciation) in fair value of investments
- Interest income
- Investments, as reflected in Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year)

The plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**Note 4 - GUARANTEED INTEREST FUND**

The plan has an investment contract with Standard Insurance Company. Contributions to the fund are held in a general account of Standard Insurance Company. The objective of the fund is to protect against loss of principal while providing returns comparable to money market funds and short-term treasury instruments. Characteristics of this investment allow for principal value to remain stable regardless of the volatility of the financial markets. This contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measurement of fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value represents contributions made, plus earnings, less participant withdrawals, and administrative expenses.

The guaranteed interest fund has no stated maturity. The interest rate, which will never be below 3% annually, is reset monthly as of the beginning of each month, during which a new interest rate is applied daily to the total outstanding balance of the investments. For deposit liabilities with no defined maturities, the fair value is the amount payable on demand at the reporting date. Accordingly, the contract value approximates the fair market value.

The plan's ability to receive amounts due is dependent on the fund's ability to meet its financial obligations. The fund's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the plan to transact at contract value with the fund. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the fund and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the fund to terminate the contract with the plan and settle at an amount different from contract value. Such events could include (1) an uncured violation of the plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the fund.

**Note 5 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the pooled separate account is based on inputs other than quoted market prices that are observable for valuing the asset or liability, either directly or indirectly. Observable inputs include quoted market prices for similar assets or liabilities in active or non-active markets.

**Note 7 - RISKS AND UNCERTAINTIES**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as tariffs, a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA.

**Note 9 - TAX STATUS**

The plan adopted a Prototype Non-Standardized 401(k) Plan with deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated the plan and trust are designed in accordance with the applicable sections of the IRC. Once qualified, the plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that as of December 31, 2024, the plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the plan's financial statement.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10 - PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are invested in a guaranteed interest fund managed by Standard Insurance Company. Fees paid by the plan for investment management services are included in administrative expenses in the accompanying financial statements. These transactions qualify as party-in-interest transactions.
