## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Kett Engineering Corporation Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Kett Engineering Corporation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

1. DESCRIPTION OF THE PLAN

The following description of Kett Engineering Corporation Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Kett Engineering Corporation (the "Company", "Employer", or "Plan Sponsor"), is designed to qualify under Section 401(a) and related provisions of the Internal Revenue Code ("IRC"). The Plan was established on January 1, 1993, and most recently amended effective November 28, 2023. The Plan is designed to provide eligible participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, or financial hardship. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reports and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent laws and the IRC.

An expansion of Setting Every Community Up for Retirement Enhancement ("SECURE") Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates for these provisions vary through 2026. The Plan Sponsor has until the end of the first plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Custodial services are provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Custodian"), while record-keeping services are performed by Principal (the "Record-keeper"), an affiliate of the Custodian (collectively "Principal"). The Custodian is responsible for the custody and management of the Plan's assets, while the Record-keeper managed participant accounts and participant related transactions.

Eligibility

Employees are eligible to participate in the Plan after completing one (1) year of service and upon attainment of age twenty-one (21). A year of service is calculated as a period during which an employee has completed at least 1,000 hours of service. Entry dates are the first day of each month after the employee meets the eligibility requirements. Eligible participants are automatically enrolled to defer 5% of their pay unless they elect a different percentage, including zero.

Contributions

Under the terms of the Plan, participating employees may contribute up to 100% of their eligible compensation as pre-tax or Roth contributions, not to exceed the amount allowable under federal limitations, which was \$23,000 for 2024. Participants age 50 or over may also contribute an additional \$7,500 in catch-up contributions to the Plan for 2024. Participants may also rollover amounts representing distributions from other qualified retirement or profit sharing plans. The Company may elect to make discretionary matching contributions to the Plan. The Company elected to make a matching contribution of five percent (5%) of each participant's pre-tax contribution for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, rollover contributions, the Company's contributions, and the Plan's earnings, and charged with the Plan's losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investments of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Payment of benefits

Distributions and withdrawals are payable to participants upon retirement, termination of employment, attainment of age 59 ½, attainment of early retirement age and six years of vesting service, financial hardship, disability, or to a beneficiary upon a participant's death. If a participant's account balance is less than or equal to \$1,000 upon termination, the balance is distributed in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. Balances greater than \$1,000 and less than or equal to \$5,000, are automatically rolled over into an individual retirement account unless a lump-sum cash payment is requested by the terminated participant. If a participant's account balance is greater than \$5,000 upon termination, the participant can consent to a distribution paid in the form of a lump-sum cash payment, installment payments, a direct rollover into another qualified plan, or to postpone payment to a later date and remain in the Plan as described in the plan documents.

Upon attaining the age of 59 ½ the participant may, while still employed by the Company, request a withdrawal from their account balance. Hardship distributions are permitted under limited circumstances as defined in the plan documents.

Notes receivable from participants

Participants may borrow not less than \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Notes receivable from participants ("participant loans") must be repaid within five years, unless the participant's loan is used to acquire a primary residence, in which case the repayment term may exceed five years. Participant loans are secured by the respective participant's vested account balance, and bear interest at a rate commensurate with local prevailing rates for instruments with similar characteristics at the time of issuance. Principal and interest are generally paid ratably through payroll deductions with payments made each pay period. Outstanding participant loans at December 31, 2024, bear interest at annual rates of between 3.25% and 8.50%, and mature at various dates through August 2029.

Administrative expenses

Administrative expenses cover the routine plan expenses for the services of lawyers, accountants, third-party administrators, and other advisors. The Plan requires that certain expenses related to the Plan be paid directly by the Company, but permits certain expenses incurred to administer the Plan to be paid from the Plan's assets. All administrative expenses reflected in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 were paid by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments held by a defined contribution plan are required to be reported at fair value (see Note 4). Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Custodian.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions and contributions receivable

Contributions are recorded based on the date the contributions or repayments have been separated from a participant's pay which is the pay date. The Plan records receivables for contributions based upon the contribution recognized, less amounts received by the Plan as of the last day of the plan year. Discretionary employer matching contributions, if any, are recorded in the year they are earned.

Contributions representing participant rollovers from other qualified plans are recorded when received.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are recorded as deemed distributions based upon the terms of the plan documents.

Payment of benefits

Benefit payments to participants are recorded when paid.

Administrative expenses

Expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through July 7, 2025, the date the financial statements were available to be issued. No subsequent events have occurred that would have a material impact on the presentation of the Plan's financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodian, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's market assumptions.

- *Level 1* - quoted prices in active markets for identical assets or liabilities;
- *Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

- *Level 3* - inputs are unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Registered investment companies (mutual fund investments)

Mutual fund investments are valued at the net asset value ("NAV") of shares held by the Plan at year end which are determined and published and is the basis for current transactions. These investments are classified within Level 1 of the valuation hierarchy.

Pooled separate accounts

Pooled separate accounts are units of participation in the pooled account and through those units of participation share in the gains and losses of all investments in the pooled account. Principal uses a unit value system of recordkeeping to track its obligations regarding the pooled separate accounts. Unit value means the dollar value for one unit. Contributions and transfers to the separate account increase the separate account's outstanding units. Payments, deducted expenses, and transfers from the separate account decrease the separate account's outstanding units. Pooled separate accounts are included in the fair value hierarchy table as Level 2 investments.

Common collective trust

Investments in the collective investment fund are valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less fees and expenses, divided by the number of outstanding units. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan was to initiate a full redemption of the collective investment funds, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation is carried out in an orderly business manner. Investments in the common collective trusts have no unfunded commitments and can be redeemed daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 850, *Related Party Disclosures*, except that ERISA's definition is broader and includes all entries and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the plan year related to compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with fiduciaries or participants of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee associate or relatives of such persons.

The Plan engages Principal Life Insurance Company and its affiliates for custodial, recordkeeping, and investment management services, and Global Retirement Partners, LLC for investment advisory services. These entities are considered parties-in-interest. Fees paid to these service providers were deemed reasonable and represent exempt transactions under ERISA Section 408(b)(2).

The Custodian also earns compensation in the form of short-term interest (or "float") when funds are received either without investment instructions or past the point in a day when funds can be invested. Such amounts are held by a financial institution and earn interest at an interest rate provided by the financial institution from time to time.

7. TAX STATUS

The Plan has adopted the standardized pre-approved profit sharing plan with Cash or Deferred Arrangement ("CODA") sponsored by Principal Life Insurance Company. The Internal Revenue Service informed Principal Life Insurance Company by a letter dated June 30, 2020, that its pre-approved plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
