These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the C.D. Smith Construction, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of C.D. Smith Construction, Inc. (the "Company"). Employees who are not members of a union or leased employees, are at least 18 years of age, and have completed 1/12 years of service are eligible for employee deferrals and employer match contributions. Profit sharing contributions are provided to non-union employees who have completed one year of service (1,000 hours) and are employed on the last day of the Plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Plan Administration

The Plan is administered by Merrill Lynch as the recordkeeper and Bank of America as the trustee of the Plan.

Contributions

Employees of the Company are eligible to participate in the Plan with elective deferrals and matching contributions upon completing one month of service. Matching contributions are made by the Employer at an amount equal to 100% of the first 5% of employee deferrals.

In 2024 and 2023, a portion of the Company's current or accumulated profits, as determined by the board of directors, may be contributed for the benefit of all employees who participate in the Plan. Such contributions for any fiscal year may not exceed certain limitations.

Participant Accounts

Each participant's account is credited with an allocation of: (a) employee contributions; (b) the Company's matching contribution; (c) the Company's profit sharing contribution; (d) plan investment income (loss); and (e) forfeitures of terminated participants' non-vested accounts. Profit sharing allocations are based on participant compensation or beginning account balances, as defined in the Plan document.

The Plan does not allow loans to be taken out of Plan participants' and beneficiaries' accounts.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover amounts, and employer match contributions plus actual earnings thereon. Profit sharing contributions are vested in accordance with the following schedule:

Payment of Benefits

Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to such participant's account. Upon disability, death, termination or retirement, the participant or beneficiary will receive, at the sole discretion of the participant or beneficiary, either; (i) a lump sum equal to the vested value of the funds allocated to their account; or (ii) equal periodic installment payments for a period of time.

Forfeited Accounts

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$40,527 and \$70,450, respectively. For the years ended September 30, 2024 and 2023, employer contributions were reduced by \$14,089 and \$12,245, respectively, from forfeited non-vested accounts.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies consistently applied in the preparation of the accompanying financial statements follow.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP"), management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays a portion of the Plan's administrative expenses. Certain plan administrative expenses are paid by the Plan and are expensed as incurred.

NOTE C - FAIR VALUE MEASUREMENTS

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Collective trust funds - Valued at the net asset value ("NAV") provided by the administrator of the fund as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investments in the fund, which are valued at the last reported sales price on the valuation date.

Mutual funds - Valued at the quoted prices of the fund in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - TAX STATUS

The prototype plan has obtained an opinion letter dated March 31, 2014, in which Internal Revenue Service ("IRS") stated that the restated prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator timely adopted the restated prototype plan. The Plan administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan. In the event of plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

NOTE F - RELATED PARTY TRANSACTIONS

Certain plan investments are managed by Merrill Lynch. Merrill Lynch is the trustee as defined by the Plan and therefore, any transactions with Merrill Lynch qualify as party-in-interest transactions.

Certain plan administrative expenses are paid by the Company.

NOTE G - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Merrill Lynch ("Trustee") has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments and cash, as shown in the statements of net assets available for benefits as of September 30, 2024 and 2023;
- Investment income (loss), as shown in the statements of changes in net assets available for benefits for the years ended September 30, 2024 and 2023; and
- Schedule H, line 4i - schedule of assets (held at end of year), as of September 30, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE H - NONEXEMPT TRANSACTION

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate participant contributions from its general assets as soon as practicable, but in no event more than 15 business days following the end of the month in which amounts are withheld from wages. During 2023 Plan year, the Company failed to remit to the Plan's trustee certain participant contributions totaling \$800 within the period prescribed by DOL regulations. Delays in remitting participant contributions to the trustee were due to administrative errors. The delayed contributions are considered prohibited, or nonexempt, transactions. The Plan Sponsor has corrected the lost earnings for the 2023 Plan year in the 2024 Plan year, in accordance with applicable IRS guidelines in order to maintain the Plan's qualified tax status.

NOTE I - SUBSEQUENT EVENTS

The Plan evaluated its September 30, 2024, financial statements for subsequent events through June 24, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
