**Opinion**

We have audited the financial statements of The Bradbury Company Employee Health Care and Dental Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets arising from cash transactions as of September 31, 2024 and 2023, the related statement of changes in net assets arising from cash transactions for the year ended September 31, 2024, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets arising from cash transactions as of September 31, 2024 and 2023, and the changes in its net assets arising from cash transactions for the year ended September 31, 2024, in accordance with cash basis of accounting as described in Note 2.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Emphasis of Matter-Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. **1. DESCRIPTION OF THE PLAN**

The following description of The Bradbury Company Employee Health Care and Dental Care Plan (Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan. The Board of Trustees is responsible for oversight of the Plan.

General - Employees become eligible to participate in the Plan on the first day of the calendar month following the participants date of hire. Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The benefits are funded by Bradbury Co., Inc. and its domestic subsidiaries (collectively, Company) and participating employees. No participant will be required to contribute an additional amount or be entitled to a refund as the result of the actual expense incurred for any year. All funds contributed are to be held for the exclusive benefit of the participants.

Benefits - The VEBA trust provides benefits covering participating employees of the Company who have met the eligibility requirements. Eligible employees may also enroll their dependents in the Plan. A participant's dependents include a spouse and any children, age 26 and under. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Premiums for these insured benefits are paid from the assets of the VEBA trust.

Contributions - A trust agreement established under the Plan requires that, in addition to meeting the eligibility requirements in the Plan, all employees desiring to participate in the Plan must authorize the Company to make appropriate payroll deductions to meet employee contribution requirements. The amount of contributions required by each participant shall be determined by the Board of Trustees in advance from time to time as they deem necessary. The amount of employees' contributions should be adjusted at least annually on the first day of the Plan year.

In addition to the employees' contributions, the Company is required to fund the Plan's unfunded claims paid and administrative expenses.

Continuation Coverage - The Plan contains provisions allowing terminated employees and dependents that become ineligible for the Plan to continue participation in the Plan. The ineligible participants are billed separately for their participation in the Plan and the premium payments received from the terminated employees are recorded as employee contributions in the Plan financial statements.

Administrative Expenses - Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan and no such costs are therefore included in these financial statements. Administrative fees for claims and reinsurance contracts are paid by the VEBA trust.

Self-insured Benefits - The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or general assets of the Company. Despite the Plan's utilization of third-

party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Company maintains a contract with Blue Cross Blue Shield of Kansas to administer the payment of medical, dental and prescription drug benefit claims.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The financial statements are prepared on the cash basis of accounting. Transactions are recorded when a transfer of funds is made without recognition as to when income was earned or expenses incurred. The difference between the cash basis and the accrual basis of accounting required by accounting principles generally accepted in the United States of America would involve the recording of receivables from the Company and employee contributions, claims payable, claims incurred but not reported or not paid, insurance premiums payable and administrative expenses incurred but not paid.

Cash - The Plan maintains its cash in bank deposit accounts that, at times, may exceed the federally insured limits. The Plan has not experienced losses in such accounts.

Contributions - Premiums paid by the Plan for expected claims as annualized by Blue Cross Blue Shield of Kansas are contributed to the Plan by employees and the Company and are included as contributions in these financial statements. Contributions are recorded when received.

Claims Paid - Claims are recorded when paid in accordance with the cash basis of accounting. Based on the lag method, unrecorded estimated medical claims payable and unrecorded claims incurred but not reported were approximately \$547,000 and \$527,000 as of September 30, 2024 and 2023, respectively. These obligations will be funded through subsequent contributions or from existing cash in the Plan.

Reinsurance - The Plan limits its risk through reinsurance of medical and dental benefits. The Plan has a contract with Blue Cross Blue Shield of Kansas which includes reinsurance coverage for claim losses as specified by a formula and pays specific losses exceeding \$200,000 and aggregate losses in excess of 125% of the Expected Incurred Claims Expense and the Administrative Fee. Reinsurance and administrative expenses are recorded when paid by the Plan.

Estimates - The preparation of financial statements requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Subsequent Events - These financial statements considered subsequent events through July 7, 2025, the date these financial statements were available to be issued.

**3. TAX STATUS**

The VEBA trust funding benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated September 27, 1993, stating that the trust is tax exempt under the provisions of Section 501(a) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded for the year ended September 30, 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan, including any amendments to the Plan since receiving the determination letter, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements related to all open periods. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**4. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company has the right under the Plan to modify the benefits provided to, and the contributions required of, participants; to discontinue its contributions at any time; and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for the purposes other than for the exclusive benefit of the Plan's participants.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan deductions are payments to Blue Cross Blue Shield of Kansas (party-in-interest), who performs administrative services for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Total fees incurred and paid directly by the Plan for these administrative services were \$237,431.
