Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Metal Craft Machine & Engineering, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Basis of Accounting

We draw your attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1 - Description of Plan

The following description of the Metal Craft Machine & Engineering, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Metal Craft Machine & Engineering, Inc. and Riverside Machine & Engineering, Inc. (collectively, the Company or Employer). The Plan was established on January 1, 1985, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The named fiduciaries determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Eligibility

Employees not covered by a collective bargaining agreement are generally eligible to participate in the Plan if they have completed 60 days of service and are 18 years of age.

Entry Date

Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

Additionally, the Employer may, at its discretion, make contributions annually as defined in the Plan document. For the year ended September 30, 2024, the Employer elected to match 25% of the employee's deferral, up to a maximum deferral of 12% of compensation. The Company's matching contribution totaled \$305,399 for the year ended September 30, 2024. The Company may also make discretionary, non-matching contributions, but no such contributions were made during 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a target date fund based on their age until changed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company matching contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Investment Options

Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon. A participant becomes fully vested in discretionary employer contributions upon reaching normal retirement age, death, or disability. A participant is 100% vested after 6 years of credited service. A year of service means completion of at least 1,000 hours of service during the applicable computation period.

Vesting is based on years of credited services as set forth in the following table:

2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years	100%

Forfeitures

At September 30, 2024 and 2023, forfeited non-vested accounts totaled \$164,092 and \$159,074, respectively. These accounts will be used to reduce future employer contributions, pay reasonable Plan expenses, or restore participant accounts upon claiming returned distribution checks. During the year ended September 30, 2024, forfeited non-vested accounts of \$16,425 were used to pay administrative expenses of the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. The loan interest rate is determined by the Plan Administrator based on local prevailing rates. Principal and interest are paid ratably through payroll deductions over no more than five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the loan terms can range up to 30 years. A participant may have no more than one outstanding note at any one time.

Payment of Benefits

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death, or disability. A terminated participant with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59½ or hardship as defined in the Plan document.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, transactions are recorded on the cash basis and investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value.

Use of Estimates

The preparation of the financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income are recorded on the cash basis. The net appreciation in the fair value of investments consists of the realized gains or losses on investments bought and sold as well as the change in unrealized depreciation on held investments.

The classification of investment earnings reported in the statement of changes in net assets available for benefits – modified cash basis may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and the related Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances. Interest income is recorded as received. Related fees are recorded as administrative expenses and are expensed as paid. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits – modified cash basis. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits – modified cash basis.

Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, the date which the financial statements were available to be issued.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Money market deposit accounts – Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts – Valued at fair value based on the NAV of units held of the collective fund. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the fund, less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 4 - Information Certified by the Agent of the Custodian and Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at September 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, an agent of Transamerica Life Insurance Company, the custodian of the Plan, and Transamerica Trust Company, the trustee of the Plan. Effective June 28, 2024, the Plan changed its qualified institution from Reliance Trust Company to Transamerica Trust Company.

Note 5 - Tax Status

The Plan uses a pre-approved plan document sponsored by Transamerica Retirement Solutions, LLC, which received an opinion letter from the Internal Revenue Services (IRS) dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and, except as noted below, is currently being operated in compliance with the applicable requirements of the IRC.

The Plan sponsor fell behind on filings once the Plan required an audit. The sponsor made significant efforts to get the filings back into compliance but faced scope limitations on four years of filings from 2006 to 2009. The remaining fiscal years through September 30, 2019, were filed under the Delinquent Filer Voluntary Compliance Program (DFVCP), which allows a delinquent filer relief for self-correction. The Plan was also delinquent on depositing a significant amount of employee contributions that were ultimately corrected, including the remittance of lost earnings. The Plan and its legal counsel also corrected other operational failures and believe these remedies to be sufficient, and that these failures will not jeopardize the tax status of the Plan.

The Plan is subject to routine audits by taxing jurisdictions; but there are currently no audits for any tax periods in progress. However, the Plan was under investigation by the Employee Benefits Security Administration (EBSA), a division of the DOL. A closing letter was received on February 5, 2025, that required no further action.

Note 6 - Contract with Insurance Company

The Plan entered into a fully benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). Transamerica maintains contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, and there is no maximum or minimum rate. Such interest rates are reviewed on a semiannual basis for resetting. The contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Because the contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measure for the contract, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Transamerica represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at September 30, 2024 and 2023, was \$1,124,838 and \$855,040, respectively. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The Plan's ability to transact at contract value with Transamerica is not limited as long as the contract is not under liquidation. Generally, liquidation has to be initiated by the Plan sponsor or by Transamerica either due to a) the Plan is changed so as to significantly affect their obligations under the contract, b) the contract can no longer be treated as a pension plan contract, c) the Plan is terminated, d) the contract holder fails to comply with the requirements of the contract, e) the contract holder, except by unintentional omission, fails to give them the information needed under the contract or fails to furnish copies of required documents, or f) the account falls below \$20,000. The Plan Administrator does not believe that any of these events are probable of occurring.

Note 7 - Related Party and Party-in-Interest Transactions

The insurance contract described in Note 6 and the money market deposit accounts are managed by Transamerica Life Insurance Company, the custodian, as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

The custodian provides certain administrative services to the Plan pursuant to a service agreement between the Plan and the custodian. The custodian receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan.

If the revenue received by the custodian from such mutual fund service providers exceeds the amount owed under the service agreement, the custodian remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participant. During the year ended September 30, 2024, revenue in the amount of \$55,692 was used to pay administrative expenses.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.

Note 9 - Delinquent Participant Contributions

During 2022, the Company failed to remit to the Plan's custodian certain employee contributions totaling approximately \$225, within the period prescribed by DOL regulations. Delays in remitting contributions to the trustee were due to administrative errors. While the amounts have been deposited, the deposit of lost earnings is pending as of September 30, 2024.
