Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of UMI Company, Inc. Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of UMI Company, Inc. Profit Sharing 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 PLAN DESCRIPTION

The following description of the UMI Company, Inc. Profit Sharing 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Effective October 1, 2023, the Plan was amended to adopt safe harbor provisions. The Plan is a safe harbor defined contribution plan covering substantially all full-time employees of UMI Company, Inc. The following related employers participate in the Plan: Spantek Expanded Metal, Inc. and Blow Molded Specialties, Inc. Midwest (collectively, "the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by management personnel appointed by the Company. Third Party Administrators serve as the trustee of the Plan, maintain the records of the participant data and hold the Plan assets.

Eligibility

Employees of the Company are generally eligible to make contributions to the Plan and receive employer contributions upon completion of three months of service. Employees can enroll in the Plan immediately upon satisfying the eligibility requirements.

Contributions

Each year, participants may contribute up to 60 percent of eligible compensation up to the maximum allowed by the law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Plan contains an automatic enrollment feature whereby upon satisfaction of the Plan's eligibility requirements, the Company will begin to automatically defer 6 percent of an employee's compensation on a pre-tax basis unless the employee makes the election to not participate. Participants automatically enrolled in the Plan will be invested in a designated fund until changed by the participant. Effective October 10, 2023, the Plan was amended to change the automatic enrollment rate to 4 percent on a pre-tax basis.

The Company contributes a discretionary match equal to 100 percent of each participant's elective deferrals not exceeding 4 percent of the participant's compensation. As of October 1, 2023, the Company contributes a safe harbor matching contribution equal to 100 percent of each participant's elective deferrals not exceeding 4 percent of the participant's compensation. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contributions, and an allocation of the plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Participants' Investment Options

Participants must direct their salary deferral contributions and Company contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting Fidelity.

Vesting

Participants are immediately vested in their deferral contributions, rollover contributions, plus actual earnings thereon. In addition, participants are immediately vested in any matching contributions received from the Company plus actual earnings thereon.

Forfeitures

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$57 and \$55, respectively. This account is used to reduce employer contributions or pay plan expenses. During the years ended September 30, 2024 and 2023, \$0 of forfeitures were used to reduce employer contributions or pay plan expenses.

Payment of Benefits

Upon retirement, termination of employment, disability, or death, a participant or his or her beneficiary in the event of death, may elect to receive either a lump-sum amount equal to the total vested value of their account, or rollover the balance into an IRA or another plan of their choice. Additionally, participants may take an in-service distribution of all vested sub-account balances upon reaching age 59 ½. Generally, certain minimum distributions are required for participants who have separated from service and have reached the required minimum distribution age.

For terminated employees who have not elected distribution with vested balances greater than \$1,000, but less than \$7,000, accounts may be subject to a mandatory distribution through a rollover to an individual retirement account. For terminated employees who have not elected distribution with vested balances of \$1,000 or less, accounts may be subject to a mandatory distribution through a lump-sum payment.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Notes Receivable from Participants

Participants may borrow from the Plan in any amount greater than \$1,000 and less than \$50,000 or 50 percent of the participant's vested account balance, minus the highest outstanding loan balance in the last 12 months, whichever is lower. Loans bear interest at a rate determined by the Plan Administrator which is based on prevailing market rates. Participants are limited to 2 outstanding loans at any given time. Generally, loans are for a period of 5 years unless the loan is used to aid in the purchase of a principal residence, which must then be repaid within 10 years. Principal and interest are paid ratably during the year through payroll deductions and credited to the participant's account.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded at September 30, 2024 and 2023, respectively.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain other administrative expenses were paid by the plan sponsor or from the Plan's assets. Administrative expenses paid by the plan sponsor are not reflected in the accompanying financial statements. Participant accounts are assessed a separate fee for the administration of loans and benefit payments.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

NOTE 3 FAIR VALUE MEASUREMENTS

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at September 30, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

NOTE 5 INCOME TAX STATUS

The Plan is a Pre-Approved Plan sponsored by the trustee and adopted by the Company. The Internal Revenue Service informed the trustee by an advisory letter dated June 30, 2020, that the Pre-Approved Plan is acceptable under section 401 of the Internal Revenue Code. The Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a significant uncertain tax position that more likely than not would be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Fidelity Management Trust Company as trustee of the Plan qualifies as a party in interest. Total fees paid to Fidelity Management Trust Company for the years ended September 30, 2024 and 2023 were \$7,345 and \$9,069, respectively.

Fidelity Management Trust Company may receive revenue from mutual fund service providers for services Fidelity Management Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Fidelity Management Trust Company for its administrative services to the Plan.

NOTE 9 RISKS AND UNCERTAINTIES

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 NON-EXEMPT TRANSACTIONS

During the year ended September 30, 2023, the Company failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$25,395, in accordance with the plan asset provisions of the Department of Labor (“DOL”) Regulation 2510.3-102, resulting in prohibited, or nonexempt, transactions. During the year ended September 30, 2024, the Company reimbursed the Plan for lost earnings. The correction was made from the Company’s assets and not from the assets of the Plan.

During the year ended September 30, 2024, the Company failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$24,374, in accordance with the plan asset provisions of the Department of Labor (“DOL”) Regulation 2510.3-102, resulting in prohibited, or nonexempt, transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating and submitting amounts to the Plan to reflect foregone earnings that would have been credited to participants’ accounts if the late remittances had been made on a timely basis.

NOTE 11 SUBSEQUENT EVENTS

No significant events occurred subsequent to the Plan’s year end. Subsequent events have been evaluated through June 20, 2025, which is the date these financial statements were available to be issued.
