Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Ames Construction, Inc. Health & Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and benefit obligations for the year ended September 30, 2024 and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of Ames Construction, Inc. Health & Welfare Plan as of September 30, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the year ended September 30, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ames Construction, Inc. Health & Welfare Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ames Construction, Inc. Health & Welfare Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 DESCRIPTION OF PLAN

The following description of Ames Construction, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on October 1, 2022 to provide health and other benefits to eligible employees and eligible dependents of Ames Construction, Inc. (the Company). In general, full-time nonunion employees working at least 30 hours per week on a regular basis and pre-age 65 nonunion retirees are eligible to participate.

Certain Plan assets are held in a trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. The costs of the postretirement benefit plan are shared by the Company and retirees. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, accidental death and dismemberment, and voluntary worksite benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), long-term and short-term disability benefits, and voluntary worksite benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums are paid to insurance companies from the general assets of the Company.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Self-Insured Benefits

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Health Savings Account

Individuals enrolled in certain high-deductible health plans (HDHPs) can establish a health savings account (HSA) to receive tax-favored contributions (from either the employee or employer). The contribution made to the HSA is used on a tax-free basis to pay or reimburse qualifying health expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as Administrative Expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Health Savings Account

Employee and employer contributions to the HSA are included in employee and employer contributions, respectively, on the statement of changes in net assets available for benefits. Amounts are transferred regularly to the HSA vendor and recorded as "Transfers to Health Savings Accounts" as the participant owns the account and the Plan has no obligation to pay any benefits from these funds.

Payment of Benefits

Claim payments and premiums are recorded when paid by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Refunds

Refunds due from the Plan's pharmacy benefits manager are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid.

Stop Loss

Stop loss refunds totaling \$2,057,652 have been included in Employer Contributions in the accompanying statement of changes in net assets available for benefits for the year ended September 30, 2024.

Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.

NOTE 3 CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at September 30 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment and are recorded as claims incurred but not reported on the statement of benefit obligations.

NOTE 4 PREMIUMS PAYABLE

Premiums for insured benefits are incurred monthly and any outstanding premiums not paid as of the end of the year are recorded as premiums payable on the statements of benefit obligations.

NOTE 5 POSTRETIREMENT BENEFIT OBLIGATIONS

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Company and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (a) currently retired or terminated employees and their beneficiaries and dependents, and (b) active employees and their beneficiaries and dependents after retirement from service with the Company.

NOTE 5 POSTRETIREMENT BENEFIT OBLIGATIONS (CONTINUED)

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, the weighted-average health cost trend was 7.25% and 7.50% in 2024 and 2023, then reducing 0.25% per year for 9 and 10 years, reaching 5.00% in plan year 2033 and after. The dental and vision costs trend rate was 4.00%.

The weighted-average health care cost trend rate assumption has a significant effect on the amounts reported as postretirement benefit obligations. If the assumed rates increased by 1 percentage point in each year, it would increase the obligation as of September 30, 2024 and September 30, 2023 by \$134,065 and \$124,312, respectively.

The following were other significant assumptions used to determine the postretirement benefit obligations as of September 30:

Weighted-average discount rate – 4.93%

Average retirement age rates - Various rates ranging from 20% at age 62 to 100% at age 65

Mortality – Pri-2012 No Collar Healthy Headcount

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the benefit obligations.

NOTE 6 TAX STATUS

The trust is used to fund certain benefits of the Plan for prevailing wage employees. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or for on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

As described in Notes 1 and 2, the Plan has several arrangements with service providers. These transactions qualify as party in interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 9 RISKS AND UNCERTAINTIES

The liability for claims payable and claims incurred but not reported (IBNR) was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The actuarial present value of postretirement benefit obligations is reported based on certain assumption pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is a least reasonably possible that changes in the estimates and assumptions in the near term would be material to the financial statements.
