### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Elwyn New Jersey 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 through September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of September 30, 2024 and December 31, 2023, and for the period from January 1, 2024 through September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental Schedule H, line 4a - Schedule of Delinquent Participant Contributions for the period from January 1, 2024 through September 30, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and



reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Effective September 30, 2024, the Plan was merged into Elwyn Defined Contribution 403(b) Plan (Note 1).

### 1. Description of Plan

The following description of the Elwyn New Jersey 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined contribution plan, established on January 1, 2017, covering all employees of Elwyn New Jersey (the Organization). Benefit Plans Administrative Services, LLC (BPAS) provided recordkeeping services for the Plan and Hand Benefits & Trust Company (HB&T) served as custodian of the Plan's investments. The administrator of the Plan was the Organization. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### *Plan Merger*

Effective September 30, 2024, the Plan merged into the Elwyn Defined Contribution 403(b) Plan, a Plan sponsored by Elwyn Pennsylvania and Delaware, an affiliate of the Organization. The net assets of the Plan totaling \$2,420,666 were transferred and are included as transfer out of assets to another plan on the statement of changes in net assets available for benefits.

#### *Eligibility*

All employees of the Organization were considered eligible for participation. There was no age or service requirement to enter the Plan and entry was immediate upon date of hire.

#### *Contributions*

Each year, participants could contribute a portion of their pretax annual compensation, as defined in the Plan document. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans.

The Organization could make a discretionary matching contribution, based on an amount or allocation formula determined by the Organization, and a non-elective contribution, based on a pro rata formula of the participant's compensation to total eligible participants' compensation. Eligibility for both contributions (discretionary matching and non-elective) required the participant to have completed 1,000 hours of service during the Plan year. For the period from January 1, 2024 through September 30, 2024, there was no discretionary matching contribution.

The Organization has certain employees covered under one of two collective bargaining agreements. Eligible participants covered by these agreements received a non-elective contribution equal to 2% of their eligible compensation and eligible participants not covered by these agreements received a non-elective contribution equal to 4% of their compensation. For the period from January 1, 2024 through September 30, 2024, there was no non-elective contribution.

The Organization could also make qualified non-elective contributions (QNECs) to the Plan, which was a discretionary contribution. The QNEC contribution could be a uniform percentage of Plan compensation, a uniform dollar amount or a target contribution. There was a QNEC contribution of \$430 made during the period from January 1, 2024 through September 30, 2024 related to the correction of a late remittance in 2023.

The Organization's contributions were made once a year and were recorded as an employer contribution receivable in the accompanying statements of net assets available for benefits.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants directed the investment of their contributions and the contributions made by the Organization into various investment options offered by the Plan.

Effective September 30, 2024, the Plan was frozen and all contributions and allocations to the Plan were discontinued as a result of the merger into the Elwyn Defined Contribution 403(b) Plan.

### ***Participant Accounts***

Prior to September 30, 2024, each participant's account was credited with the participant's contribution and allocations of (a) the Organization's contributions and (b) Plan earnings or losses and was charged with an allocation of administrative expenses. Allocations were based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the vested portion of their accounts.

### ***Vesting***

Participants were vested immediately in their individual deferral and the allocated earnings thereon. Vesting in the Organization's discretionary matching and non-elective contribution portions of their accounts was based on years of continuous service. A participant was 100% vested after three years of credited service.

### ***Notes Receivable from Participants***

The Plan did not allow for notes receivable from participants.

### ***Payment of Benefits***

Upon separation of service due to death, disability, retirement or other reasons, a participant could elect to receive a distribution equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments. Participants could obtain an in-service distribution after reaching age 59½ and hardship distributions were permitted under certain circumstances as outlined in the Plan document. In-service and hardship distributions could only be obtained from a participant's voluntary contribution and rollover accounts as contributions from the Organization were not eligible for these distributions. The involuntary small balance cash-out limit was \$7,000.

### *Forfeitures*

As of December 31, 2023, forfeited non-vested accounts totaled \$79,122. These accounts were used to reduce future Organization's contributions or pay reasonable Plan expenses. The forfeitures balance as of December 31, 2023 was utilized to reduce the 2023 Organization's contributions funded in September 2024. During 2024, \$13,226 of forfeited non-vested accounts were transferred to the Elwyn Defined Contribution 403(b) Plan as a result of the merger. There was no forfeitures balance as of September 30, 2024.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

As of December 31, 2023, the Plan's investments were stated at fair value. There were no investments as of September 30, 2024 as a result of the Plan's merger with the Elwyn Defined Contribution 403(b) Plan. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's management determined the Plan's valuation policies utilizing information provided by HB&T. See Note 4 for a discussion of fair value measurements.

Investment transactions (purchases and sales) were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as, held during the period from January 1, 2024 through September 30, 2024.

### *Contributions Receivable*

Participant contributions were recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation. Employer contributions were recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefits were recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Organization. Expenses that were paid by the Organization are excluded from these financial statements. Certain fees related to participant-initiated transactions and the administration of the Plan were charged directly to the participant's accounts and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investments**

Certain information disclosed in the accompanying financial statements, related to investments held at December 31, 2023, and net appreciation in fair value of investments and dividends for the period from January 1, 2024 through September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by HB&T, a qualified institution.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and December 31, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

The valuation methods described could produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan investment assets at fair value as of September 30, 2024 and December 31, 2023. There were no investments at fair value as of September 30, 2024 as a result of the Plan's merger with the Elwyn Defined Contribution 403(b) Plan.

### 5. Tax Status

The Plan used a pre-approved plan document sponsored by BPAS. BPAS received an opinion letter from the IRS, dated March 31, 2017, which stated that the pre-approved Plan document, as then designed, satisfied the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

### 6. Risks and Uncertainties

The Plan invested in various investment securities which were exposed to various risks, such as interest rate risk, overall market volatility and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 7. Related Party and Party-In-Interest Transaction

As described in Note 2, the Plan and participants paid certain expenses related to Plan operations and investment activity to various service providers. Participant distribution fees were paid to BPAS by participants. These transactions were party-in-interest transactions, which were exempt from prohibited transaction rules.

### **8. Delinquent Participant Contributions**

During 2023, certain participant contributions for two pay periods totaling \$250 were not remitted by the Organization within the appropriate time period as prescribed by the Department of Labor (DOL) Regulations. These transactions constitute non-exempt party-in-interest or prohibited transactions as defined by ERISA. The Organization self-corrected these transactions during the period from January 1, 2024 through September 30, 2024 by remitting related lost earnings to the Plan.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued.
