REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator of the
LMB, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the LMB, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, as described in Note 2.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, as described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting, as described in Note 2.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) (Modified Cash Basis) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of the Plan

The following description of the LMB, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution plan covering substantially all employees of LMBI, L.P. (Plan Administrator) and its subsidiary ECR-LPR, L.P. (collectively the Sponsoring Employers). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Bank of America, N.A. is the Trustee.

Eligibility

All employees age 21 or above of the Sponsoring Employers are eligible to participate once they have completed one full year of employment and 1,000 hours of service.

Contributions

The Sponsoring Employers match the participant's elected contribution (deferral), up to 6% of eligible compensation.

Participant contributions (deferrals) cannot exceed the lesser of 100% of eligible compensation or the Internal Revenue Service annual limit, which was \$23,000 in 2024. Participants who will be age 50 or above before the end of the current plan year are eligible to elect to make Catch-Up contributions (deferrals), subject to the Internal Revenue Service annual limit, which was \$7,500 in 2024. Effective January 1, 2024, Plan Participants may contribute designated Roth (after tax) contributions. Other after-tax contributions are not permitted.

Eligible employees are also allowed to make rollover contributions, either before or after they satisfy the Plan's eligibility requirement. However, rollover contributions will only be accepted from another qualified Plan or IRA.

Participants are allowed to adjust their contribution (deferral) election at any time during the year. To do so, the participant must notify the Trustee either by phone or via online account access. Revised elections become effective as soon as administratively feasible.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Investments

The Plan provides a variety of investment options from which participants may select. Participants direct how their funds are to be invested by notifying the Trustee, either by phone or via online account access. If the participant fails to provide investment allocation directions, the participant's account is invested in the Plan's qualified default investment fund. The default is a series of target retirement date mutual funds, American Funds Target Date Retirement Funds which most closely align with the participant's retirement age of 65.

Plan Administration and Expenses

The Plan's assets are held and administered by the Trustee. The Plan Administrator has responsibility for appointing and removing the Trustee, establishing a funding policy and method, and amending or terminating the Plan. The Sponsoring Employers bear responsibility for making contributions. All costs and expenses in administering the Plan are paid by the Plan, unless paid by the Sponsoring Employers. Expenses that are paid by the Sponsoring Employers are excluded from these financial statements.

Forfeited Accounts

At December 31, 2024 and 2023, the balance in the forfeiture account was \$6 and \$2, respectively. Amounts in this account will be used throughout the year to either reduce the contributions of the Sponsoring Employers or to pay administrative expenses under the Plan as directed by the Sponsoring Employers.

Participants' Accounts

Each participant's account is credited with the participant's contributions and the Sponsoring Employers' matching contributions and allocations of investment earnings or losses. Each participant's account may also be allocated a portion of any administrative expenses the Plan pays. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the vested amount in the participant's account.

Vesting

Each participant's account is automatically fully vested in the participant's contributions and the related allocations of investment earnings or losses. The Sponsoring Employers' matching contributions and the related allocations of investment earnings and losses become fully vested after the participant has accrued 3 years of vesting service.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Payment of Benefits

Upon age 59½ or termination of service, participants may elect to receive a lump-sum distribution equal to their vested account balance or a direct rollover to an eligible qualified plan specified by the participant. Active participants are also allowed to request receipt of a portion of their account balance as a hardship distribution upon providing appropriate documentation to the Trustee.

2. Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements and supplemental schedule were prepared on a modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles. Therefore, certain additions to net assets available for benefits are recognized when received rather than when earned (except for Sponsoring Employers and participant contributions, which are recorded when earned), and certain deductions from net assets available for benefits are recognized when paid, rather than when the obligation is incurred. Benefits paid to participants are recorded when paid.

Investment Valuation and Income Recognition

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (at exit price).

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year. Dividend and interest income is recorded when received.

Use of Estimates

The preparation of financial statements in conformity with a modified cash basis of accounting requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes to Financial Statements (continued)

3. Fair Value Measurement

FASB ASC 820 establishes a fair value hierarchy that prioritizes and ranks the level of observability of inputs used to measure the investments at fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to unobservable inputs (Level III measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level I – Unadjusted quoted prices in active markets for identical assets or liabilities.
- Level II – Quoted prices in active markets for similar assets and liabilities; quoted prices for identical or similar instruments in markets that are not active; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level III – Significant unobservable inputs reflecting Plan-specific assumptions, consistent with reasonably available assumptions made by other market participants.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets held and carried at fair value:

- Common/collective trust: Valued at the net asset value (NAV), which is calculated at the end of each business day. The unit value is based on the current value of the fund's holdings divided by the total number of outstanding units to obtain a daily NAV.
- Mutual funds: Valued based on published market prices, which represent the NAV of shares held by the Plan at year-end.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement as of the reporting date.

4. Investments and Investment Income

All investment information disclosed in the accompanying financial statements, notes and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividend and interest income for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Trustee.

Notes to Financial Statements (continued)

4. Investments and Investment Income (continued)

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from the Trustee of the Plan that all of the information provided by the Trustee is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, and all information in the supplemental schedule of assets held for investment purposes (held at end of year) is presented in reliance solely upon those certifications.

5. Plan Termination

Although the Sponsoring Employers have not expressed any intent to do so, the Sponsoring Employers have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, each participant may elect to receive the amount in their participant account no later than the normal withdrawal dates allowed by the Plan.

In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

6. Tax Status

On June 30, 2020, the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not applied for an opinion letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

8. Subsequent Events

The Plan has evaluated subsequent events through June 24, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan amended the conditions of eligibility by removing the age and years of service requirements. Eligible employees now become a participant in the Plan on the first day of the month coinciding with or next following their date of hire.

Effective January 1, 2025, participants age 60-63 as of December 31, 2025 are eligible to elect to make higher Catch-Up contributions (deferrals) as defined in Section 109 of the SECURE 2.0 Act, subject to the Internal Revenue Service annual limit, which is \$11,250 in 2025.
