Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of MSRB 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1 - Plan Description

The following description of MSRB 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Municipal Securities Rulemaking Board (the "Plan Sponsor" or the "MSRB"). The retirement plan committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Eligible employees are automatically enrolled in the Plan at a deferral rate of 6 percent of pretax annual compensation with automatic escalation of 1 percent each October 1, up to a maximum of 10 percent of eligible compensation. Participants may affirmatively elect a different percentage or elect not to make elective deferral contributions.

The MSRB provides a nonelective stated contribution to all participants who are active participants on the contribution date. The amount of the stated contribution is calculated as of the contribution date and is equal to a percentage of the participants' quarterly compensation based on years of service as follows: participants with five years of service or less - 7 percent; participants with six and seven years of service - 8 percent; and participants with eight or more years of service - 9 percent. The nonelective contribution is contributed quarterly.

The MSRB may also, at its discretion, contribute employer matching contributions and discretionary employer contributions to the Plan. For the year ended December 31, 2024, the MSRB did not elect to make employer matching contributions or discretionary employer contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances, reduced by any outstanding loan balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through biweekly payroll deductions.

Certain plan assets are in investment funds managed by Principal Life Insurance Company (Principal Life), Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust), Principal Global Investors Trust Company (Principal Global) or their affiliates (collectively, Principal). Principal is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age. Benefits are payable in the form of a lump-sum amount equal to the vested balance of a participant's account, with certain exceptions allowed for annuities or installments.

Participants may also request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Plan Sponsor's contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants become 100 percent vested in all contributions made by the Plan Sponsor after attaining three years of credited service.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$11,756 and \$40,911, respectively.

The Plan used forfeitures of \$81,157 during the year ended December 31, 2024 to reduce employer contributions. Additionally, forfeitures of \$11,169 were utilized to reduce 2024 employer contributions remitted in 2025.

Termination

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee.

See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains (losses) include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

December 31, 2024 and 2023**Note 2 - Summary of Significant Accounting Policies (Continued)*****Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Interest income is recorded on the accrual basis. If a participant ceases to make the scheduled repayments and the plan administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions are recognized upon authorization and in the year the underlying compensation is earned. All participant and employer contributions are participant directed. Participant contributions in excess of amounts allowed by the IRS would be recorded as a liability with a corresponding reduction in contributions.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the MSRB and are excluded from these financial statements. Administrative expenses include certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net realized and unrealized gains on investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Principal Life, Principal Trust, and Principal Global hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust and Principal Life on behalf of Principal Global.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts

Valued at the NAV of shares in each account held by the Plan at year end. NAV is not a publicly quoted price in an active market. NAV, as provided by the insurance carrier, is used as a practical expedient to estimating fair value. There are no redemption restrictions or unfunded commitments on these investments. In accordance with the fair value measurements topic, investments measured at NAV have not been classified in the fair value hierarchy.

Common/Collective Trust Funds

Valued at the NAV of shares in each account held by the Plan at year end. NAV is not a publicly quoted price in an active market. NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. There are no redemption restrictions or unfunded commitments on these investments except for a 30-day notice period on the Principal Stable Value Fund common collective trust fund. In accordance with the fair value measurements topic, investments measured at NAV have not been classified in the fair value hierarchy.
