Plan Administrator and the Board of Directors SP Holdings, Inc. 401(k) Plan

Scope and Nature of ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of SP Holdings, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of the SP Holdings, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of SP Holdings, Inc. (SP), and its affiliates, Alliance Packaging, LLC and Mystic, Ltd. (collectively, the Employer). All employees who are 21 years of age or older, become participants in the Plan, and are eligible to receive the Employer's safe harbor non-elective contributions, as of the first day of the Plan year quarter coinciding with or the next quarter following the date such employees have completed one year of eligible service as defined by the Plan. All participants employed on the last day of the year and those that terminated due to death, permanent disability or reached normal retirement age (65) during the year, are eligible to receive any matching contributions declared by the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

SP is the Plan's sponsor and administrator. The Plan's investments are held by Empower Trust Company, LLC, the Plan's trustee. The Plan's third-party administrative service provider and record keeper is Empower Retirement, LLC (Empower). The plan administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Employee Contributions

An employee may make voluntary contributions to the Plan through payroll deductions. Beginning January 1, 2024, participants may elect to categorize a portion or all of their contribution under the Plan's Roth deferral feature. These contributions are funded to the Plan following each pay date. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants may make rollover contributions from other qualified plans, and eligible participants may make "catch-up" contributions, subject to certain limitations as defined by the Internal Revenue Code (the Code).

Employer Contributions

The Employer may elect, at its discretion, to make matching and/or profit sharing contributions to the Plan. During 2024 and 2023, the Employer elected to match 100% of each participant's salary deferral contributions, up to 3% and 4% of eligible compensation, respectively. During 2023, the Employer elected to make profit sharing contributions to Plan equal to 2% of each participant's eligible compensation. The matching contributions are funded into the Plan subsequent to year end. Effective January 1, 2024, in order to satisfy the safe harbor rules of the Code, notified its employees that each eligible employee would receive a safe harbor contribution from the Employer equal to 3% of the employee's eligible compensation for any plan year. The safe harbor contribution has been funded to the Plan by the Employer following each pay date.

1. Description of Plan, continued

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's contributions, an allocation of the revenue sharing account, if any, and plan earnings. Participants direct the investment of their account balance into various investment options offered by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, if any. Allocations are based on participant earnings, account balances, the participant's status, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Employer safe harbor contributions plus actual earnings thereon. Vesting in the Employer's discretionary matching and profit sharing contribution portion of their accounts is based on years of credited service. A participant vests after three years of credited service, at which time they become 100% vested. In the event a participant reaches normal retirement age, dies or becomes disabled while employed by the Employer, a participant's account will become fully vested.

Payment of Benefits

On termination of service, a participant or their beneficiary may receive the value of the vested interest in his or her account as a lump sum distribution. Distributions may also be made in installments to comply with minimum distribution rules required by the Code. The Plan permits in-service withdrawals to participants meeting certain requirements. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$536 and \$525, respectively. Forfeitures of the nonvested portions of terminated participants' accounts are maintained in a separate account and used to either offset the Employer's contributions or pay the Plan's administrative expenses. During 2024, forfeitures totaling \$51,364 were used to reduce Employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Summary of Accounting Policies, continued

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Employer matching and safe harbor contributions are recorded in the year in which the participant compensation is earned.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses and Revenue Sharing

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Participant withdrawal fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Certain other fees may be paid by the Plan through forfeitures or through revenue sharing that the Plan receives based on a revenue sharing agreement with Empower. Under the terms of the agreement, each quarter Empower refunds and deposits into the Plan certain excess fees, as defined by the agreement. These deposits are held by the Plan and may be used to pay administrative expenses or allocated to active participant accounts. During 2024, revenue sharing amounts totaling \$240,123 were allocated to active participant accounts.

Subsequent Events

The Plan has evaluated subsequent events through June 27, 2025, the date the financial statements were available to be issued.

3. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the trustee of the Plan).

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Collective trust fund: Valued at the fund's per unit NAV provided by the fund's trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The redemption frequency for participant transactions (purchases and sales) in the collective trust fund occurs daily. Were the Plan to initiate a full or partial redemption of its participation in the collective trust, written notice would be required and the transfer will be within twelve months following the written notice. There are no unfunded commitments in this fund.

5. Related-Party and Party-In-Interest Transactions

Expenses paid by the Plan are party-in-interest transactions as defined by ERISA. Furthermore, as described in Note 7, the Employer adopted a pre-approved defined contribution plan document, sponsored by an affiliate of Empower. See Note 10 regarding delinquent participant contributions.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their Employer matching and profit sharing contributions.

7. Tax Status

The Employer adopted a pre-approved defined contribution plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts as reported in the financial statements.

9. Reconciliation to Form 5500

The Plan's financial statements are prepared on the accrual basis of accounting. The Form 5500 is prepared on the cash basis. Accordingly, the following is a reconciliation of net assets available for benefits per the financial statements as of December 31, 2024 and 2023, to Form 5500:
