### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Harken, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### 1. Description of the Plan

The Harken, Inc. 401(k) Savings Plan (the Plan) was established on September 1, 1985.

The following description of the Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) established by Harken, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. All employees who have completed at least 30 days of service with the Company, as defined in the plan amendment, and are 18 or older will be automatically enrolled at 3% unless the employee elects otherwise.

#### *Contributions*

Participants may contribute up to 100% of pretax annual compensation, as defined in the plan agreement, up to the maximum limits of the IRC. The Plan permits eligible participants to make "catch-up" contributions each year starting the year the participant attains age 50. Participants may also contribute amounts representing distributions from other qualified plans.

Beginning October 1, 2023, the Plan implemented an automatic enrollment increase of 1% each year subsequent to enrollment of up to a maximum of 10%. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of investment options. The Company has established a separate funding arrangement within the Plan to facilitate the segregation of all or a portion of a participant's account, at the participant's election, into optional self-directed accounts for investment purposes. Under the terms of the Plan, a participant or a beneficiary exercises investment control over the self-directed account and assumes full responsibility for the results of the investment decisions made subject to the provisions of the Plan.

The Company makes discretionary matching contributions. The Company match for the 2024 plan year was 10% of the participant's contributions. Additional discretionary profit-sharing contributions may be contributed with the approval of the Company's Board of Directors. There were no profit-sharing contributions made for the year ended September 30, 2024.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and the Company match, as well as an allocation of profit sharing and plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or participant eligible compensation, as defined in the plan agreement. The maximum benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Participants who leave the Plan because of death; early or normal retirement; disability retirement; or those that reach early retirement age, as defined in the plan agreement, are considered 100% vested.

### *Investment Options*

Upon enrollment in the Plan, participants may direct the investment of their account balances into a variety of investment options and may change their investment options daily.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. These loans are secured by the balance in the participant's account. The loans bear interest at effective rates that range from 3.25% to 8.50% at September 30, 2024, which are commensurate with local prevailing rates as determined monthly by the plan administrator. Principal and interest are paid ratably through payroll deductions. Each participant may not have more than two loans outstanding at any time.

### *Payment of Benefits*

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, early retirement, or termination of employment, as defined in the plan agreement. The Plan provides for normal retirement at age 65 and early retirement at age 55. In-service distributions are allowed under the Plan when a participant reaches the age of 59½. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or in partial payments. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan agreement.

### *Forfeited Accounts*

Forfeited accounts can be used to pay administrative expenses or reduce Company contributions. There were no forfeited non-vested accounts as of September 30, 2024 and 2023. In 2024, \$7,156 of forfeited non-vested accounts were used to reduce Company matching contributions.

### *Administrative Expenses*

The Plan pays fees incurred for advisory, accounting, and certain expenses associated with the administration of the Plan, unless otherwise paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All other administrative expenses and

investment management services that are paid by the Plan are allocated to participant accounts as a reduction of investment earnings.

### **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting, except for benefit payments, which are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements. As of September 30, 2024, the Plan has two investments of 10% or more of total investments concentrated in the funds. As of September 30, 2023, the Plan had two investments of 10% or more of total investments concentrated in the funds.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms in the plan agreement.

### **3. Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1* - This level consists of unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets, or liabilities.

*Level 2* - This level consists of quoted prices in markets that are not considered to be active, or financial instruments for which all significant inputs are observable, either directly or indirectly.

*Level 3* - This level consists of prices or values that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended September 30, 2024, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Collective Investment Trusts (CITs)* - Collective investment trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV.

*Mutual Funds* - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States of America Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable Value Fund* - This fund is valued at the NAV of units of the Wilmington Trust Flexpath Single Box Stable Value Fund. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### 4. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Participant loan and distribution processing fees are paid to Principal by participants. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 6. Tax Status

The Plan adopted a Pre-Approved Plan document sponsored by Principal Life Insurance Company. The Internal Revenue Service (IRS) ruled in an opinion letter dated June 30, 2020 that the document qualifies under Section 401(a) of the IRC and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended subsequent to the IRS ruling. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP required management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of September 30, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

### 8. Subsequent Events

The Plan has evaluated subsequent events through July 11, 2025, the date the financial statements were available to be issued.
