### Note 1: Description of Plan

The following description of the A.M.T. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan which covers substantially all employees of A.M.T. Services, Inc. and Adaptive Systems, LLC (collectively, the "Company" and "Plan Sponsor") meeting the eligibility requirements discussed below. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Plan Sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Trustees.

#### Eligibility

Except for nonresident aliens, leased employees and employees covered by a collective bargaining agreement, any employee who has completed three months of service and reached the age of 21 is eligible to participate in the Plan. Upon meeting these requirements, a participant is eligible to make elective deferral contributions and receive a discretionary employer profit-sharing contribution. A participant becomes eligible to receive a discretionary employer matching contribution upon completing one year of service with at least 1,000 hours worked. The employer profit sharing and matching contributions may have additional eligibility requirements, as defined in the Plan document, or discussed below, based upon discretionary elections relative to the timing and frequency of funding those contributions. Plan entry dates include the first day of the Plan year and the first day of each subsequent quarter. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate for automatically enrolled participants increases 1% annually up to a 10% deferral until changed by the participant.

#### Contributions

Contributions to participant accounts are made by employees through tax-deferred and post-tax salary deductions and by the Company from its earnings. Participants may voluntarily contribute up to 85% of their eligible compensation, not to exceed Internal Revenue Code (IRC) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as defined by the IRC. Participants may elect to change fund elections and transfer investment balances between funds on a daily basis and change contribution percentages on a quarterly basis. Employees may directly "roll over" their assets from a qualified plan and transfer the assets into their Plan account.

The Company may provide discretionary matching contributions to participants meeting the eligibility requirements discussed above. If provided, the contribution period is considered the Plan year. The Company elected to match 20% of the participant's contributions, up to 5% of participant's eligible compensation. During the year ended September 30, 2024, the Company contributed approximately \$88,000 of discretionary matching contributions.

#### Contributions (Continued)

The Company may also provide discretionary profit sharing contributions to eligible participants of the Plan, who are defined as those eligible for the general requirements of the Plan, in addition to having been employed on the last day of the Plan year. During the year ended September 30, 2024, the Plan Sponsor did not provide discretionary profit sharing contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, an allocation of the Company's discretionary profit-sharing contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of Plan administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and earnings (losses) thereon. Plan Sponsor discretionary matching and profit sharing contributions and earnings (losses) thereon vest in accordance with the provisions of the Plan as follows:

#### Forfeitures

Forfeitures of non-vested Company contributions are used to pay for the Plan's administrative expenses and to fund employer contributions. The Plan requires forfeitures to be used to pay administrative expenses first and then the rest used to fund employer contributions. At September 30, 2024 and 2023, forfeited non-vested accounts totaled approximately \$6,200 and \$7,100, respectively. For the year ended September 30, 2024, approximately \$10,700 forfeitures were used to fund employer contributions. No amounts were used to pay administrative expenses during fiscal year 2024.

#### **Notes Receivable From Participants**

Participants may borrow from the Plan a minimum amount of \$1,000 up to a maximum equal to the lesser of one-half of their total vested account balance, or \$50,000, reduced by the highest loan balance outstanding during the prior twelve months. The loans are secured by the balance in the Participant's account. Loans bear interest at a rate set by the Plan administrator in accordance with local prevailing rates for similar types of loans. Principal and interest payments are made ratably through payroll deductions over a term not to exceed five years (except for home purchase loans, which can be extended up to ten years from the date of the loan).

#### **Payment of Benefits**

Plan benefits are available upon retirement, in-service withdrawal after age 59 1/2, disability, death, or termination of employment. Participants or their beneficiaries may receive a lump sum distribution equal to the value of their vested interest in the account or installment payments as requested by the participant, subject to minimum distribution requirements by the IRC. A participant no longer employed by the Company may be subject to various force-out provisions depending on the participant's account balance.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the Plan's financial statements in conformity with GAAP periodically requires the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures presented in the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Plan Sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. There were no deemed distributions during the year ended September 30, 2024.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, or through the use of forfeitures, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and included in administrative expenses. Administrative expenses also include trustee, record keeping and professional fees. Investment-related expenses are included in the net appreciation in fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through July 9, 2025, which is the date the financial statements were available to be issued.

### Note 3: Certification of Information

Fidelity Management Trust Company ("Fidelity"), the Plan's trustee, holds the Plan's investments and executes investment transactions. Fidelity has certified that investment balances, notes receivable from participants, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants that have been included in the accompanying financial statements, as well as the supplemental schedule, are complete and accurate as of September 30, 2024 and 2023 and for the year ended September 30, 2024.

### Note 4: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

### Note 4: Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at a stable \$1.00 NAV which approximates fair value. The money market fund held by the Plan is deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5: Party-In-Interest Transactions**

Transactions involving participant notes receivable and investment funds administered by affiliates of Fidelity are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company may, by action of its Board of Directors, amend the Plan, discontinue its contributions, or terminate the Plan subject to the provisions of ERISA. Upon termination, participants would be 100% vested in their employer contributions.

### **Note 7: Income Tax Status**

The Plan has adopted a non-standardized pre-approved plan document with an Internal Revenue Service notification letter dated June 30, 2020 which states the document as then designed is in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the letter, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
