## INDEPENDENT AUDITOR'S REPORT

To the Trustee, Plan Administrator, and Participants  
Southern Illinois Bancorp, Inc. Employees Stock Ownership Plan

### Opinion

We have audited the financial statements of the Southern Illinois Bancorp, Inc. Employees Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year end December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Supplemental Schedules Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

### **NOTE 1 – PLAN DESCRIPTION**

The following description of the Southern Illinois Bancorp, Inc. Employees Stock Ownership Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Southern Illinois Bancorp, Inc. (Company) established the Plan effective as of January 1, 1978. The Plan operates, as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company. The Plan Trustees are a group of three Company employees appointed by the Company's Board of Directors. The Plan holds 38,956 shares of Company common stock. The common stock is held in a trust established under the Plan. All shares have been allocated to participants.

#### Eligibility

Employees of the Company, not covered by a collective bargaining agreement or classified as a leased employee, who have completed 1,000 hours of service within a 12-month period, are eligible to participate. Once eligibility is met, participants enter the Plan on January 1. Participants who do not have at least 1,000 hours of service during such Plan year and are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

#### Contributions

Each year, cash or Company stock may be contributed at the Company's discretion. Employee contributions are not permitted. During the year ended December 31, 2024, the Company contributed \$464,175.

#### Payment of Benefits

Distributions on account of death, disability, retirement, or other separations from service commence in the Plan year following the event. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in the form of cash in a lump-sum amount or in substantially equal installments paid over a period of no more than five years, as defined in the Plan. If requested by the participant, a distribution can be made in the form of employer stock. Under the provisions of the Plan, the Company is obligated to provide a put option to the participant regarding Company stock. The Company also has a right of first refusal for the stock purchase.

### Voting Rights

The Trustees are entitled to exercise voting rights on behalf of the collective best interest of the Plan participants. Whenever a vote concerns a corporate matter as defined in the Plan agreement, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. The Trustees are permitted to vote any allocated share for which instructions have not been given by a participant.

### Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of employer contributions and shares and cash from forfeitures of terminated participants' non-vested accounts. Generally, only those participants who have at least 1,000 hours of service during such Plan year and are employed on the last day of the Plan year, will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Eligible participants also receive an allocation of shares related to the repurchase of shares from distributions. Generally, only those eligible participants who have available cash at the beginning of the year will receive an allocation of repurchased accounts. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance. Dividends are allocated to participants throughout the year, in accordance with the per share dividend paid by the Company.

### Vesting

If a participant's employment with the Company ends for any reason other than retirement, disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Vesting begins at 20% after 2 years of service with participants becoming fully vested after 6 years of service.

### Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25% of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end.

### Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the Plan year ended December 31, 2024, totaled \$3,259 and 29 shares.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. See Note 4 for a discussion of the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan can be paid by the Plan, but historically are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses, if any, are included in net appreciation of fair value of investments.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Changes in Fair Value of Level 3 Assets

The Plan repurchased approximately 1,764 shares from participants at a price determined from the independent appraisal, which were used to fund benefits paid and to segregate participants' accounts into cash for future distributions. These shares were reallocated to the remaining participants. During the Plan year ended December 31, 2024, the Company did not redeem any participant shares from the Plan.

### **NOTE 5 – DIVIDENDS**

During the year ended December 31, 2024, the Company declared four equal quarterly dividends. Total 2024 dividends were in the amount of \$3.40 per share, or \$132,450. The first three quarterly dividends were paid during 2024. The fourth quarter dividend was paid during the first quarter of 2025 and was recorded as a dividend receivable as of December 31, 2024, in the amount of \$33,113. As of December 31, 2023, the Plan had a dividend receivable in the amount of \$26,550, which was paid in the first quarter of 2024.

### **NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan invests in Company common stock and a money market fund. These are related party and party-in-interest transactions. As described in Note 2, the Company historically pays all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

### **NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan investments consist of the Company's common stock and a money market fund, which are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investments, it is at least reasonably possible that changes in the value could occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 8 – PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Company directs the Trustees to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

### **NOTE 9 – TAX STATUS**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated December 6, 2012, stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE 10 – SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through June 27, 2025, the date the financial statements were available to be issued.
