Independent Auditor's Report

Opinion

Opinion

Notes to Financial Statements

Note 1. Plan Description

The following description of Clive Daniel Home Holdings, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering the employees of Clive Daniel Home Holdings, LLC (the Company). Employees who have completed twelve months of service, and meet the Plan's eligibility requirements, are eligible to participate. The Plan is a participant directed retirement plan maintained to provide eligible employees with the opportunity to save for retirement on a tax deferred basis and to receive part or all matching contributions from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan is a defined contribution plan in which participants elect to contribute up to \$23,000 of pretax annual compensation to the Plan on their behalf. Participants direct their investments into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Rollover contributions to the Plan are also allowed.

Participants must make elective deferrals into the Plan and be employed on December 31 to receive a matching contribution. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors and are invested in a portfolio of investments as directed by the Company.

Participant accounts: Each participant's account is credited with participant's contributions and Company's non-discretionary matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Employer matching and non-elective contributions have the following vesting schedule:

<u>Years of Vesting Service</u>	<u>Vested Interest</u>
Less than 2	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Forfeitures: If a participant is not fully vested on their termination date, the non-vested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited account balances totaled \$2,573 and \$690, respectively. Forfeited amounts were used to reduce employer contributions during 2024 and are included in the \$9,075 liability due to the parent company on the Statement of Net Assets Available for Benefits.

Notes receivable from participants: Participants may borrow from their accounts the lesser of \$50,000 or 50% of their vested account balance. The minimum amount for any single loan is \$1,000. The loans are collateralized by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is repaid through payroll deductions. Interest accrues at a rate of prime plus 1.00%.

Note 1. Plan Description (Continued)

Payment of benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amounts equal to the value of the participant's vested account balance, or installment payments available under the Plan. For termination of service or other reasons, a participant may receive the value of the vested account balance as a lump sum distribution. Benefits payments are recorded when paid.

Hardship Amendment: In November 2019, the Plan signed a new hardship amendment which prohibits the Plan from suspending employee deferral contributions following a hardship withdrawal. Previously, a suspension of six months was required after a hardship withdrawal.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification.

Investment valuation and income recognition: Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

Contributions: Participant contributions are recognized when earned. Company matching contributions are recognized concurrently with participant contributions. Company discretionary non-elective contributions are recognized annually, as applicable.

Notes receivable from participants: Notes receivable from participants are recorded at their unpaid principal balances plus any accrued interest. Notes receivable from participants are written off when deemed uncollectible.

Benefit payments: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through June 24, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by John Hancock (USA) the Plan's Trustee

The information related to investments and notes receivable from participants that is included throughout the Plan's financial statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024, was prepared or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to these plan assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Note 4 and the supplemental schedule related to the Plan's assets.

John Hancock (USA) also certified to the completeness and accuracy of \$459,789 of net increase in the fair value of investments and \$9,443 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The Plan has determined the fair value of certain assets through application of accounting guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1: Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the closing price reported on the active market for which the securities are traded.

Note 4. Fair Value Measurements (Continued)

Pooled separate accounts: Valued at net asset value, which is based on the latest quoted market price of the investments held within the fund.

At December 31, 2024 and 2023, the Plan has investments in pooled separate accounts totaling \$4,629,026 and \$3,784,839, respectively. Fair value for the Plan's pooled separate account investments is measured using net asset value per share ("NAV") as a practical expedient. NAV of these investments is based on the fair value of the fund's underlying net assets divided by the number of units outstanding. In accordance with Financial Accounting Standards Board Accounting Standards Codification 820-10, since the Plan's pooled separate account investments are measured at NAV as a practical expedient, the disclosure of the fair value hierarchy information of these investments is not applicable.

Note 5. Income Tax Status

The Plan adopted a standardized form of a prototype plan sponsored by John Hancock (USA). The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by tax authorities for years before 2021.

Note 6. Plan Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100% vested in their account balances.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Party-in-Interest Transactions

The Plan's investments are shares of pooled separate accounts managed by John Hancock. John Hancock provides investment management services to the Plan and is the custodian, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for the investment management services are included in net appreciation in fair value of investments. A portion of the costs of the Plan's administration is paid for by the Employer and is excluded from the Plan's financial statements. Certain officers and employees of the Company, who may be participants in the Plan, perform administrative and other duties for the Plan at no cost to the Plan. The Plan issues notes receivable to participants, which are secured by the vested balances in the participants' accounts. Notes receivable from participants also qualify as exempt party-in-interest transactions.
