## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of the  
Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan  
Omaha, Nebraska

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Opinion

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **1. PLAN DESCRIPTION**

The following plan description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan (the Plan) is a defined contribution plan. The Executive Vice President of Finance of Kirkham Michael, Inc. (the Company) administers the Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended.

The Plan has designated Fidelity Management Trust Company (Fidelity, the "trustee") as trustee of Plan assets. Under terms of the trust agreement between the trustee and the Plan, the trustee invests funds of the Plan in investment pools at approximate percentage guidelines as specified by the Plan's sponsor or as directed by the Plan participants.

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of SECURE 2.0 were effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

**Participation** – Employees of the Company are eligible to make 401(k) deferral contributions and receive Company discretionary matching contributions on the first day of the month following the completion of 30 days of eligible service and are 21 years of age or older. Employees hired before June 1, 2001, became eligible on the first day of the month following the completion of one year of eligible service and were 21 years of age or older. Temporary employees become eligible on the first day of the month after completing 1,000 hours of eligible service and being 21 years of age or older.

**Contributions** – Each year, participants may contribute up to 100% of the participant's eligible compensation to either a Pre-tax 401(k) deferral or a Roth 401(k) deferral, provided that the contribution does not exceed annual limitations set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans (roll-overs). Participants are automatically enrolled with a 4% salary deferral contribution, unless they affirmatively elect not to participate. Participants may increase or decrease their deferral rate on a quarterly basis unless they decrease to 0%, which can be done at any time. Effective January 1, 2013, the Plan elected to make discretionary matching and/or profit-sharing contributions. The Plan allows the employer sole discretion regarding matching and profit-

sharing contributions. The amount, the allocation formula, and the percentage or dollar amount limit applicable to such match and profit-sharing, if any, is at the complete and sole discretion of the employer and may vary from year to year. For the plan year ended November 30, 2016, and the first month plan year beginning December 1, 2016, the employer made a matching contribution of 50% of the first 4% of elective deferrals. Effective January 1, 2017, the matching contribution was increased to 50% of the first 5% of elective deferrals. For the plan years ended December 31, 2024 and 2023, the employer made no profit-sharing contribution.

*Accounts* – Each participant’s account is credited with the participant’s contributions, allocations of the Company’s matching contributions, and Plan gains or losses. The Plan is participant-directed, with all investment choices subject to change by the participant via electronic investment allocation options. Earnings or losses on investments are determined periodically and are allocated to the participants’ accounts in the proportion that each account balance in those investments bears to the total. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s accounts.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions vest according to the following schedule:

*Distributions* - A participant becomes eligible for payment of their vested account balance upon termination of employment, total or permanent disability, normal retirement, death or proven hardship. A participant may receive payment in the form of a lump sum payment or a rollover into a properly qualified IRA.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. A participant may only have one loan outstanding at a time.

The notes are secured by the balance in the participant's account and bear interest at a rate of 4.25-9.5%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

*Forfeitures* – An employee forfeits any portion of their unvested benefit upon termination. Forfeitures are first applied to pay administrative expenses under the Plan. In years where employer contributions are made, forfeitures from non-vested employer contributions not used to pay administrative expenses shall be applied to reduce the earliest employer contributions made after the forfeitures are determined. Total plan forfeitures for the years ended November 30, 2024 and 2023, were \$18,534 and \$18,891, respectively, and were all used to reduce employer contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 7 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation(depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of loans and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation(depreciation) of fair value of investments.

**3. INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**4. INFORMATION CERTIFIED BY FIDELITY (UNAUDITED)**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at November 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

**5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are invested in separate accounts managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan for investment management and administrator services for the years ended November 30, 2024 and 2023, were \$713 and \$688, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Stable Value Collective Trust Fund:** A stable value fund that is valued at the NAV of the units of a bank collective trust. The NAV, as provided by the trustee, is used as a readily determinable fair value to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This readily determinable fair value is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to briefly

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of the  
Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan  
Omaha, Nebraska

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. PLAN DESCRIPTION**

The following plan description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Kirkham-Michael, Inc. and Affiliates Employees' 401(k) Plan (the Plan) is a defined contribution plan. The Executive Vice President of Finance of Kirkham Michael, Inc. (the Company) administers the Plan. The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA), as amended.

The Plan has designated Fidelity Management Trust Company (Fidelity, the "trustee") as trustee of Plan assets. Under terms of the trust agreement between the trustee and the Plan, the trustee invests funds of the Plan in investment pools at approximate percentage guidelines as specified by the Plan's sponsor or as directed by the Plan participants.

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of SECURE 2.0 were effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

**Participation** – Employees of the Company are eligible to make 401(k) deferral contributions and receive Company discretionary matching contributions on the first day of the month following the completion of 30 days of eligible service and are 21 years of age or older. Employees hired before June 1, 2001, became eligible on the first day of the month following the completion of one year of eligible service and were 21 years of age or older. Temporary employees become eligible on the first day of the month after completing 1,000 hours of eligible service and being 21 years of age or older.

**Contributions** – Each year, participants may contribute up to 100% of the participant's eligible compensation to either a Pre-tax 401(k) deferral or a Roth 401(k) deferral, provided that the contribution does not exceed annual limitations set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributions plans (roll-overs). Participants are automatically enrolled with a 4% salary deferral contribution, unless they affirmatively elect not to participate. Participants may increase or decrease their deferral rate on a quarterly basis unless they decrease to 0%, which can be done at any time. Effective January 1, 2013, the Plan elected to make discretionary matching and/or profit-sharing contributions. The Plan allows the employer sole discretion regarding matching and profit-

sharing contributions. The amount, the allocation formula, and the percentage or dollar amount limit applicable to such match and profit-sharing, if any, is at the complete and sole discretion of the employer and may vary from year to year. For the plan year ended November 30, 2016, and the first month plan year beginning December 1, 2016, the employer made a matching contribution of 50% of the first 4% of elective deferrals. Effective January 1, 2017, the matching contribution was increased to 50% of the first 5% of elective deferrals. For the plan years ended December 31, 2024 and 2023, the employer made no profit-sharing contribution.

*Accounts* – Each participant’s account is credited with the participant’s contributions, allocations of the Company’s matching contributions, and Plan gains or losses. The Plan is participant-directed, with all investment choices subject to change by the participant via electronic investment allocation options. Earnings or losses on investments are determined periodically and are allocated to the participants’ accounts in the proportion that each account balance in those investments bears to the total. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s accounts.

*Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Employer contributions vest according to the following schedule:

*Distributions* - A participant becomes eligible for payment of their vested account balance upon termination of employment, total or permanent disability, normal retirement, death or proven hardship. A participant may receive payment in the form of a lump sum payment or a rollover into a properly qualified IRA.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. A participant may only have one loan outstanding at a time.

The notes are secured by the balance in the participant's account and bear interest at a rate of 4.25-9.5%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Forfeitures** – An employee forfeits any portion of their unvested benefit upon termination. Forfeitures are first applied to pay administrative expenses under the Plan. In years where employer contributions are made, forfeitures from non-vested employer contributions not used to pay administrative expenses shall be applied to reduce the earliest employer contributions made after the forfeitures are determined. Total plan forfeitures for the years ended November 30, 2024 and 2023, were \$18,534 and \$18,891, respectively, and were all used to reduce employer contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 7 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation(depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of loans and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation(depreciation) of fair value of investments.

**3. INCOME TAX STATUS**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**4. INFORMATION CERTIFIED BY FIDELITY (UNAUDITED)**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at November 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

**5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments are invested in separate accounts managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan for investment management and administrator services for the years ended November 30, 2024 and 2023, were \$713 and \$688, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

- **Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- **Stable Value Collective Trust Fund:** A stable value fund that is valued at the NAV of the units of a bank collective trust. The NAV, as provided by the trustee, is used as a readily determinable fair value to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This readily determinable fair value is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to briefly

delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
