Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fuji Electric Corp of America 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fuji Electric Corp of America 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

1. Plan Description

The Fuji Electric Corp of America 401(k) Profit Sharing Plan (the “Plan”) is the profit sharing plan for Fuji Electric Corp of America and Reliable Turbine Services LLC (collectively the “Company”). The following description provides only general information. The Plan document should be consulted for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan with a 401(k) and profit-sharing feature covering eligible employees of the Company who are 18 years of age or older. Employees are eligible to make elective deferrals and receive employer contributions on the first day of the calendar quarter following their completion of six months of entry service. The Plan adopted an automatic enrollment feature to enroll eligible employees into the Plan. The initial participant contribution is 3% of gross pay. Accounts of participants who do not affirmatively elect investment options for their account will be invested in a Target Date Fund assuming retirement at age 65. Participants can opt out of the automatic enrollment feature or change their contribution amount or investment allocation at any time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan administrator oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute eligible pretax compensation, as defined by the Plan, up to the maximum allowed by law. Participants may also contribute distributions from other qualified plans (rollovers). Participants are permitted to make after-tax contributions as “Roth” contributions. The Plan has elected to be constituted as a safe harbor plan, which requires a qualified nonelective contribution in an amount equal to 3% of the participant’s eligible compensation. The Plan provides for, at the discretion of the Company’s management, an additional profit-sharing contribution. For the year ended December 31, 2024, the Company has elected to make no profit-sharing contribution. All participant and Company contributions are subject to limitations by law. All contributions are participant directed and can be redirected daily.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor contributions and allocations of discretionary contributions and Plan earnings (and losses) and charged with the participant’s withdrawals or distributions and an allocation of administrative expenses. Allocations are based on participant account balances as defined. The benefit to which a participant is entitled is the participant’s vested account.

1. Plan Description (*continued*)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and in any Company safe harbor contributions. Participants' vesting in the Company's matching contribution and discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant vests 20% after one year of credited service (consisting of 1,000 or more hours of service) and each year thereafter, until 100% vested after five years of credited service. Upon death, disability, or retirement, as defined by the Plan document, a participant will become fully vested.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans require repayment within no more than 5 years, or up to 15 years or the repayment period currently in effect for a commercial home loan if for the purchase of a primary residence. The Plan allows only one loan outstanding per participant. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest must be paid ratably through payroll deductions or otherwise in at least equal quarterly installments.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant, or his or her beneficiary, may elect to receive one of the following forms of payment equal to the value of the participant's vested interest in his or her account: 1) lump sum; 2) partial distribution, or 3) fixed payment installments. In those cases where the vested balance, excluding rollovers, is less than \$5,000, a participant will receive the value of the vested interest as a lump sum distribution.

Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited account balances held in non-participant direct accounts totaled \$1,365 and \$2. Forfeitures will be used to reduce administrative expenses or employer contributions. For the year ended December 31, 2024, forfeitures in the amount of \$6,844 were used to offset employer contributions and no forfeitures were used to reduce administrative expenses.

ERISA Expense Budget

The plan collects a fixed fee from participant accounts to cover administrative expenses through an ERISA expense budget. At year-end, any variance between collected and actual expenses is adjusted. During the year, an excess of \$7,501 was identified and refunded pro-rata to participant accounts. This amount is reflected as other income on the Statement of Changes in Net Assets.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements*, which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the group annuity contract, which is valued at contract value. Registered investment companies held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the registered investment companies are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The registered investment companies of the Plan are deemed to be actively traded. The common/collective trusts are valued at the NAV, as provided by the trustee, which is used as a practical expedient for fair value based on the fund’s underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The group annuity contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 9, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

The Plan had investments in a benefit-responsive group annuity contract, which is stated at contract value. The group annuity contract amounted to \$1,274,910 and \$1,274,060 at December 31, 2024 and 2023.

5. Group Annuity Contract

The Principal Fixed Income Guaranteed Option (the "PFIGO") is a guaranteed general account backed group annuity contract issued by Principal Life Insurance Company. Because the PFIGO is benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the PFIGO. Contract value represents contributions, plus earnings, less participant withdrawals and administrative expenses.

A rate of interest is contractually guaranteed by Principal Life Insurance Company and is credited to participant's account balances. This net crediting rate is after the deduction of fees for administrative and record-keeping services provided to the Plan. The rate is reset on a semiannual basis.

5. Group Annuity Contract (continued)

Benefit payments are made at contract value (i.e. no market value adjustments or surrender charge adjustments) for plan benefit events including: retirement, death, disability, termination of employment, loans, withdrawals, or plan termination. An employer level liquidation or employer initiated transfer of the plan's interest in the PFIGO will be subject to either a 12 month advance notice or a 5% surrender charge, whichever the employer chooses. Notification of a plan's intent to terminate its interest may be revoked within 90 days of the receipt of such notice, after which time, the notice becomes irrevocable. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the PFIGO exceeds 20% of the plan's interest in the contract during the 12 month period immediately preceding the employer-level surrender of the plan's interest in the contract. If this scenario occurs, the surrender charge will be billed to the employer. Management believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The credit risk of the issuer, Principal Life Insurance Company, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A1 as of July 2024), A.M. Best (A+ as of April 2025), Standard and Poor's (A+ as of April 2025), and Fitch Ratings (AA- as of May 2025).

6. Common/Collective Trusts

The Plan offers 13 common/collective trusts called the Principal LifeTime Hybrid Funds ("Funds"). These Funds include: the Principal LifeTime Hybrid 2015 Fund; the Principal LifeTime Hybrid 2020 Fund; the Principal LifeTime Hybrid 2025 Fund; the Principal LifeTime Hybrid 2030 Fund; the Principal LifeTime Hybrid 2035 Fund; the Principal LifeTime Hybrid 2040 Fund; the Principal LifeTime Hybrid 2045 Fund; the Principal LifeTime Hybrid 2050 Fund; the Principal LifeTime Hybrid 2055 Fund; the Principal LifeTime Hybrid 2060 Fund; the Principal LifeTime Hybrid 2065 Fund; the Principal LifeTime Hybrid 2070 Fund, and the Principal LifeTime Hybrid Income Fund. The unit value of each of these Funds is determined on a daily basis. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value. There are no redemption restrictions on these funds. The Plan has no unfunded commitments to these funds at December 31, 2024 and 2023.

7. Party-In-Interest Transactions

Certain investments of the Plan are managed by Principal Trust Company, Principal Life Insurance Company or Principal Global Investors Trust Company, all of whom are members of Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

7. Party-In-Interest Transactions (*continued*)

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Voluntary Compliance Program

The plan administrator has identified Plan document errors that required the submission of the Voluntary Compliance Program (“VCP”) application to the IRS under the Employee Plans Compliance Resolution System (“EPCRS”). The Plan has submitted a VCP application. The proposed correction methodology will not impact any participant’s benefit in the Plan.

9. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype document preparer, Principal Trust Company, by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

11. Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.
