INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee, Participants, and Beneficiaries of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of T & R Electric Supply Company, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about T & R Electric Supply Company, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



A. DESCRIPTION OF PLAN

The following description of the T & R Electric Supply Company, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General: The Plan is a multiple employer defined contribution plan covering substantially all full-time employees of the Companies. All employees of the Companies are eligible to participate in the Plan after 60 days of service with the exception of employees classified as temporary or seasonal which must complete one year of service and are age eighteen or older. The effective date of the Plan is January 1, 1997 although elective deferrals did not begin until January 1, 1998. This Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions: Each year, participants may contribute the maximum percentage allowable not to exceed the limits of Code Section 401(k). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the plan. The Plan includes an automatic contribution arrangement whereby all newly eligible employees are automatically enrolled in the Plan, unless a contrary election is made, with a default deferral rate of 3% of the eligible compensation. This default rate is increased by 1% per year up to a maximum of 6%. Company contributions are on a purely discretionary basis and may include matching contributions, profit sharing contributions, and qualified non-elective contributions. During the Plan year, the Company matched 50% of participant contributions up to 6%.
3. Participants Accounts: Each participant's account is credited with the participant's contribution, allocations of the Company's matching contribution, Plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Investments: Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

5. Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. Upon death or disability, a participant's account becomes 100% vested.
6. Determination Letter: The Company has adopted a prototype plan of EMPOWER Retirement Plan Services, Inc. The Internal Revenue Service has determined that effective January 1, 1997, and as amended and restated September 10, 2021, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. The Plan administrator and the plan's counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Service.
7. Participant Loans: Participant loans are not permitted by the plan.
8. Payment of Benefits: Participants who attain normal retirement age (65) or who terminate service due to death, disability, retirement, or other reasons may elect to receive a distribution of their vested interest, in either a lump sum or annual installments.
9. Forfeited Accounts: Forfeited non-vested accounts are used to reduce plan expenses. In the fiscal year ended September 30, 2024, plan expenses were reduced by \$1,884 for forfeited non vested accounts.

B. SUMMARY OF ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

1. Date of Management's Review: Subsequent events were evaluated through June 30, 2025, which is the date the financial statements were available to be issued.
2. Accrual Basis: The financial statements of the Plan are prepared on the accrual basis of accounting. Contributions are included in income in the year for which they are accrued by T & R Electric Supply Company, Inc.

3. Valuation of Investments: Investments are reported at current value, except for fully benefit-responsive investment contracts, which are reported at contract value. If available, quoted market prices are used to value investments. Investments are valued by an independent third-party appraiser. If quoted market prices are unavailable, other observable inputs would be used. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the plan year.
4. Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
5. Contributions: Contributions from employees are recorded as they are withheld from the participant's wages.
6. Payment of Benefits: Benefits are recorded when paid.
7. Operating Expenses: Certain expenses of maintaining the plan, including audit fees, are paid by the Company.

C. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments if Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurement

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded and are valued at their daily asset valuation. The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended September 30, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

The Plan's investments are held in a bank-administered trust fund and have been certified to as complete and accurate by EMPOWER Corporation (a Great-West Financial Company), the Plan's asset custodian, which is regulated and examined by the State of Colorado.

The plan allows for participant-directed investments into various funds, including stock and bond funds. Gains and losses included in changes in net assets available for benefits are reported in net appreciation/depreciation in fair value of investments.

D. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract and a portfolio of synthetic investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

The key difference between a synthetic investment contract and a traditional investment contract is the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The synthetic investment contracts held by the Plan include wrapper contracts that provide a guarantee that the credit rate will not fall below 0 percent. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. Formulas are provided in each contract that adjusts renewal crediting rates to recognize the difference between the fair value and the book value of the underlying assets. Crediting rates are reviewed monthly or quarterly for resetting.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

F. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan upon a 60-day notice subject to the provisions of ERISA and the Internal Revenue Code.

G. TAX STATUS

The Company has adopted a prototype plan of EMPOWER Retirement Plan Services, Inc. The Internal Revenue Service has informed EMPOWER that effective January 1, 1997 the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.
