Responsibilities of Management for the Financial Statements

Note 1 Description of Plan

The following description of the Service Electric Cablevision, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan trustees are responsible for oversight of the Plan, and with the advice of external investment advisors, periodically determine the appropriateness of the Plan's investment offerings and monitor investment performance and reports to the Plan's plan administrator. The Plan is a defined contribution profit-sharing plan (401(k) Plan) covering all full-time employees of the Company.

Eligibility Requirements

Employees are eligible to participate in the plan after they have completed one year of service and are age 21 or older.

Contributions

Each year participants may elect to defer to the Plan not exceed the Internal Revenue Service (IRS) limitation (\$23,000 for 2024 and \$22,500 for 2023). Participants may designate all or a portion of their elective deferral as Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions (up to \$7,500 for 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may, at its sole discretion, make matching and profit-sharing contributions. The Company contributed \$495,720 and \$473,791 for the years ended September 30, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company matching and profit-sharing contributions, as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 Description of Plan

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service based on a cliff-vesting basis. Participants become fully vested upon termination of employment due to death or disability.

Forfeitures

Forfeited non-vested accounts may be used to pay administrative expenses or reduce employer contributions. Forfeited non-vested accounts totaled \$11,014 and \$10,447 as of September 30, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable terms range from 1-5 years or up to 10 years for the purchase of a primary residence. The notes receivable is secured by the balance in the participant's account and bear interest at a rate 1% above the prime rate as published in the Wall Street Journal. At September 30, 2024, interest rates ranged from 3.75% to 9.00%. Principal and interest are paid ratably through payroll deductions. All notes receivable are due and payable from the participant's Plan account upon termination of employment.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, participants who are still employed may make hardship withdrawals as defined by the IRS from their salary deferral account balance. Employees age 59 ½ may withdraw any portion of their vested account balance. Benefits are recorded when paid.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principals generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Employer and Employee Contribution Receivables

Employee contribution receivables are recorded when amounts have been withheld from employees prior to the end of the year but were not remitted to the plan until the subsequent year. Employer contribution receivables represent the Company's match and discretionary profit-sharing contribution for the plan year was not paid until the subsequent year.

Notes Receivable from Participants.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. If a participant ceases to make notes receivable repayments and the plan administrator deems the participant notes receivable to be in default, the participant notes receivable balance is reduced, and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Administrative expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 ERISA Section 103(a)(3)(c) Audit for the 2024 Financial Statements

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from Reliance Trust Company (“the custodian of the plan”) in which they certified that the statements furnished for the specified periods, pursuant to 29 CFR 2520.103-5 is complete and accurate reflection of the custodian of the plan’s business records. The information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments held at September 30, 2024, and net appreciation in fair value of investments, interest, and dividends for the year ended September 30, 2024 was obtained or derived from information supplied from and certified by the custodian of the plan, the custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Note 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Money Market Fund – are invested in cash and cash equivalents.

Mutual Funds – the mutual funds are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 6 Related Party Transactions and Party-In-Interest Transactions

During the course of the year, the Plan entered into certain party-in-interest transactions with Reliance Trust Company, who serves as fund custodian. The Plan also has service providers in which administrative fees (Note 2) are paid for services provided. As such, transactions in these investments and for services provided qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for the investment management services which amounted to \$50,507 and \$44,067 for the years ended September 30, 2024 and 2023, respectively are included in administrative expenses.

In addition, notes receivable from participants, as disclosed in the statements of net assets available for benefits, qualify as party-in-interest transactions.

Note 7 Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The company is covered by a prototype plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities that are subject to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 Subsequent Events

The Plan has evaluated subsequent events through July 10, 2025, the date the financial statements were available to be issued. Based upon the evaluation, the Plan's management did not identify subsequent events that require adjustment or disclosure in the financial statements.


